## MVPD CARRIAGE ELECTION STATEMENT

September 28, 2020

KCEB (FID: 83913) hereby elects must-carry on all MVPDs in the Tyler-Longview (Lufkin & Nacogdoches) Designated Market Area (“DMA”) for the 2021-2023 carriage cycle, except as provided below. Pursuant to Section 76.57 of the FCC’s rules, KCEB elects to be carried on all cable systems in the DMA on channel 54. KCEB also requests carriage on channel 54 on all DBS systems in the DMA, except as provided below.

KCEB hereby elects retransmission consent for DirecTV, LLC, in the DMA for the 2021-2023 carriage cycle, which election we believe to be a change from the must-carry election of the previous licensee of KCEB.
