SALEM, Ore. - One of the two inmates who escaped from Oregon's only prison for women in early October has been captured in Texas.

Brandy Woodward and Shelly Radan walked away from the Corrections Commissary Building in Salem the morning of October 11, 2021, while part of a work crew based out of Coffee Creek Correctional Facility..

Woodward was arrested in Texas on Tuesday evening, 92 days after her escape.

Oregon State Police are now working with Texas law enforcement to extradite Woodward back to Oregon.

Radan remains at large.

#### **EVENT HALL-SHOOTING**

6 people shot outside Oregon concert; suspect not in custody

EUGENE, Ore. (AP) — Police in Oregon set up a tip line and are asking for witnesses to come forward with any information about a shooting that injured six people, one critically, outside a concert in Eugene.

Officers responded to the WOW Hall after reports of a shooting near the venue's rear entrance around 9:30 p.m. Friday and found chaos.

The gunfire erupted in a parking lot behind the venue.

No arrests had been made, and investigators have not determined whether the shooting was targeted or random.

Police Chief Chris Skinner said investigators hadn't received much information from possible witnesses...

#### PORTLAND HOMICIDES-2021

2021 was a record year for homicides in Portland

PORTLAND, Ore. (AP) — In 2021 Portland, Oregon, recorded 90 homicides amid a surge in gun violence, shattering the city's previous high of 66 set more than three decades ago.

The number of homicides in Portland surpassed more populous cities including San Francisco and Boston — and were more than double the number of slayings last year in its larger Pacific Northwest neighbor Seattle.

City police and officials say last year's increase — which disproportionally impacted Portland's Black community — was fueled by gang-related arguments, drug deals gone array and disputes among people living on the streets and exacerbated by the pandemic, economic hardships and mental health crises.

Oregon is getting its first glimpse of the scale of fraud perpetrated against the state's unemployment insurance system during the height of the pandemic.

A report released by the state's employment department says it paid out more than \$24 million in fraudulent claims in 2020, the first 10 months of the COVID-19 pandemic.

Oregon overall paid \$7.4 billion to 581,000 people in 2020, meaning about 0.3% of the claims were fraudulent.

A law passed in the 2021 legislative session allows the employment department for five years to wave overpayments caused by unintentional errors.

While other states have been forthcoming about the amount of fraud perpetrated, Oregon Employment Department acting director David Gerstenfeld until now has repeatedly declined to publicly discuss the amount of fraud that occurred on the state's unemployment insurance system.

Gerstenfeld cited the department's desire to not give fraudsters information about how to commit it.

People shot outside Oregon concert identified

EUGENE, Ore. (AP) — Police have identified six people shot outside a concert Friday in Oregon, and confirmed they are all either in stable condition or out of the hospital.

The Register-Guard reports five people from Oregon and one person from California were gathered at a porch area behind a music and community events venue in Eugene called WOW Hall before the shooting around 9:30 p.m.

Police say three of those injured are hip-hop artists who had traveled from Pendleton, Oregon, to perform.

Police had no new descriptions Tuesday of the suspect, who remains at large. Police say detectives are still trying to discern if the shooting was targeted or random.

#### COVID-RELIEF FUNDS-FRAUD

Oregon man pleads guilty to stealing COVID-relief money

PORTLAND, Ore. (AP) — Federal officials say an Oregon man has pleaded guilty to perpetrating a scheme to steal money intended to help small businesses during the COVID-19 pandemic.

The U.S. Attorney's Office — District of Oregon says 47-year-old Benjamin Tifekchian of Portland on Tuesday pleaded guilty to bank fraud. After Congress in 2020 passed the Coronavirus Aid, Relief, and Economic Security Act, Tifekchian made false claims and successfully obtained more than \$884,000 in a Paycheck Protection Program loan.

Prosecutors say Tifekchian used some of the money to pay for gambling and vacations before Bank of America froze the loan funds, suspecting fraud.

Oen Nicholson told Judge Martin Stone he wants to dismiss his assigned public defender and represent himself.

The judge warned Nicholsen of the disadvantages of representing himself.

He then ordered a competency exam at the state hospital in Salem

Nicholson is accused of killing his father, as well as a Florida couple and a woman in a marijuana dispensary in North Bend in June 2021.

He also faces charges related to the kidnapping of a woman in Springfield and forcing her to drive him to Wisconsin, where he turned himself in to police..

Police: 1 killed, 5 hurt in shooting during Portland protest

PORTLAND, Ore. (AP) — One person was killed and five others were wounded in a shooting at a Portland park where a march was planned to protest police violence.

Police say the shooting at Normandale Park Saturday night happened during a confrontation between an armed homeowner and armed protesters.

Officers found one woman dead, and two men and three other women were taken to the hospital.

Their conditions haven't been released....

The Multnomah County District Attorney's Office filed murder and attempted murder charges Tuesday for the man suspected of shooting five people at a park in Northeast Portland on Saturday night.

Benjamin Jeffrey Smith, 43, allegedly confronted participants at a protest Saturday night before pulling out a handgun and shooting multiple people in the crowd. Brandy "June" Knightly, 60, was killed and four others were injured.

The shooting ended when a person in the crowd fired back at Simth, wounding him in the hip.

The Multnomah County District Attorney's Office ultimately decided to bring "no complaint" against the person "based upon our review of facts and evidence."

Portland police officers have remained at the hospital with Smith since the shooting and subsequent surgery, court records state.



#### WAGE THEFT

Probe: Restaurant owners shortchanged employees nearly \$170K

SALEM, Ore. (AP) — An investigation by the U.S. Department of Labor, the Wage and Hour division has found that KKOKI Korean BBQ restaurant owners in Salem, Portland and Eugene shortchanged 118 employees nearly \$170,000.

The Statesman Journal reports the investigation report says managers took part of workers' tips, paid overtime only after workers worked 86 hours rather than 40 hours per week and that the employer failed to keep accurate employee records.

A total of \$169,728 was recovered, representing \$84,864 in back wages and an equal amount in liquidated damages.

Additionally, the report says the division issued \$30,199 in penalties for the "willful nature of the employer's violations," Kkoki Korean BBQ owners were not available for comment.

#### LIVE SCORPION IMPORTS-PLEA

Oregon man pleads guilty to importing live scorpions

EUGENE, Ore. (AP) — An Oregon man has pleaded guilty in federal court to illegally importing and exporting hundreds of live scorpions.

The Oregon Department of Justice says Darren Drake pleaded guilty Monday to conspiring with others to commit Lacey Act violations.

Court documents say from September 2017 into March 2018, Drake imported and exported dozens of live scorpions from and to contacts in Germany without obtaining an import-export license from the U.S. Fish and Wildlife Service.

Documents say one intercepted parcel had been falsely labeled as chocolates. Drake also mailed or received several hundred live scorpions from other U.S. states, including Michigan and Texas, in violation of federal mailing laws.

Charges have been dropped in a Cold Case murder investigation involving Nine-year old Hayley Mae Coblentz.

Two years ago, her body was found in a dufflebag alongside the Salmon River northeast of Lincoln City.,

She was originally called a Jane Doe until advanced DNA led to her mother and her spouse in Detroit Mi.

The pair were later arrested in connection with the death of Mayley Mae.

The mother, Twenty-eight year old Shawna Browning was first to be extradited back to Oregon and made a court appearance in Lincoln County at Newport.

Where Lincoln Co. District Attorney Lanee Danforth asked the Oregon Dept. of Justice to prosecute the case as Aggravated Murder.

They dismissed the charges before presenting the case to a Grand Jury, "pending further investigation." Then last Thursday, a motion was filed to dismiss all charges.

#### PRISON NURSE-SEX ASSAULT

Ex-prison nurse charged with sex assault of women in custody

PORTLAND, Ore. (AP) — The U.S. Department of Justice has unsealed an indictment that accuses a former Oregon Department of Corrections nurse of sexually assaulting a dozen women in custody at the state women's prison.

Oregon Public Broadcasting reports 37-year-old Tony Klein pleaded not guilty Monday to 21 counts of "depriving the victims of their constitutional right not to be subjected to cruel and unusual punishment."

The indictment alleges that in 2016 and 2017 Klein committed various forms of sexual assault including aggravated sexual abuse.

Klein also pleaded not guilty Monday to four counts of perjury related to a federal lawsuit over alleged sexual misconduct while he was a nurse at the facility.

#### **GHOST GUN OPERATION**

Prosecutors: 'Ghost gun' manufacturing operation raided

SALEM, Ore. (AP) — Prosecutors say a man was running a "massive" so-called "ghost gun" operation from his mother's house in Salem, Oregon, and distributing counterfeit pills made of fentanyl in exchange for other guns.

The Oregonian/OregonLive reports agents from the U.S. Alcohol, Tobacco, Firearms and Explosives and Salem police seized 63 firearms from the home Tuesday amid approximately 200 counterfeit oxycontin pills.

Authorities say Tyler Ray Harnden was arrested and indicted on drug and firearm charges.

It wasn't immediately known if he has a lawyer to comment on his behalf.

Ghost guns are homemade firearms that lack serial numbers used to trace them and are often purchased without a background check.

Intro: In response to an uptick in threats against election workers after the 2020 election, Oregon lawmakers passed a measure recently that gives them greater protections.

The Bill increases the penalties for harassing election workers and shields their personal information.

Chris Walker is Jackson County Clerk, in charge of elections for the county. She says elections always are tense – especially presidential elections since roughly half of the population is going to be disappointed.

:11 "What we have not experienced as we have since the 2020 election is the amount of anger directed toward elections officials themselves, and that was kind of new territory for us."

Tag: Walker has witnessed threats herself. In the weeks after the 2020 election, graffiti that said "vote don't work" and "Next time bullets" was found painted on the parking lot near her election office in Medford.

Under the measure, the maximum penalty for harassing an election worker is punishable by 364 days in prison and a 6,250 dollar fine.

NORTH BEND, Ore. — A woman has been arrested and charged with attempted murder following a pedestrian hit and run on Tuesday.

The incident took place around 5:20 p.m. when a Lexus SUV, driven by 31 year old Kelsey Culver struck the pedestrian 41-year-old Kyle Hagquist of Coos Bay.

According to Police reports, Culver then fled the scene in the vehicle and was later observed driving erratically, hitting another vehicle and ultimately striking a construction container and utility trailer in front of the Bachelors Inn, in Coos Bay.

Coos Bay Police arrested Kelsey Culver, while Hagquist was being transported to Bay Area Hospital before he was Life-flighted to RiverBend Hospital in Springfield.

Culver has been charged with Attempted Murder, First Degree Assault, and Felony Hit and Run.

This investigation is continuing.

COQUILLE, Ore. — As expected, a 31 year old Coos Bay woman was arraigned Friday for the hit and run fatality involving a pedestrian in the parking lot of Pony Village Mall near the Mini Pet Mart.

According to the Coos County District Attorney's office, Kelsey Culver was charged with second degree murder for allegedly hitting and killing 41-year-old Kyle Hagquist.

The incident happened Tuesday

Records show Culver has over a dozen previous violations from 2017 to 2021 for driving while suspended or revoked.

Her next court appearance is March 30 where the judge is expected to set a plea date.

Culver's bail is set at \$2 million.

The case is expected to go to a grand jury.

#### PORTLAND PROTESTS-PLEA

Man gets 10 years for violent actions during Oregon protests

PORTLAND, Ore. (AP) — A man from Indiana accused of hurling Molotov cocktails at police and breaking windows during the Antifa inspired riots in Portland in 2020 has been sentenced to 10 years in prison.

Malik Muhammad initially faced dozens of charges in state and federal court stemming from the riots, after traveling from Indianapolis to Portland.

He pleaded guilty to 14 felonies including attempted murder Tuesday as part of a plea agreement.

Muhammad also pleaded guilty in U.S. District Court on Monday to two counts of unlawful possession of a destructive device in connection with the same protests.

No additional prison time is expected in that sentencing...

PORTLAND, Ore. (KOIN) — Oregon has a teacher shortage. And the problem is getting worse.

The State legislature is exploring ways to attract and retain teachers, and Lawmakers one of their strategies is to recruit some of the 30,000 people in Oregon who have active teacher licenses but aren't teaching

HB4030 is one of the Bills being discussed.

Portland Democrat Michael Dembrow, who chairs the Senate Education Committee.

House Bill 4030 proposes allowing teachers with out-of-state licenses to work without getting licensed in Oregon, reduces the number of background checks and creates a state teaching jobs portal so teachers can apply in multiple districts at one time. The bill also provides funding to help substitute teachers and teaching assistants get certification.

There were meetings with teachers unions, education groups, teachers and administrators last fall to brainstorm ideas to recruit and retain more school employees.

SALEM, Ore. — Over the last 10 years, Oregon has had the sixth-highest number of domestic violent extremism incidents of all U.S. states, despite being ranking 27th in the nation by population.

The report released yesterday by the Oregon Secretary of State's Office found the state can and should do more to prevent future domestic violent extremism incidents.

Oregon is one of 16 states in the U.S. that has no legislation at all defining or specifically criminalizing domestic terrorism or domestic violent extremism at the state level.

The report says: "Enacting laws doing so could "provide the state with mechanisms to mitigate future risk,"

It also highlighted how law enforcement agencies can work to prevent and respond to extremist threats through coordinated networks. And suggests the state do more to create public awareness of the threats.

Secretary of State Shemia Fagan "The rise in domestic terrorism is an immediate threat to Oregonians and we cannot simply wait for the next incident to occur,"

SALEM – The Oregon Health Authority has ordered 6 million home test kits to be given away free to help detect the coronavirus.

The kits, each containing two tests, will be sent to health agencies, schools and community organizations to distribute.

They also will go to farm and agricultural workers, health care workers, shelters and early learning centers.

Commercially-available home test kits have been in short supply, with some pharmacies and other retailers reporting they are selling out as soon as they get stocks in.

The state stock will be in addition to the federal government's announced 500 million free at-home tests. A website to request those tests is expected to be operating soon.

Oregon issues hospital crisis care standards as COVID surges

PORTLAND, Ore. (AP) — Oregon health authorities have published new interim guidelines for hospitals to follow if a surge of COVID-19 patients forces them to activate crisis standards of care.

The policy will be used to help decide which patients get urgent, life-saving care if there aren't enough hospital beds, staff or critical medical equipment.

The standards are based on similar guidelines developed in Arizona, Massachusetts and Washington amid the pandemic.

The policy replaces a previous one that was criticized by groups that said they discriminated against the elderly, the disabled and those with serious pre-existing illnesses....

Researchers: COVID hospitalizations in Oregon are peaking

SALEM, Ore. (AP) — The number of people hospitalized for COVID-19 in Oregon will peak this weekend near current levels, and then steadily recede to preomicron levels by the end of March.

That's according to a weekly report by Oregon Health and Science University.

Meanwhile, the percentage of tests for COVID-19 that were positive dropped this week to 19% from an all-time high the previous week of 24.5%, according to Oregon Health Authority data.

In Oregon, the number of hospitalized patients with COVID-19 dipped slightly and the number of COVID-19 patients in ICU beds also dropped.

Gov. Kate Brown has \$200 million workforce development plan

SALEM, Ore. (AP) — Oregon Gov. Kate Brown is proposing a \$200 million legislative package to bolster the state's workforce during the pandemic.

Oregon Public Broadcasting reports the program, titled "Future Ready Oregon," aims to prioritize key populations disproportionately impacted by COVID-19 and existing disparities.

They include Oregonians of color, women, low-income individuals, rural communities, veterans and those who are incarcerated or formerly incarcerated.

Three specific sectors would benefit from the program: Health care, manufacturing and construction.

The total \$200 million would be composed of both state general fund monies made up of personal and corporate income taxes, as well as American Rescue Plan Act dollars.

Scott Burns, a geology professor at Portland State University, told KOIN that while episodes of increased uplift have been observed in this region before, the cause is what local scientists are excited about because the last major volcanic eruption in Oregon, which was 2,000 years ago, was right there in that area.

Burns said: "We believe that the magma is rising about four miles below the surface.

Despite the excitement, USGS and Burns have said that the public is not in any immediate danger. The volcano status is currently listed as "green," and there is no sign of an imminent eruption.

The Oregon Court of Appeals heard arguments Tuesday in a case that has major implications for how the state manages forestland and whether counties can depend on timber revenue from state forests.

The state of Oregon is challenging a 2019 jury verdict that required the state to pay more than \$1 billion to 13 counties including Coos who've lost money as

logging declined.

The counties donated about 700,000 acres of forestlands to the state in the 1930s and 1940s, when they didn't have the resources to make the land profitable.

PORTLAND, Ore. (AP) — Federal regulators have issued a draft environmental impact statement saying there are significant benefits to a plan to demolish four massive dams on the Klamath River to save imperiled migratory salmon.

That sets the stage for the largest dam demolition project in U.S. history.

The issuing of the statement Friday by the Federal Energy Regulatory Commission clears a major regulatory hurdle for the project and paves the way for public hearings on the document before a final draft is issued as soon as this summer.

That would allow preparations to begin in earnest for taking down the dams. The aging dams were built before current environmental regulations.

Climatologists: Drought to worsen in Oregon, Idaho this year

PORTLAND, Ore. (AP) — Climatologists in the U.S. Pacific Northwest warn that much of Oregon and parts of Idaho can expect even tougher drought conditions this summer than in the previous two years.

Water and climate experts from Oregon, Washington and Idaho said at a news conference called by the National Oceanic and Atmospheric Administration that parts of the region should prepare now for severe drought and wildfires.

PORTLAND, Ore. — Oregon is rolling out a new website and hotline to help track people who test positive for COVID-19 using an at-home test kit.

The new opt-in method for tracking coronavirus cases comes with a shift in how the Oregon Health Authority investigates coronavirus cases.

OHA will move away from individual investigation and contact tracing calls to focus on investigating outbreaks in high-risk settings.

State health officials said they hope the opt-in approach will quickly get information – like resources on how to safely isolate and quarantine - to people who tested positive or were exposed to COVID-19.

While not required, the OHA strongly recommends people report their at-home test results and let close contacts know they may have been exposed, so they can help limit the potential spread.

PORTLAND, Ore. (KATU) — The first-ever, Pacific-wide Tsunami Advisory caused by a volcanic eruption, rather than an earthquake, should serve as a wakeup call for coastal residents.

That's what Scientists are saying in the wake of Saturdays event.

Experts said the largest waves had spared the Oregon coast, as compared to areas farther south in California.

While the waves seen along the Oregon coast may not seem like a big deal, experts caution that under a Tsunami Advisory, anything can change in a second.

Harold Tobin, director of the Pacific Northwest Seismic Network and professor of the University of Washington said: "It just shows that we have to be vigilant. This is a good reminder and a wake-up call that tsunamis are a possibility," adding" This volcanic eruption is a historic one and experts will be studying it for years to come...

PORTLAND, Ore. — The Oregon Health Authority is holding two public hearings Monday to discuss making masking inside schools and health care settings permanent, as well as to take public comment on vaccine requirements for educators and health care workers.

Oregon Health Authority extends mask rule in schools

PORTLAND, Ore. (AP) — The Oregon Health Authority has adopted permanent rules requiring masks in school settings.

Oregon Public Broadcasting reports the permanent rule replaces a temporary one that was set to expire on Jan. 28.

Oregon health and education officials have required masks in schools as one mitigation strategy meant to limit the spread of COVID-19, so students can stay in school full time.

Oregon education officials say any repeal of the making rules depend on the course of the coronavirus.

Health officials said that COVID-19 hospitalizations and deaths, transmission data, vaccination rates, and guidance from the Centers for Disease Control and Prevention all play a role in the mask requirement decision-making.

The Oregon Health Authority is reporting that COVID-19 hospitalizations in Oregon are declining faster than expected which is pushing the state closer to lifting its indoor mask mandate.

In a news release last week, the Oregon Health Authority said it would lift the indoor mask mandate on March 31, or potentially sooner, "if hospitalizations decline to the levels projected by the end of March sooner than expected."

Peter Graven, the director of the Office of Advanced Analytics, said "We will look at the data at that time to ensure we are expected to continue a downward trajectory in daily hospitalizations, and if that is the case, whether it is safe and prudent to lift the requirement prior to that date.

Two counties in southern Oregon have declared states of emergency related to cannabis, paving the way for a moratorium on new hemp licenses.

Jackson County commissioners declared a local state of emergency Thursday while Josephine County commissioners declared one Wednesday, The Mail Tribune reported. A new Oregon law requires the state to deny applications for new hemp licenses in counties that declare a cannabis emergency.

Law enforcement agencies found a slew of problems at illegal marijuana grows they busted in 2021, including workers living in squalid conditions, water theft, improper use of pesticides and other chemicals, garbage, electrical wiring hazards and evidence of illegal drug trafficking.

Agencies believe organized criminal networks, including foreign drug cartels, are financially backing many of the illegal grows.
