### Journalism Internship Agreement

The following criteria must be met in order to successfully complete a journalism internship at The University of Texas-Pan American:

- 1. No student may enroll for internship hours without prior approval of the instructor.
- Students within 50 miles of the UTPA campus are required to meet at least every two
  weeks with their faculty advisor to discuss progress in their internship.
- Students more than 50 miles from campus will keep their UTPA advisor abreast of their work progress via e-mailings at least once a week.
- 4. It is the student's responsibility to make sure their work supervisor mails a letter directly to the UTPA faculty advisor at the end of the internship period. The letter should describe the student's work responsibilities, and include an overall evaluation of the student's performance.
- 5. Students will compile a portfolio of their work (articles and/or photographs) during their internship. The portfolio will be due at a time specified by the intern's UTPA faculty advisor.
- 6. The student will complete a narrative (minimum length 2,000 words) that details their work as an intern. The narrative will include--but is not restricted to--the following:
  - a) a comparison of classroom learning with real world experience: similarities & differences
  - b) specific job related learning experiences.
  - c) insights gained about the field through the internship.
