The stations donate air time to benefit state agencies, enabling them to publicize events and programs of interest to the general public. NCSA campaigns aired during the third quarter of 2018 were National Guard, Virginia Tourism, Virginia State Parks and Virginia Health Department. The stations also air numerous public service announcements provided by the Ad Council dealing with issues of interest to the public.

American Radio Journal is a weekly half hour public affairs program that focuses on informing and educating listeners on the key issues of the day. The program concentrates on national economic issues, and also covers significant foreign affairs developments and occasionally pressing social issues.

American Radio Journal airs Sundays at 9:30 AM on WGVY-AM. Program summaries for third quarter 2018:

Air Date: July 1, 2018. Topics include a Supreme Court ruling against forced union fees, the upcoming battle to confirm a new Supreme Court justice, a light rail referendum and a commentary on the passing of a sports icon.

Air Date: July 8, 2018. Topics discussed include efforts to combat the opioid crisis, US Senate cancellation of its summer recess, economic losses due to tariffs, commentary on the future of affirmative action.

Air Date: July 15, 2018. Topics include the Federal Reserve, the Supreme Court justice confirmation process, the scope of asset forfeiture in Michigan and a commentary on the appointment of Brett Kavanaugh to the US Supreme Court.

Air Date: July 22, 2018. This week's topics include discussions on truth, justice and the American Way, campaign fundraising, Judge Brett Kavanaugh's record on second and fourth amendment rights, and commentary on US Presidents and their Russian counterparts.

Air Date: July 29, 2018. This week's topics include the proposed \$12 billion farm subsidy, Supreme Court ruling on state sales taxes and commentary on the impact of the administration's tariff policies.

Air Date: August 5, 2018. Topics include a proposed carbon tax, tax cuts, a proposal to have federal taxpayers subsidize high end housing costs, and commentary on intolerance in academia.

Air Date: August 12, 2018. This week's discussions include the cost of the Medicare for All plan, results of a special congressional election in Ohio, a California law preventing ex-inmates from becoming firefighters, and commentary on the left's love affair with Russia.

Air Date: August 19, 2018. This week's topics include a new book "The Great Revolt," US Senate races, the moral case for free trade, and commentary on property taxes.

Air Date: August 26, 2018. This week's subjects for discussion include Congressional Republicans who try to appease the left, the impact of Trump associates' legal problems on the mid-term elections, the possible re-appointment of an Obama member of the National Labor Relations Board and commentary on former intelligence officers and security clearances.

Air Date: September 2, 2018. This week the discussion includes the importance of the Immigration and Customs Enforcement agency, primary election results in Florida and Arizona, the impact of a congressional redistricting court decision in North Carolina, and commentary on the inconsistency of the left.

Air Date: September 9, 2018. This week's topics include details on the new US - Mexico trade agreement, tax cuts, a new plan to tax major employers, and commentary on a spending spree by the states.

Air Date: September 16, 2018. This week the discussions include the International Criminal Court, the political impact of the Brett Kavanaugh confirmation vote, labor unions and the Janus decision, and commentary on why Americans need to lighten up.

Air Date: September 23, 2018. This week American Radio Journal discusses the landmark Janus v AFSCME Supreme Court decision, the impact of the Kavanaugh controversy on the mid-term elections, state competitiveness, and a commentary on the post-911 generation.

Air Date: September 30, 2018. This week's topics include tax cuts, the federal budget, trade policy and a commentary on saving the Social Security system.
