# **POST-FILING RENEWAL ANNOUNCEMENT INSTRUCTIONS**

The following contains instructions for the broadcast of post-filing renewal announcements for Sinclair's **Tallahassee**, **FL** station. Pre-filing announcements are no longer required. Included with these instructions are the text of the post-filing announcements and a Statement Certifying Compliance that needs to be completed, dated, executed and <u>placed in the station's online public</u> <u>inspection file within seven (7) days</u> after the last post-filing renewal announcement has been aired (<u>December 23, 2020</u>). If for any reason the station did not air the required announcement on the specified days and during the specified time periods, please contact the company's communications counsel before the Statement Certifying Compliance is finalized, dated and executed.

## **<u>Post-filing Renewal Announcements for</u>** WTWC-TV, Tallahassee, FL, Facility ID 66908

The following post-filing renewal announcement must be read over the air on the station's primary programming stream on each of the following days: October 1, October 16, November 1, November 16, December 1, and December 16, 2020.

Of these six airings:

- 1. At least three of the announcements must be aired between 6:00 P.M. and 11:00 P.M.
- 2. At least one announcement must be aired between 9:00 A.M. and 1:00 P.M.
- 3. At least one announcement must be aired between 1:00 P.M. and 5:00 P.M.
- 4. At least one announcement must be aired between 5:00 P.M. and 7:00 P.M.
