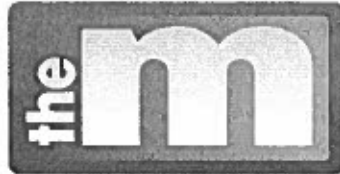

The Buffalo diocese is under federal investigation. Bishop Richard Malone refuses to resign and accused priests remain part of the Catholic Church. - 10/06/18 **48 HOURS: "Hollywood Horror Story"** – a report on the brutal murder of Iana Kasian, a woman killed by a perpetrator who left the crime scene like something out of a graphic novel. Kasian, a tax attorney, in what seemed like a charmed life, immigrated to the United States to be a translator. While living in California, she met Blake Leibel, the son of a wealthy Canadian real estate family. He lived a complicated life, but longed to make it big in the Hollywood film industry. Almost a year before he met Kasian he was obsessed with the notion that his family would be harmed by someone tied to his brother Cody, who had big gambling debts. At the time Kasian was killed, Leibel was divorcing his wife, living with Kasian and his newborn daughter Diana. He was also romantically involved with another woman. Kasian's mother, Olga Kasian, became concerned when she could not reach her daughter. She called the police, who eventually gained access to the home she shared with Leibel -- authorities were shocked by what they found. Leibel was barricaded inside a bedroom and Kasian was discovered dead in the bathroom. Her body covered with a blanket, she was extremely pale, and she was scalped. It was a horrible, sadistic killing, just like a scene in one of Leibel's movies. Police arrested Leibel. Investigation led to the discovery that Kasian's body was drained of blood. It took 6-8 hours for her to die. Leibel stood trial and the scenes from his graphic novel and the film he directed took center stage. He was found guilty of first-degree murder without parole. **On-screen text graphic:** Olga has filed a wrongful death lawsuit against Blake Leibel. Any proceeds would go to Diana. Diana is an American citizen. Olga is still hoping to raise her in the United States. - 10/13/18 **48 HOURS: “Dead Ringer”** - a report about former pro boxer Ramon Sosa, the potential victim in a murder-for-hire scheme, who with the help of law enforcement agents, managed to survive -- all the while setting up a sting operation to catch those responsible. Sosa owned the popular Woodlands Boxing and Fitness in Montgomery County, Texas. He had a family and a beautiful second wife who helped him run their booming business. After six years together, things began to sour between Sosa and his wife -- he learned of a divorce attorney and missing money from the business. And then someone wanted him dead. A friend of Sosa’s named Mundo, who worked out at the gym, overheard Sosa’s wife Lulu and was sure she had murder on her mind. They came up with a sting operation to protect the boxer, in which Mundo posed as a hit man. When they had evidence, they contacted the police, who then took over the case. Mundo still played along, agreeing to kill Sosa, and provided photographic proof of the death. Police staged the death scene, with Sosa’s “dead body” photographed in a ditch with a bullet hole in the head. Lulu Sosa was arrested, and claimed she was innocent. She was charged with solicitation of capital murder. After 15 months, she gave up the fight and agreed to a plea deal to reduced charges and twenty years in prison. **On-screen text graphic:** Lulu Sosa comes up for parole once a year. This past Tuesday, she was denied parole for a second time. - 10/20/18 **48 HOURS: “The Fitbit Alibi” (9:00 – 10:00p)** – a report on the groundbreaking 2016 murder case of Nicole Vander Heyden that was solved using 21st century technology. Vander Heyden went out with her live-in boyfriend Doug Detrie and other friends for a night on the town in Green Bay, Wisconsin and never made it home. A day later, she was found beaten and strangled in a field. Her live-in boyfriend became the prime suspect and was arrested because he had separated from the group during the barhopping and went home without Nicole. Detrie was wearing a Fitbit device and the data recorded during the time of Vander Heyden’s murder corroborated with what Detrie had told police, therefore clearing him of suspicion. He was released 18 days after his arrest. Over the next several months, clothes and other items found at the murder scene were processed by the police for DNA, which led police to George Steven Burch, a man who had moved from Virginia to Green Bay for a fresh start. Burch was questioned about a hit-and-run and had handed over his cell phone to police. The phone was an Android device with a Google account, which stores and tracks a person’s exact location within Google’s servers and is viewed with a tool called Google Dashboard. Investigators got a warrant to view Burch’s account and discovered that on the night of the murder, the data tracked him to Nicole’s house – the crime scene – where he stayed for nearly an hour. He was arrested and charged with first-degree intentional homicide. On February 19, 2018, George Burch went on trial for Nicole’s murder. The technology evidence from Fitbit and Google played an important part of the proceedings. Also in the courtroom, the sister and fiancé of Joey White, a man Burch killed in Virginia twenty years ago. Neither is surprised that Burch is on trial again. Only this time, they hope he is found guilty, and is not acquitted. It took the jury three hours to find Burch guilty. **On-screen text graphic:** Doug Detrie continues to raise Dylan, now two. A massive search ensued. It ended after 44 days with Williams listed as “still missing.” People wondered if he had run off. After six months, his waders, hunting license and a flashlight were discovered at the lake and another explanation was offered: he was eaten by alligators. Mike’s mother, Cheryl Williams, always believed there was more to the story. For nine years, she wrote to the governor of Florida urging him to re-open the case. She even contacted wildlife experts, who told her that alligators do not feed in cold winter months. In the meantime, Denise Williams moved on with her life, cashed in life insurance policies and completely cut off contact with Mike’s mother. She eventually married Mike’s best friend Brian Winchester. Seven years later, the re-opened investigation led to suspicions that both Cheryl and Brian were involved, but police could do nothing because they were married to each other. Soon after, their marriage disintegrated. Police saw an opportunity when Brian cracked after assaulting and kidnapping Denise, to which he pleaded guilty and cut a deal with prosecutors: he finally admitted to killing Mike Williams. Brian revealed the location of the body, with the understanding he that would not be charged with murder. He said it was all Denise’s idea -- she was not willing to be divorced, but wanted to be with Brian. She was arrested and charged with murder and is currently awaiting trial. **On-screen text graphic:** Denise Williams is scheduled to stand trial for the murder of her husband on December 10, 2018. Mike and Denise’s daughter is nineteen and in college. She is said to be close with Denise’s sisters. Azzeh eventually went on to help undercover agents with the case, which included staging the deaths of the intended targets, McDaniel’s ex-husband Marion “Mack” McDaniel and Meghan Verikas. During the sting operation, which included the use of bodycam footage, the couple was arrested. Included are excerpts of the bodycam footage, and of a recorded diary McDaniel started after being released on bail. She took her own life sixteen days later. Leon Jacob has pleaded not guilty. Dilione then provided information about Rackover and Max Gemma, whose father was once the mayor of Oceanport, NJ to the police. The investigation revealed that after the murder, Comunale’s body was dumped out of a window at the Sutton Place address, driven to Oceanport, NJ and left in a hole in the ground in a wooded area behind a florist shop. Rackover and Dilione were charged with the brutal murder of Comunale and other crimes. Max Gemma was charged with hindering prosecution and tampering with physical evidence. After the arrest, police discovered that Rackover, was not really the son of the celebrity jeweler, but an ex-con from Florida named James Beaudin, who Jeffrey Rackover had befriended, explaining that he was the son he never knew about. At trial, both Rackover and Dilione said the other was responsible. The star witness in the case was Louis Ruggiero, the troubled son of popular New York television anchor Rosanna Scotto. Ruggiero, a close friend of Rackover’s, testified about what Rackover told him happened that night, becoming the first witness who directly implicated James Rackover in the crime. On November 2, 2018, the jury reached a verdict: the former James Beaudoin, now James Rackover, was convicted on all counts for the murder. Dilione’s trial is set for January, with Gemma being tried at a later date. **On-screen text graphic:** James Rackover will be sentenced on December 5th. 48 HOURS: “Defending DJ” - a report about Danroy “DJ” Henry and the dedication and struggles his family endured trying to restore their son’s reputation after he was shot dead in Pleasantville, New York, by police officer Aaron Hess in 2010. This event triggered a seven-year journey for the family as they searched for answers about what really happened. During a night out with his teammates, a fight broke out among other restaurant patrons and police were called to the scene. DJ and his friends decided to leave. They were waiting in his car in a fire lane prior to their departure. Police approached the vehicle and told DJ he should move; his friends said DJ started to slowly move away. The police claim that DJ tried to mow officers down with his car when Officer Hess approached and that was how Officer Hess ended up on the hood of the car, shooting his weapon and fatally injuring DJ as he sat behind the wheel. The police claimed Officer Hess shot because he feared for his life. DJ’s friends painted a far different version of the incident. Witnesses agreed, also saying that medical attention was slow to respond. The Henry family vowed to learn the truth – even it was bad. They wanted to know what happened to their son and filed a lawsuit. Four years after the shooting, the family was still hopeful. In 2016, the Henry family accepted the decision in a wrongful death suit against the Village of Pleasantville and Aaron Hess and were awarded \$6 million. In 2017, they settled a wrongful death suit with the town of Mount Pleasant for an undisclosed amount and something more valuable to them: a public apology. Seven years after DJ’s death, they cleared his name. No criminal charges were brought in the case. Today, Aaron Hess works in private security. Their 1994 disappearance launched an international search for Barnett and Savanna that did not end until she was arrested in Australia. Lee Barnett was in the midst of a bitter divorce with then-husband Harris Todd. Barnett had married him even though he said he did not want children. Problems began after she became pregnant. They went to counseling, and during this period a doctor diagnosed her as having hyperthymic temperament, a form of bipolar disorder. After Savanna was born, she filed for divorce. Harris counter-sued. The judge sided with Todd. Barnett then started to make plans to leave with 11-month-old Savanna. She obtained fake documents (birth certificates and passports) and disappeared. An FBI manhunt ensued. She was vilified in the press. In 1999, Harris Todd told 48 HOURS that she was mentally ill. Barnett countered with her side of the story: she cut off all contact with her family and headed to Europe, then Malaysia, Singapore, South Africa, Botswana and Australia. Along the way, she met and married Alex Geldenhuys, and had another child, Reece. Unbeknownst to Savanna, she became Samantha Geldenhuys. While they were on the run, Barnett also kept a secret diary for her daughter, planning one day to tell her the story of her life. In 2011, the FBI got a tip that Barnett was living in Australia. Samantha learned about her past from the agents. In 2013, Barnett was extradited to the United States. Samantha has read all the transcripts and the diaries and has a new understanding of her mother. Barnett pled guilty to all charges and spent 21 months in prison. Samantha eventually met her father and described it as a surreal experience. Later, Mead changed her story: it wasn’t suicide, it was her estranged husband Kris Ertmann, who tried to kill her. Mead claimed she met Ertmann in a secluded park to get a child support check. He suddenly grabbed her in a bear hug and slit her throat. Thinking she was about to die, she drove the car to a parking lot which became a second crime scene. An investigation led to Ertman being arrested and charged with attempted murder. He claimed he could not remember anything and had PTSD. Additional investigating revealed Ertmann ultimately trying to arrange a hit on his estranged wife, resulting in an undercover cop posing as a hit man and getting instructions from Ertmann to kill his wife. The case never went to trial. Prosecutors offered a deal to plead no contest, and will spend the rest of his life in prison. Tiffany Mead lives with her new husband and her emotional support dog. Another was Tony Jackson, a serial rapist who lived nearby at the time of Jodi’s disappearance. Throughout the years, friends and family members have kept up the search for Jodi, despite her family declaring her dead in 2001 as a means to settle her estate. In 2003, a group of journalists created a website to keep the story alive and to crack the case. As of 2017, John Vansice, living in Phoenix, is still considered a suspect. Mason City police believe they are close to solving the case. On June 5, 2018, which would have been Jodi’s 50th birthday, four billboards were unveiled in Mason City, Iowa, keeping her memory alive with the hope of solving her disappearance. **On-screen text graphic:** FindJodi. Williams, a successful real estate appraiser, left home to go duck hunting on Lake Seminole on his sixth wedding anniversary. When he did not return home, his wife Denise started looking for him. A massive search ensued. It ended after 44 days with Williams listed as "still missing." People wondered if he had run off. After six months, his waders, hunting license and a flashlight were discovered at the lake and another explanation was offered: he was eaten by alligators. Mike's mother, Cheryl Williams, always believed there was more to the story. For nine years, she wrote to the governor of Florida urging him to re-open the case. She even contacted wildlife experts, who told her that alligators do not feed in cold winter months. In the meantime, Denise Williams moved on with her life, cashed in life insurance policies and completely cut off contact with Mike's mother. She eventually married Mike's best friend Brian Winchester. Seven years later, the re-opened investigation led to suspicions that both Cheryl and Brian were involved, but police could do nothing because they were married to each other. Soon after, their marriage disintegrated. Police saw an opportunity when Brian cracked after assaulting and kidnapping Denise, to which he pleaded guilty and cut a deal with prosecutors: he finally admitted to killing Mike Williams. Brian revealed the location of the body, with the understanding he that would not be charged with murder. He said it was all Denise's idea -- she was not willing to be divorced, but wanted to be with Brian. She was arrested and charged with murder. Original on-screen text graphic: Denise Williams is scheduled to stand trial for the murder of her husband on December 10, 2018. Mike and Denise's daughter is nineteen and in college. She is said to be close with Denise's sisters. **12/22/18 Update:** The trial began in December 2018. The prosecution's star witness, Brian Winchester, admitted he killed Mike Williams. Defense attorney Ethan Way was so confident the state had no hard evidence that he did not want the jury to consider any charges less than murder one. The jury took eight hours to reach a verdict: Denise Williams was guilty on all counts. According to Ryan’s friends, Shayna’s behavior became obsessive. He told her he was not seeing her on the weekend of October 12, 2012, but did not tell her that he had a date with another woman. He did not make the date: a 911 call to police was made by Shayna, telling police she had shot her boyfriend in self-defense. Police were suspicious from the start. She had shot him six times. Shayna also talked endlessly during the 3-hour interrogation video and then, when alone, she danced and sang songs. Friends said Ryan was not an abuser. She was charged with murder. Investigation revealed that, after the shooting, she waited 10 minutes to call 911. She also texted endlessly; there were thousands of text messages to Ryan, most of which he did not answer. Yet, because of Kentucky laws, he could not get a restraining order. Prosecutors believe that Shayna could not deal with Ryan’s rejection and that her rage sent her over the edge. She believed it was over for good and would have none of it. Now it is 2014, and she has been jailed since 2012 awaiting trial. In 2014, two and a half years after the crime, the trial is set to begin. Central to the trial is what Shayna told police. Prosecutors believe the only person in danger that night was Ryan Poston, and that Shayna acted out of hate. Ryan did not want to see Shayna anymore. There were no signs of a violent struggle, as Shayna had suggested happening. Shayna’s mother, Sharon Hubers, cannot comprehend what is happening to her daughter. The defense must convince the jury that Ryan was the aggressor. A verdict is reached: guilty of murder. The court re-convenes for sentencing. Shayna Hubers, who has been diagnosed as a narcissist, addresses the court, but never apologizes to Ryan’s family. Shayna Hubers is sentenced to 40 years. 07/15/17 Epilogue: One year later, a surprising development: a new trial is ordered. The verdict was overturned due to a problem with the jury. Shayna will be tried all over again, in about a year. Ryan’s family is ready. **12/29/18 Update:** In August, 2018, newly married Shayna Hubers is prepared. She now claims that Ryan was abusive and she suffers from a borderline personality disorder. Her stories about that night have changed as well, and the prosecutor hones in on that. The jury finds her guilty. The next day, after the victim impact statements, the jury calls for life in prison -- more time than Shayna received in the original trial. Jacob Kittilstad welcomed the returning guests from the **Back the Badge Golf Outing & Dinner** for this year's check presentation for **Band of Blue**. The golf outing itself is an event for members of law enforcement to relax and enjoy some time with their co-workers away from work – but it also raised money for the charity which gives positive life experiences to children of officers who have died while on the job.

Startup Racine is a spin-off from **Startup Milwaukee** – which seeks to connect entrepreneurs with local resources. **Jacob** learned about the line-up for **Racine Startup Week** which will educate people on how to find capital, know what to look for while navigating the legal aspects of a new business, and understand the importance of online marketing. Organizers hope the network established at events like this will promote growth within the community and act as a sort of idea incubator.

The football program at **Horlick High School** has seen a lot of success this season – and Head Coach **Brian Fletcher** is getting some recognition for that after being nominated for the **U.S. Cellular "Most Valuable Coach"** award. He's already made it into the top 15 and, if he wins, he stands to bring in tens of thousands of dollars for the school.

Senior Lineman **Stephon Chapman** talked about Coach Fletcher's impact on the Horlick High School Football team. **Jacob** also asked Chapman about his own personal story – which included a lot of moving around the country as a young man, until he finally made the decision to stay in the city of Racine and continue playing football. Solen said she opposes the plan and warns that the decision would leave millions of American citizens in a legal-limbo with regards to their identities.

Next **WI Appeals Judge Brian Hagedorn** told **Jacob** about his decision to run for a seat on the Wisconsin Supreme Court. He talked about his current responsibilities and his past background working as chief legal counsel for Governor Scott Walker. He also referenced the opioid epidemic as something that he would like to address if given the opportunity to hold the position – and gave examples of what he could accomplish.

The **Racine Zoo** is preparing for the holidays with some upcoming visits from Santa Claus and his reindeer. **Merry Zoomas** and the **Brunch with Santa** will mix Christmas-related activities with up-close animal encounters for

Jamie also says that Cameron was bullied for “acting feminine” and she believes this contributed to the suicide. The discussion also referenced the recent proposal by the Trump administration to change the legal definition of gender – which Jamie opposes.

Next, **Rabbi Martyn Adelberg** talked to Jacob about the rise of anti-Semitic violence and rhetoric nationwide. Rabbi Adelberg reflected on the support Racine’s **Beth Israel Sinai Congregation** has received from the community since the mass shooting at Pittsburgh’s **Tree of Life Synagogue**. He also spoke about the role he feels social media plays in motivating the hate speech and violence.

In its twelfth year, **Blank-Fest Wisconsin** is returning to **McAuliffe’s Pub** to collect donated items for people who are homeless in the Racine-area. Instead of selling tickets, organizers ask that event-goers bring items like blankets and toiletries (and that donation will act as their tickets in). The two-day festival will feature one day of folk-related music and another day of rock-adjacent acts. HALO Inc. also joined the interview to talk about the impact of these donations during this time of year.

Jacob Kittilstad recognized that there is always another election to be looking ahead to – and the next race on the calendar is for a seat on the Wisconsin Supreme Court. **Chief Wisconsin Appeals Court Judge Lisa Neubauer** is running for that position. Jacob asked her questions about her approach to the law and talked about how she separates the legislative life of her family members from her own profession in the judiciary branch.

Jacob Kittilstad looked back at the end of Prohibition – and how it affected part of Racine. For about a century areas of the city have been "dry" because of rules enacted by aldermen immediately after the end of Prohibition. But a new bar/restaurant recently earned approval from the city council and it is being seen as a historic moment.

If you'd like to see some breakdancing – up close and personal – you have a chance coming up. **Sweatshop Movement** is hosting a Bboy event called **JAM the GYM: The Battle "Sweat the Technique 5"**. The event will bring together competitors from across the region while also showing younger local Bboys the ins-and-outs of a large scale competition. The event is a fundraiser for the group which recently moved into a larger space to answer growing demand for their programs in Racine.

For the fourth year in a row **Rapeine** (and its editor Jesse Booker) is holding their **Santa Is Real** fundraiser. The goal of the work is to get presents to kids whose families might not otherwise be able to afford them. The amount of money raised has about doubled every year – and this year the effort has already raised close to \$5,000.

If you're not seeking out bagpipe music you might not often hear it. However, a 13-year-old in Franksville hears it pretty much every day when he practices. **Clayton Nelson** started playing two years ago and has already been identified as a budding talent in this area of music. He talks to Jacob about how he's honing his skills and gives an in-studio performance.

Jacob Kittilstad presented a full interview with **Lenny Zwieg** to start off the show. People around Burlington may know him (and his family) from their T-Shirts which ask people to "Share Your Spare" – a reference to the fact that the father of three needs a kidney donation. The T-shirts were his fiancée's idea and they started getting a lot of interest after a picture of Zwieg at a Brewer's game went viral online. The family talks about the struggle finding a donor match and how they continue to support one another through the decade long health-fallout from Dengue Fever.

Next, **Racine County Foster Care** joined Jacob in-studio to talk about their new campaign titled "**Bring Them Home**". The goal of the effort is to get more local parents involved in the foster care system so that the 90 children who have been sent out of county can return to the region where their families and schools are. Program coordinators say that trauma for children is reduced when they can stay closer to their communities – and they say continuing connections with people who know them also makes their lives less chaotic. Foster mother of 22 children, **Stacy Scott**, also talked about her commitment to the program and shared why she got additional training to take in more than one child at a time (especially siblings).

The **Racine Studio of Performing Arts** is preparing for their annual recital known as **RSPA Present The Greatest Show**. The studio's director brought along two young dancers who have had to overcome challenges to even get on stage – and one of the 12-year-olds showed-off one of the solo dances that she has been preparing for.

Beat Council wrapped up the show by promoting their album which is coming out on Memorial Day. It's called "**Crown**" and it brings together producers, rappers, singers, and music video producers who live in the Racine area. **Kiondre Graham** and **Armon Wilkes** also gave a special performance of the new single "**Work**" – which they say speaks to the blue collar work ethic in the city.

Jacob Kittilstad has completed his set of interviews with every candidate seeking to replace **Speaker Paul Ryan**. As a former employee, **Bryan Steil** has been endorsed by Speaker Ryan ahead of the Republican Party primary. The core of his work with the congressman involved economic, finance, and budget issues – and he shared no political criticism of his potential predecessor or **President Donald Trump**. Steil expressed hope about the possibilities the Foxconn Development will bring to the region – and also shared his opinion on a few key issues including immigration and abortion.

As a follow-up, congressional candidate **Kevin Adam Steen** joined Jacob in-studio for a discussion on his background. Steen spends most of his time around the Burlington-area and has separated himself from the other candidates by defining his political identity in terms of his religious beliefs. The candidate shared his opinions on

abortion, gay marriage, and the legalization of marijuana. He also talked about his support of **President Donald Trump** – and his skepticism of one of his opponents on the primary ballot: **Bryan Steil**.

When a toaster stops toasting or a blender stops blending the typical response from people these days is to throw away the appliance. The new **Repair Café** at the **Racine Public Library** is hoping to reverse that trend by providing both tools and volunteer-experts to guide people with questions. The volunteers are often older individuals who learned how to be handy by virtue of how they were raised. The goal is to share those skills as they may have not made it through the latest generational jump. Volunteers also can offer guidance on fixing clothing, furniture, and other items you might find around the house. The events are scheduled for the third Sunday of every month at the Racine Public Library from 11:00 a.m. to 1:30 p.m.

And the **Wisconsin Senior Olympics** has a qualifier race for nationals planned for Racine. **The Olympian 5k/10k** will take runners on a route along Lake Michigan – and will bring a wide variety of age ranges to the course. While many older racers will be competing in the WSO aspect of the event, younger athletes are also welcome to participate. In fact, organizers with **Real Racine** say the event will be inter-generational – and past events have included family members supporting one another.

The pair of entrepreneurs explains that the operation is run out of one of their homes - but they've already gotten steady orders coming from Mars Cheese Castle and Milwaukee Public Market.

After revealing the latest Ugly Mug, Jacob welcomed the organizer of **Racine's Got Talent 3** to the studio. The city-wide talent show highlights the special skills of people under age 18. This could include musical performances, dance, and spoken word. The event is also done in the style of a reality television show with live feedback given immediately after performances.

One of the competitors in Racine's Got Talent 3 is **Christina Pringle**. She's 15 (and a half)-years-old and is already writing her own music. She performed her original song "To Say Goodbye" before discussing her inspirations with Jacob. She also says that she still gets nervous while performing, but her competitive nature is pushing her to get on the talent show stage.

Lastly, Jacob revealed a talent of his own: drawing a county-by-county map of the state of Wisconsin in less than three minutes - the grand finale, of course, being Racine County.
