RE: MY WIFE AND KIDS – Sinclair Broadcast Group, Inc.

Dear Mr. Howitt:

Reference is hereby made to that Television License Agreement, dated as of June 14, 2004, between Buena Vista Television ("BVT") and Sinclair Broadcast Group, Inc. ("Client") relating to the license of MY WIFE AND KIDS for broadcast over the facilities of several of Client's Stations, including WLFL-TV/WRDC-TV (Raleigh-Durham), WUXP-TV/WZTV-TV (Nashville), WCGV-TV/WVTV-TV (Milwaukee), KMYS-TV/KABB-TV (San Antonio), WLOS-TV/WMYA-TV (Greenville/Spartanburg/Asheville), KOCB-TV/KOKH-TV (Oklahoma City), KVMY-TV/KVCW-TV (Las Vegas), KDSM-TV (Des Moines), WDKA-TV/KBSI-TV (Paducah/Cape Girardeau), WMSN-TV (Madison), WTWC-TV (Tallahassee), and WYZZ-TV (Peoria) (the "Agreement").

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree to amend the Agreement as follows:

The following provision is hereby added to the Agreement at the end of paragraph 11 (entitled "Syndex Protection/Cable Licensing"):

"During the 2008/2009 broadcast season, Client shall, by the terms of this Agreement, be entitled to invoke the protection against duplication of programming imported under the Compulsory Copyright License, as provided in Section 76.101 of the FCC rules. Notwithstanding the foregoing, the protections provided for hereinabove may not be invoked against the cable signal of a basic cable network and/or any so-called "superstation" (i.e., an over-the-air broadcast television station that is regionally and/or nationally retransmitted via cable, satellite or other technology)."

Except as specifically amended by, and without limiting the foregoing, the terms and conditions of said Television License Agreement shall remain in full force and effect and are hereby ratified by the parties.

If the foregoing is in accordance with your understanding and agreement, kindly acknowledge your approval and acceptance thereof by affixing your signature in the space provided below.
