DHEC Public Health – Duration: 29 min

ISSUE: Covid19/Flu

This week on Carolina Cares, Tyler Ryan speaks DHEC Public Health Physician Dr. Jonathan Knoche about the latest information on Covid 19, the DHEC best guidance, various treatments, what is on the horizon, the CDC's shifts in numbers, prevention etc., as well as the impact that this years flu may have on it. ISSUE: Environment

Boy Scouts of America Indian Water Council – 29 min

ISSUE: Community/Environment

This week on Carolina Cares, Tyler Ryan speaks with Doug Stone from the Boy Scouts of America Indian Water Council. The two discuss scouting, the history, the restructuring, as well as their involvement with the Power Plant initiative with the SC Flood Water Commission, as well as the Scouting Food Drive. January 24th.

MADD – 29 min

ISSUE: Road Safety/Drug & Alcohol Enforcement

This week on Carolina Cares, Tyler Ryan speaks with the South Carolina / North Carolina Regional Executive Director of MADD, Steven Buritt. The two discuss the challenges to DUI detection and prosecution, as well as the new laws aimed to cut down driving under the influence of any drug or alcohol. February 7th.

Richland County Public Library – 29 min

ISSUE: Education

This week on Carolina Cares, Tyler Ryan speaks with Richland County Public Library's Emily Stoll about the changes of modern libraries across the state and beyond. As libraries have transitioned well beyond a warehouse of dusty books, to community centers offering everything from traditional books to multimedia hubs, theaters, training, and more. February 14th.

Lexington County Museum – 29 min

ISSUE: History/Arts

This week on Carolina Cares, Tyler Ryan speaks with the Director of the Lexington County Museum, JR Fennell. The two discuss the rich history of the Palmetto State, from colonial days, to the involvement in the Revolutionary War, the move of the Capital to Columbia, the Civil War, and other historically significant moments in South Carolina's past. February 21st.

Lexington-Richland Alcohol and Drug Abuse Council – 29 min

ISSUE: Substance Abuse Treatment

This week on Carolina Cares with Tyler Ryan, Tyler speaks with Robbie Robertson and Hailey Kanipe from The Lexington-Richland Alcohol and Drug Abuse Council about additions, treatments, and specifically opioids, which have seen a 58% increase over the last year, tied to the COVID pandemic. The three discuss the issue on a local, statewide and national scale, and what may be behind the addictions which claim thousands of lives a year. February 28th.

DHEC Registered Dietitian – Obesity – 29 min

ISSUE: Health/Diet

This week on Carolina Cares, Tyler Ryan speaks with DHEC Registered Dietitian Farrah Wigand about the obesity epidemic that exists in the United States. With over 65% of adults having a BMI that is considered obese, the two discuss weight loss, healthy diets, and the reality behind the pills that promise to make you shed the pounds without the work. March 7th.

Harvest Hope Food Bank – 29 min

ISSUE: Hunger

This week on Carolina Cares with Tyler Ryan, Tyler speaks with Chuck Backman, with Harvest Hope Food Bank. Harvest Hope services 20 counties in South Carolina, from the Upstate to the Low Country, and partners with the other 4 food banks in the Palmetto State to provide food to families who find themselves food insecure. The two discuss the hunger problem in the state and on the national level, as well as how people can get involved. March 14th.

Providence House – 29 min

ISSUE: Substance Abuse

This week on Carolina Cares with Tyler Ryan, Tyler speaks with the Executive and Marketing Directors of the Providence House, a state-wide organization geared toward recovery from substance abuse and incarceration. The group also speaks with two men who have been through the program about the tunnel they went down prior to finding the bottom, and the recovery that is waiting. March 21st.

Spartanburg Lions Club International – 29 min

ISSUE: Community

This week on Carolina Cares, Tyler Ryan speaks with Gene Spiees, with Spartanburg Lions Club International. The two talk about the history of the club, which has a presence in over 200 countries, service to community, and Gene shares his journey to becoming involved in the organization. March 28th.
