After completing this training, the student is submitted to practice first, followed by a performance assessment.

Training internal procedures:

Radio Redentor FM 104.1 (WERR) enters in agreement with several educational institutions in order to become a branch for technical practice for their students to complete the required practice hours according to their Internship Programs. Each educational institution includes WERR in their list of participating stations for their student to choose.

Employees dedicated to Technical positions are assigned to perform trainings to the Intern Students in an interactive and demonstrative manner. They are exposed to the tools and digital fm equipment that are used at the station for radio broadcasting such as digital console management, recording, editing, ad patterns, broadcasting, etc, for live as well as for recorded programming.
