This Appendix contains a narrative description of the station's supplemental outreach efforts covering the period from February 1, 2023, to January 31, 2024.

- 1. On August 4, 2023, the company's chief revenue officer delivered a four-hour sales training session called "Impact Selling" for all WYDC's Account Executives. The station's Account Executives continue to receive periodic training and weekly follow-ups.
- 2. On March 23, 2023, WYDC's Multi-media Journalist, Maggie Hall attended and spoke at the Erwin Elementary School, Fifth Grade Career Fair. Maggie reviewed what it is like to have a career in broadcast journalism. Several students were featured in the evening's local news broadcast and were given the microphone to announce their future career ambitions.
- 3. We broadcast on-air announcements for job openings using existing employees to notify our viewers of those job openings at WYDC. We believe this generates additional interest in the community for job applicants through both our website and by visits to our facility.
- 4. On April 20, 2023, WYDC participated in the Southern Tier Virtual Career Fair. Frank Acomb, Host of our morning program Frankly Speaking, attended the event which supported recruitment efforts in Chenango, Dealware, Ostego, Chemung, Schuyler, Tioga, Tomkins and Broome counties. WYDC heavily promoted this event on-air.
- 5. We continue to offer job shadowing to prospective candidates. During the week of September 4, 2023, Multi-media Journalist, Josh Stuttle shadowed our existing Multi-media Journalist Maggie Hall before committing to the job.
