* A pair of major hurricanes, increasing fuel costs, and red tide are all taking a toll on the Gulf seafood industry, making the products scarce and expensive. Many shrimp boats were severely damaged by Hurricane Katrina. Even the good boats remain tied to the dock, because high fuel costs make shrimping unprofitable. With the hurricanes impacting up to $70 \%$ of the Gulf, oyster production is down and prices are up. Industry experts think it will be years before production is back to normal, with prices leveling off by this time next year.

** The excitement of gambling on the Gulf was taken away by Katrina. Mississippi casinos will remain closed for months to come, and that leaves many people here searching for entertainment. One area gaming center is profiting from Mississippi's loss, with Biloxi faithfuls causing a betting boom. A casino manager at the Creek Entertainment Center in Atmore said many others from our area who used to travel two hours to gamble in Biloxi are now making the near-by Poarch Creek Indian Reservation their destination. In fact, tour buses from as far away as Tampa stop in everyday. Business has doubled in the month since Katrina hit, and the center is expanding to meet the new demand. An additional gaming room is under construction, and plans for a multi-million dollar hotel-casino are in the works. Poarch Creek leaders say it should be complete by 2007.

We also reported on the relocation and expansion of IMS Expertservices, a firm servicing the legal community, with 16 new high-wage jobs for our area.

The county must generate extra revenue to pay for several transportation and infrastructure projects, as required under Florida's new "pay-as-you-grow" initiative.
