Since the FCC's rules have gone into effect on March 10<sup>th</sup>, 2003, the Station's employment unit has implemented two supplemental outreach activities, as provided by Section 73.2080(c)(2).

During this reporting period, March 22, 2007 – March 21, 2008 there were zero full time job vacancies. WLJC routinely advertises full-time job vacancies on its website <u>www.wljc.com</u> and in the Three Forks Tradition Newspaper, a popular local newspaper. Furthermore, the Station will expand its recruitment efforts by routinely posting job vacancies on various web sites that should reach a broader base of applicants, for example the Kentucky Broadcaster's Association's web site, www.kba.org.

The station engaged in supplemental outreach activities that help provide information about opportunities in broadcasting in general. For example, during the fall of 2007, the station's internship program provided two high school students the opportunity to learn about, and gain experience with television production and operations. The internship is for high school students, and draws from the local high school. In addition, the station in conjunction with the Kentucky Higher Education assistance Authority (KHEAA) participated in a \$1000.00 scholarship program that was designed to supplement one student's higher education opportunity in the broadcast industry.

The station also provides training to its managers and supervisors on preventing discrimination and harassment in the work place and in interviewing techniques designed to build a more diverse work force. On June 20-21, 2007, management personnel participated in a seminar on equal employment opportunities and preventing discrimination in the workplace sponsored by the Kentucky Chamber of Commerce. Participants learned how to choose the right candidate to build a diverse team. This station is an equal opportunity employer. It is the policy of this
