FOLLOWING IS A LIST OF PROGRAMS DESIGNED FOR CHILDREN SIXTEEN YEARS OLD AND YOUNGER THAT WERE SCHEDULED TO AIR FOR BROADCAST DURING THE **FIRST QUARTER, DECEMBER 28, 2015 THROUGH MARCH 27, 2016.** ALTHOUGH SOME OF THESE PROGRAMS ARE NOT SUBJECT TO THE COMMERCIAL LIMITS NOR THE WEBSITE RULE (SEE 47 C.F.R. & 73.670 Note 2) BECAUSE SOME OF THESE PROGRAMS ARE PRODUCED AND DIRECTED AT CHILDREN THIRTEEN TO SIXTEEN YEARS OLD, **KRCR** HAS ENDEAVORED TO COMPLY WITH FCC RESTRICTIONS FOR ALL CHILDRENS PROGRAMMING REGARDLESS OF AGE LIMITS. THIS CERTIFIES THAT ALL OF THESE PROGRAMS WERE FORMATTED TO ALLOW FOR NO MORE THAN 10.5 MINUTES OF TOTAL COMMERCIAL TIME PER CLOCK HOUR ON WEEKENDS AND NO MORE THAN 12 MINUTES OF TOTAL COMMERCIAL TIME PER CLOCK HOUR ON WEEKDAYS, OR HALF THAT ALLOTTED TIME FOR AN ISOLATED HALF HOUR OF CHILDREN'S PROGRAMMING.
