## **Statement Correcting "Second Home" Information in Children's Reports**

In its quarterly children's programming reports for the periods from the fourth quarter of 2014 through the third quarter of 2019, station KNXV-TV mistakenly indicated that many rescheduled episodes of preempted children's educational/informational programming did not air in the "second homes" for those programs. KNXV-TV has reviewed its records and determined that in the great majority of cases, those episodes did in fact air in the programs' second home windows, and that the notation in the children's programming report was inadvertently answered incorrectly. In a relatively small number of cases, certain rescheduled episodes did in fact air outside of their second homes for various reasons. In all but a handful of cases noted below, the rescheduled episodes aired within one week of the originally scheduled air time, and in all cases promotional efforts were made to notify the public of the rescheduled date and time for the preempted episode.

Over the period covered by this statement, KNXV-TV aired a total of more than 1500 episodes of children's E/I programming on its primary channel; of these episodes, less than three percent were preempted and made good outside of their second home. Based on a thorough review of station records, KNXV-TV has determined that the following programs were preempted and made good outside of their second home:

Episodes of *Sea Rescue* originally scheduled to air on the following dates were preempted and aired outside of their second homes: November 29 and December6, 2014; December 19, 2015; November 20, 2016; and April 28, 2018.<sup>1</sup> An episode of *Sea Rescue* preempted on July 23, 2016 was made good in its second home time slot, but during the weekend following the preemption rather than the following day.

Episodes of *Wildlife Docs* originally scheduled to air on the following dates were preempted and made good outside of their second homes: November 29 and December 6, 2014; December 19, 2015; November 20, 2016; April 15, 2017<sup>2</sup>. Episodes of *Wildlife Docs* preempted on July 23, 2016 and on April 28, 2018 were made good in their second home time slot, but during the weekend following the preemption rather than the following day.

Episodes of *Born to Explore* originally scheduled to air on the following dates were preempted and made good outside of their second homes: January 31, February 21, May 9,

August 22 and 29, and December 26, 2016. An episode of *Born to Explore* preempted on June 4, 2016 was made good in its second home time slot, but during the second weekend following the preemption rather than the following day.

Episodes of *Outback Adventures* originally scheduled to air on the following dates were preempted and made good outside of their second homes: January 31, 2014, December 25, 2016; and August 20, 2017.

Episodes of *Rock the Park* originally scheduled to air on the following dates were preempted and made good outside of their second homes: December 25, 2016; April 28 and December 16, 2018; and March 2 and 16 and August 3, 2019. Episodes of *Rock the Park* preempted on June 4 and July 23, 2016 were made good in their second home time slots, but during the first and second weekends following the preemption, respectively, rather than the following day.

Episodes of *Vacation Creation* originally scheduled to air on the following dates were preempted and made good outside of their second homes: March 24, April 28, July 21, and December 16, 2018; and January 26 and March 16, 2019. Episodes of *Vacation Creation* preempted on August 25, 2018 and April 27, 2019 were made good in their second home time slots, but during the weekend following the preemption rather than the following day.

Episodes of *Jack Hanna* originally scheduled to air on the following dates were preempted and aired outside of their second homes: May 5, 2018 and April 28, 2019. An episode of *Jack Hanna* preempted on April 28, 2018 was made good in its second home time slot, but during the weekend following the preemption rather than the following day.

Episodes of *Ocean Treks* originally scheduled to air on the following dates were preempted and aired outside of their second homes: April 28, May 5, and November 18, 2018; and April 28,2019.

An episode of *The Great Dr. Scott* preempted on April 27, 2019 was made good in its second home time slot, but during the second weekend following the preemption rather than the following day.

KNXV-TV also aired extensive children's E/I programming on its multicast channels during the time covered by these reports (averaging at least 3 hours per quarter of E/I programming for every 168 hours of multicast programming broadcast on the station). During the period covered by this statement, these programs were not preempted, and as such the "second home" question was not applicable to them.

By this statement, Licensee also clarifies whether certain programs listed in its children's programming reports aired on the Station's primary channel or multicast channel(s). Throughout the period of time starting with the fourth quarter of 2014, KNXV generally identified all children's E/I programming airing on other than its primary channel as such in its children's programming reports, although in a few instances this designation was inadvertently omitted from the reports. For clarity, KNXV supplements its reports to reflect that the following programs aired on one of the station's multicast channel. Except where listed below or identified

in the children's programming reports as airing on a multicast channel, all programs listed in the children's programming reports aired on the Station's primary channel:

- Fourth Quarter of 2014 Digital Core Program #10, Family Style with Chef Jeff, aired on multicast channel 15.2.
- First Quarter of 2015 Digital Core Programs #10 and #11, Family Style with Chef Jeff and Safari Tracks, aired on multicast channel 15.2.
- Fourth Quarter of 2018 Digital Core Program # 14, *Henry Ford's Innovation Nation* aired on multicast channel 15.3.
- Second Quarter of 2019 Digital Core Program #18, *Animal Rescue Amazing Stories*, aired on multicast channel 15.4.
