Todd,

I left a long voicemail; let me give you that info again. First, with political advertising it must be prepaid and I have some paperwork you will need to fill out.

We have four stations:

News / Talk 1310 Am / 97.3 Fm is \$5.00 per :30 commercial. I'd advise looking at one commercial in each hour of MetroNews Talkline w/ Hoppy Kerchavel. That would be \$10 per weekday. The other most listened to shows are Rush and Morning Metro News.

On the music Fms, 103.1 The Bear WRON has the most listeners. All the music FMs are \$8 per :30 commercial. Oldies 93 has the same reach. Rock 95 WRLB is a strong signal except in on the east side of WSS and up Rt. 92. I'd recommend first using the Bear, then looking at Oldies 93 based on your budget. You would probably want to run at least four commercials or five commercials on each station.

My best advise would be to come in and talk to me. We can create a schedule, get the forms taken care of, and record a commercial then. I'm available weekdays after I get off the air from 10 a.m.-4:30 p.m.
