Attached please find the UNIMAS Network's Closed Captioning Certification for the Fourth Quarter of 2016

In 1998, the FCC adopted rules requiring all broadcasters, cable operators and satellite distributors to begin providing programming in a closed captioned format to make programming accessible to those with hearing disabilities. The FCC established a phase-in schedule requiring these program distributors to provide an increasing amount of their programming in a closed captioned format over time.

As of January 1, 2010, all "new" non-exempt Spanish-language programming must be captioned, with certain limited exceptions. In addition, FCC regulations currently require that at least 30 percent of "pre-rule" Spanish-language programming be captioned per quarter. (Commencing January 1, 2012, the quarterly captioning requirement for "pre-rule" Spanish-language programming will increase to 75 percent.)

Whether programming counts as "new" or "pre-rule" depends on its format and when it was first exhibited.

- Digital programming is "new" if it was first published or exhibited on or after July 1, 2002. It is "pre-rule" if it was first published or exhibited before that date.
- Analog programming is "new" if it was first published or exhibited on or after January 1, 1998. It is "pre-rule" if it was first published or exhibited before that date.

The UNIMAS Network is providing you with this Closed Captioning Certification to assist you in keeping records demonstrating your station's compliance with this phase-in schedule. Since your station may not have aired all of the programming listed on the Closed Captioning Certification, or may have added additional closed captioned programming, you cannot rely solely on this Certification. You should review your station's logs to determine whether all of the closed captioned programming on the attached Certification was aired.

We have provided you with a form of Certification that can be completed locally and attached to the Network Closed Captioning Certification attesting to the amount of closed captioned programming aired on your station. You should check with your legal counsel in preparing this documentation.
