Information regarding economic growth and its community impact is reported. This issue includes employment, business development, local business highlights, and other expansions of capacity and advancement.

7. Community Events

Civic, political, public, or educational activities or functions to which the public is invited to participate, or attend are communicated to viewers.

8. Civic Affairs

Community issues regarding elections, voting, political administration, and governmental topics are addressed to enable more informed decisions and increased engagement by station viewers.

9. Civil Rights History

Our viewing area includes a rich local history that provides a front row seat and unique opportunity to share the story of people, places, and events significant in the struggle for equality and justice and the resulting local, national, and international impact.

10. Resources

Resources available to address physical, mental, and social needs are communicated.

WCOV Programs and Issues Summary 1st Quarter 2023 Program Overview

JUSTICE WITH JUDGE MABLEAN MONDAY – FRIDAY 7:00AM to 8:00AM; 10:00AM to 11:00AM

Mablean Ephriam, the ninth of ten children born to Robert T. and Mable Ephriam, in Hazlehurst, Mississippi, is now known throughout the world as Judge Mablean, since her seven-year run as the judge on the FOX television show, Divorce Court. She returned to television on September 15, 2014, as the judge in Justice with Judge Mablean.

The family migrated to Los Angeles in 1955, allowing Judge Mablean to begin school in Los Angeles. She graduated from Thomas Jefferson High School in 1967 with honors. She was awarded a four-year academic scholarship to Pitzer College in Claremont, California.

After her undergraduate studies, she married and became a mother, delaying her childhood dream, from age thirteen (13) years old, to become a lawyer. During these times, she worked in investment banking at First Western Bank, as a correctional officer at the Federal Women's Prison in Terminal Island, California, and a legal secretary. She never gave up on her dream.

In 1974, she decided it was time to fulfill her dream. She began law school in the Fall of 1974 at Beverly Rubens College of Law (later changed to Whittier College School of Law). Judge Mablean attended law school at night. She continued to work during the day as a legal secretary. In her third year of law school, she was employed as a Certified Law Clerk in the Criminal Division of the Office of the City Attorney of Los Angeles. There, she researched, wrote, and argued criminal misdemeanor appeals before the Appellate Division of the Los Angeles Superior Court.

She graduated from Whittier College School of Law in 1978, earning her Juris Doctor degree. During her law school years, she participated in the Moot Court. Her team won second place in the statewide Moot Court Honors Program. This was accomplished without neglecting her husband and children. She was admitted to the practice of law by the State Bar of California in November 1978, having passed the bar the first time.

Judge Mablean began her law career as a Prosecutor in the Criminal Division of the Office of the City Attorney, Los Angeles in November 1978. During her years as a criminal prosecutor, Judge Mablean was assigned as a filing attorney at the Bauchet Street Division, handling crimes against persons (CAP) filings. Her review of and filing of case involving domestic violence against women caused her much concern when the victims would call to ask for dismissal of the cases after filing and were reluctant witnesses. She met with and discussed remedies with the then presiding Judge of the Bauchet Street Criminal Court, Judge Madge Watai. Together, they devised a plan known as a diversion plan Judge Watai agreed when a victim was reluctant to testify and was asking for dismissal of the case, if the defendant were to agree to counseling program and no further criminal behavior for six months, she would dismiss the case. It was Judge Mablean's work in CAP that gave birth to the opening of The Family Law Center on 76th Street and Central Avenue. She sought the support of WLALA President, Patsy Ostroy, along with BWL members (who provided the legal representation, Assemblywoman Maxine Waters (who provided the supplies) and the Brotherhood Crusade (who provided the building) and opened a clinic to assist women in obtaining domestic violence restraining orders. This unorthodox, informal sentencing procedure by Judge Watai later became codified by the legislature as the Domestic Violence Diversion and Prevention Act.

Judge Mablean entered the Office of the City Attorney with a plan; gain trial experience, earn a good name and reputation as a trial lawyer, network and become well acquainted with others in the legal community, then open her own office. Her plan came to fruition in July 1982. She opened her own law practice, initially sharing office space with a law school classmate, Joan Whiteside Green. Her early practice emphasized criminal defense, personal injury, and family law. In 1984, she moved her offices and shared office space with Katie Murff Trotter, later joined by Shirley A. Henderson. She found her niche in family law. Her experience and skills gained as a trial attorney while a prosecutor quickly earned her respect as a trial lawyer in family law court. She earned a reputation in family law as the divorce attorney for police officers, judicial officers, doctors, lawyers, and men. Judge Mablean, along with her colleagues, Shirley Henderson, and Adrienne Konigar, formed a legal entity known as S.E.D.A. (Support Enforcement Division Attorneys) representing men in child support enforcement cases brought by the District Attorney Child Support Enforcement Division. After her employment in the entertainment industry in 1998, she formed a partnership with Carolyn Makupson, Law Offices of Ephriam and Makupson. She gradually decreased her practice as a lawyer. In 2004, the partnership was dissolved, and Judge Mablean shifted from the practice of law to entertainment and public speaking.

Judge Mablean has volunteered in numerous legal and community organizations, such as Member and Past President of the Black Women Lawyers Association of Los Angeles (1982-83). During her tenure, she co-founded and opened the Harriet Buhai Center for Family Law (1982), a pro-bono legal services organization, that initially provided legal services and

representation to women who were victims of domestic violence, and later expanded to provide services to low-income persons throughout Los Angeles County, in all areas of family law); Member of the American Bar Association, (serving on the Diversity Committee and in the Young Lawyers Division); State Bar of California- Family Law Section, Executive Committee; Los Angeles County Bar Assn. – Executive Committee; Langston Bar Assn. ,Calif. Assn. of Black Lawyers (CABL) and Women Lawyers Association, National Bar Assn.; (served a term on the Board of Governors as Representative of Local Bar Associations), Women Lawyers Association of Los Angeles (WLALA) and California Women Lawyers (CWL); Board of Directors,- Union Rescue Mission, (first black woman). Her religious affiliation and services include member of the West Angeles Church of God in Christ, serving in the Youth Ministry; member, Board of Directors-Southern California Economic Development Corp., and member of the Executive Board of the Women's Department – Church of God in Christ.

In October of 1998, FOX (Twentieth Television) selected Judge Mablean to preside as Judge on the newly revised half hour syndicated, television show, DIVORCE COURT. Judge Mablean did not seek the position. Through word-of-mouth regarding her legal talents (from her colleagues and friends, especially, Shirley Henderson), and an unknown entertainment attorney, FOX interviewed her and offered the job within seven (7) days. Judge Mablean attributes this to divine intervention.

Judge Mablean is involved in the day-to-day operation of her 501 © (3) non-profit, the Mablean Ephriam Foundation (www.mableanephriamfoundation.com), whose mission is to strengthen families, educate minds, financially empower the residents of the impoverished communities of Los Angeles County. The foundation has adopted two schools, Peary Middle School (Gardena) and her alma mater, Jefferson High School (South Los Angeles), providing both academic and cultural enrichment programs and scholarships for graduating seniors. She is the founder of an annual event, Honoring Unsung Fathers (H.U.F.) Awards and Scholarship Brunch. It has been held on Father's Day each year since 2004. The Foundation also awards scholarships to graduating high school seniors (throughout Los Angeles County). Judge Mablean also travels extensively as a much sought-after public speaker. She is the owner of Mablean Ephriam Mediation Offices.

Judge Mablean attributes her success to God, her parents, her family and close friends. Her faith, religion, and trust in God, keeps this mother of four and grandmother of ten, meek and humble.

ALL OF IT! The show launched during the Covid pandemic and was a challenge no daytime show has had to face. Drew and the team turned this into an opportunity and delivered an hour of needed optimism to viewers every day.

For her contributions to the film industry, Barrymore received a motion picture star on the Hollywood Walk of Fame in 2004. The Drew Barrymore Show was nominated for three Daytime Emmy Awards in 2021.

HOT BENCH MONDAY – FRIDAY 11:00AM-12:00 NOON

From the producers of Judge Judy, HOT BENCH adds a new dimension to the court genre, with a panel of three judges hearing court cases, arguing the merits of the case amongst themselves and rendering a verdict. 'Hot Bench' is a term used to describe a court where the judge or judges frequently interrupt lawyers' presentations with questions, often leading to lively exchanges. A variety of topics related to law, crime, public safety, and education are regularly addressed.

"When my husband Jerry and I were in Ireland recently, we visited the courts and watched a three-judge bench, which I found both fascinating and compelling," Judge Judy Sheindlin said. "I immediately thought what a terrific and unique idea for a television program that brings the court genre to the next level. We have assembled three individuals with extremely varied backgrounds to serve as the judges. They are smart and talented, with terrific instincts and great chemistry, and are sure to create a "hot bench."

HOT BENCH's trios of judges are Judge Patricia DiMango, Judge Michael Corriero, and Judge Tanya Acker.

Tanya Acker is an experienced litigator who has represented a wide variety of clients. She is a Yale Law School graduate and served as a judicial law clerk to the Honorable Dorothy Wright Nelson on the Ninth US Circuit Court of Appeals. After her clerkship, the Office of the Solicitor General in the US Department of Justice awarded her a Bristow Fellowship. In private practice, Acker's legal work spanned a variety of matters from civil litigation involving public and private entities, to various constitutional cases, to the provision of business counseling and advice. She also maintained a commitment to pro bono work, receiving the ACLU's First Amendment Award for her successful representation of a group of homeless individuals against the City of Santa Barbara. She maintains an active involvement in various philanthropic, civic, and business organizations.

Patricia DiMango was first appointed to serve as a judge in the criminal courts for the city of New York by Mayor Rudolph Guiliani. Thereafter she was elected to the New York State Supreme Court bench in the 2nd and 11th Judicial Districts. She became the Italian American woman ever appointed to these positions. Soon after, she was elevated to the position of First Deputy Administrative Judge for criminal matters, 2nd Judicial District. Her reputation as stern

and fair assisted her in handling a large volume of serious felony cases from their arraignment through trial including a number of high-profile trials. Awards include Alumna of the Year from Brooklyn College, the Rapallo Award, the Distinguished Judiciary Award from the Catholic Lawyers Guild, and Woman of the Year by the New York State Supreme Court Officers Association. She received her law degree from St. John's University where she graduated in the top 10 percent of her class. She also holds a Master's Degree from Columbia University in Developmental Psychology. While pursuing her master's degree, Justice DiMango was a schoolteacher for the New York City Public Schools, focusing on special education of children with emotional and intellectual deficiencies.

JUDGE MATHIS MONDAY – FRIDAY 12:00NOON TO 1:00PM & 11:00PM TO 12AM

Judge Mathis is currently in its 21st season and has a full docket that engages and excites viewers from coast to coast. Judge Mathis is a national figure known for his advocacy campaigns for equal justice. His inspirational life story of a street youth who rose from jail to Judge has provided hope to millions who watch him on the award-winning television court show, Judge Mathis, each day. In addition, his weekly newspaper column brings social and political insight to readers throughout the country.

Judge Mathis's public service career began in college where he led 'Free South Africa' and voter registration campaigns on campus. After graduating from college in 1983, he joined the staff of Detroit City councilman, Clyde Cleveland. He was the youngest judge in Michigan's history and served as a Superior Court Judge for Michigan's 36th district. In his efforts to reach out to youth and ex-offenders both in and outside of the courtroom, Judge Mathis opened a community center in his hometown of Detroit and has assisted thousands of youth with his non-profit agency Young Adults Asserting Themselves (Y.A.A.T.), an agency that provides career, business start-up and job opportunities, as well as job training and college enrollment assistance.

In honor of his years of work and commitment to his hometown of Detroit, the city honored Mathis by naming one of the streets, Mathis Avenue, after him. The street is part of a new housing development, which replaced the housing projects he grew up in. Judge Mathis has received numerous awards and keys to the city from government officials and is the recipient of Honorary Doctorates from both Florida A&M University and Eastern Michigan University.

Judge Mathis presides over real, hard-hitting cases and his decisions are legal and binding. His use of the bench to provide resolution and counseling to litigants before him has catapulted Judge Mathis to the forefront of a national dialogue about real issues facing contemporary society. His trademark sense of humor, personal commitment to social and equal justice, and degree of humanity and forthrightness distinguish him from the rest of the genre. His program provides information on issues including law, crime, education, social and family matters, and resources

THE PEOPLE'S COURT MONDAY – FRIDAY 1:00PM TO 2:00PM & 12:00AM TO 1:00AM

The honorable Judge Marilyn Milian returns to celebrate a decade of dockets on the courtroom series that launched the entire court show genre. Milian continues to render verdicts and dispense legal insight in the courtroom where justice and reality collide.

"The People's Court," Draws on ordinary people who have filed grievances in civil court and have opted to have their cases heard and mediated by Judge Milian. An experienced team of researchers continually canvas courts across the country in search of the most compelling, unique, and thought-provoking cases. Running the gamut from disputes between neighbors and family members, to dissatisfied customers suing businesses, Milian's decisions, based on current law are final and binding. "These cases are never about the money, they're about principle," Milian proclaims. "The People's Court" has been delivering reality television to viewers for over two decades.

Judge Marilyn Milian brings over 19 years of legal experience to the bench. Milian was appointed to the Miami Circuit Court in 1999 by Governor Jeb Bush, where she served in the Criminal Division. Prior to that, she spent five years in the Miami County Court in the Domestic Violence, Criminal and Civil divisions. She was appointed to the County Court by thengovernor, Lawton Chiles. Before serving in the County Court, Milian worked for 10 years as an Assistant State Attorney for the Dade County State Attorney's Office, personally hired by Janet Reno

Judge Milan is honored to be the first Latina Judge to host a nationally syndicated television court show. She often uses pearls of wisdom recalled from her Cuban mother and grandmother when addressing litigants. She is well known for her dedication to the Hispanic community and as strong voice against domestic violence.

Harvey Levin serves as the series' host and legal reporter. In addition to introducing the cases to viewers, Levin literally takes "The People's Court" to the people by polling viewers who watch the cases via monitor. These viewers' spirited comments and debates regarding the cases and Milian's decisions are then incorporated into the show. An attorney and law professor, Levin also examines and explains the legal issues and precedents introduced in the cases.

In-court reporter Doug Llewelyn and court officer Douglas McIntosh, assist Judge Milian in the courtroom. Llewelyn interviews litigants after a decision has been rendered in their cases. As court officer, McIntosh helps Milian in maintaining courtroom order, as well as acting as an intermediary between the Judge and the litigants.

Back in March of 2022 Alabama passed a law that would allow people to carry concealed handguns without first undergoing a background check and getting a state permit. The law was highly opposed by law enforcement due to it being deemed dangerous but the proposal was championed by gun rights advocates who argue people should not have to get a permit to carry a concealed handgun. The new constitutional carry law allows anyone who is 21 -- and legally entitled to possess a firearm -- to conceal carry a firearm without a permit

NFL football player Damar Hamlin's life was saved from CPR and now more people are eager to learn the technique. Reporter Carrington Cole spoke with the Prattville fire department to find out more. Cardiopulmonary resuscitation, commonly known as CPR, is the manual act of distributing oxygen rich blood throughout the body. This skill is used when someone's heart has stopped beating. "It really is important and you hope that it's a skill you never have to use but it's definitely one that you want to have when the time comes." CPR requires a person to give 30 chest compressions to an unresponsive individual to help them restart their heart. "There's basically 3 boxes to check in order to start CPR that would be unresponsive, not breathing or agonal respirations as we call them which is obviously a not normal breath, and no pulse. Once all 3 of those boxes are checked, then CPR does need to be initiated." This is a vital skill to know so you can jump into action during a medical emergency while you wait for first responders. "If a CPR is administered within the first few minutes of someone having a cardiac arrest, it doubles and sometimes triples their chance of survival receiving that care immediately is extremely important." "the more people that we have that learn CPR, the more people we have in situations that can save someone's life early CPR and having an AED on hand, which is an automatic external defibrillator, are the two key things to saving someone's life in the event of a cardiac arrest." some local residents are starting to host CPR parties to make learning fun. "regular old get together with my family and friends but I would invite a CPR instructor to come in and teach them CPR and first aid" learning CPR isn't just for adults, anybody at any age can learn "I've been CPR certified since I was 13 years old" "everyone needs to know how to do it and everyone can do it. It's a simple task that can save someone's life in the event of emergency.

January 8, 2023 – Community Events, Resources

• Turning to political news, Ja'Mel Brown has announced his candidacy for Montgomery City Council District 7 Brown says he wants to represent district seven, to give the people

He feels this moment is the right time to announce his candidacy. I'm running because I believe now is the time to give the people a voice down at City Hall for so many years people not distant district 7 but across the whole city of Montgomery I feel like many others has been neglected they haven't had a voice when it comes to many major and minor issues down at City Hall. Clay McInnis, who presently serves Montgomery City Council district 7 confirmed to us Thursday that he will not seek re-election. Qualifications start in March.

• Changes are coming to Alabama prisons. State and local officials discussed state changes to inmate incentive time and in prison law enforcement regulations. Reporter Teresa Lawson has more. Today Governor Ivey's signed Executive Order 725. It's a clear plan of action to better help the wellbeing and rehabilitation of inmates within state facilities. It also ensures that law enforcement has the ability to uphold the law within prison confines. "Our action today, very simply put, keeps violent offenders off the streets, incentivizes inmates who truly want to rehabilitate and better themselves, reinforces the concept that bad choices have consequences and keeps our public safe." Alabama reported just over 200 inmate deaths at state prison facilities in 2022.

• Volunteer fire departments are often the first line of defense for many rural areas. Reporter Teresa Lawson has more. Emergencies happen every day. And if you live outside of the city limits having emergency personnel close by could make the difference between life and death. Much like the rest of the fire service in Alabama, especially the volunteer service, we're just we're in need of volunteers. Volunteers carry the lion share of our load especially on nights and weekends when we don't have paid staff on, so we depend on volunteers to carry on our mission Many areas in the river region are in need of volunteer firefighters, a common misconception is that you have to devote a lot of your time to fighting fires in your area and going through a lot of training, but it's important to

have volunteer firefighters in your community in case of an emergency. Anybody who is able bodied and fit and would like to take just a couple of hours of courses can put on the uniform and help out whether you can offer one day a week or just a few hours a day. As far as the time, that's something you're able to manage. We find that it generally doesn't take as much time as what people think it does but that's something that is manageable and can be controlled. If you're able to do a few hours a week. Your help is appreciated. It can be done in as little as a couple of months on a volunteer schedule as far as classes at night or on the weekend or there's an online component now where they are able to do their coursework online and then come do skills all along. And that has become our preferred method of doing it. Training takes about six months and all who complete training receive a state certification.

This is my office and we're closed temporarily until we can get our repairs done. Money raised will go into the special disaster fund which allows the organization to give financial support to affected families. After the storm people have gotten their insurance filed and FEMA has done their low interest loans, we're going to have a lot of people who need help. And the money donated is going to be used to take care of these people. The cleanup effort has just begun and financial assistance is needed. A lot of unmet needs after this storm and the generosity of folks from around the state and your viewership that have been giving money we're setting it aside to take care of these people. These disasters come out of nowhere and sometimes we're not prepared for it, they're not prepared so having these funds can really support these victims we can really help them fill in these gaps get them back into a place or put them back to where they used to be. Money received from The United Way can be used in conjunction with money from FEMA and other government agencies.

January 19 2023 – Civil Rights History, Civic Affairs, Community Events

• It's been one week since the tornadoes hit our area. Despite that, officials with the Bridge Crossing Jubilee in Selma say this year's event will go on as scheduled. Jubilee organizers say in light of the devastation left behind in the city from a recent EF-2 tornado -- the annual Voting Rights event -- is needed now -- more than ever. The Bridge Crossing Jubilee commemorates Bloody Sunday -- the Selma to Montgomery March -- and the signing of the Voting Rights Act of 1965. It draws thousands of people to Selma each year. And organizers are focused on using this year's event -- to help secure resources -- for local recovery efforts. "And we everybody to come to Jubilee with their funds -- with their energy -- with their ideas to help rebuild Selma. And to be all that we can be together." "We don't need people just to come here and walk. We don't need people to come here and talk. But we need for you to leave some financial dollars here in Selma, Dallas County." The goal of the Jubilee -- is to inspire people to respect and appreciate the power of the vote.

January 20, 2023 – Community Events, Resources

• A food giveaway was held at the Newtown Community Center. This Giveaway was open to anyone in the Montgomery community. This past November, more than 300 families were fed totaling now a little over 800 people. Zizi's Bee Company works in partnership with help a brother out foundation and is a nonprofit organization who strives to give back to the community by hosting these food drives. They aim to help the elderly, veterans, and the youth who are in need. We grew up in this community and this community is where we see the most help is needed with inflation on the prices of

groceries. This is our way to help our community any little bit can help our people in Montgomery Alabama. we want to make sure that the needs of the elderly are met the biggest thing about this is we have a philosophy and we understand the golden rules better to give than receive do unto other done to you and love thy neighbor These food drives are held on the 3rd Friday of each month.

January 21 2023 - Crime Prevention and Law Enforcement, Public Safety

MPD is also investigating two separate cases involving gunshot victims that both happened this morning. • Troy police are investigating a shooting that left one person dead and another injured. Officers were called to the 700 block of South Brundidge Street around 10:15 Saturday night after receiving a call related to a shooting. Once they arrived, they found two victims with gunshot wounds. One was pronounced dead on the scene. The other was taken to a hospital in Dothan for non-life threatening injuries. The suspect was AT the scene and taken into custody where charges are expected to be filed. The Troy University Police Department and the Pike County Sheriff's Office assisted in securing the scene.

As city streets reopen to traffic -- the full extent of the devastation caused by the tornado -- is becoming clearer. We can go through the city. You can maneuver around through the city. Selma took a direct hit from an EF-2 tornado just over a week ago. The twister cut a 23 mile -- path of destruction through the city. It begins on the western corner of our city and runs all the way through the city to the eastern corner. It's about; roughly about a third of the city really was truly directly affected. And we're estimating about 3300 homes were lost. One of them belonged to Lashawdo Cutler of Selma. The single mother of three -- says a tree fell on her house during the storm. So now she's staying with her mother -- until she gets another place of her own. You could just hear the wind. Like you could just hear all the stuff on the outside just blowing. And it was just roaring. All I remember is just getting low, ducking my head down, I put my hand on my head and praying. Just praying. Praying to God. It's completely destroyed. I mean they don't have a home. Their items were gone. They have nothing. Nothing. The city has set up a Distribution Center at the George Evans Building -- to provide tornado victims -- with much-needed supplies. And churches all over the city -- have joined in the effort to help. This city is going to need help months, years from now. An unexpected by-product of the tornado -- seems to be a new spirit of cooperation in the city -- and a stronger sense of togetherness. The murder of a midtown woman has left the community reeling. We spoke with those who knew and remember her for her kindness. Reporter Teresa Lawson has the story. Stephanie was such a good person 64-year-old Stephanie Stone lost her life to a senseless act of violence in what seems to be a robbery gone awry. What's the purpose? I don't know if God was ready for her then, you know I don't know what happened and neither does anybody else know why he did that but it's so sad. And as details become clear, clarity brings more questions than answers. When it first happened you know we thought it was just an accident so to see the employees go from grief to hate in finding out how Ms. Stephanie was taken from us and seeing everyone dealing with those emotions has just been something I've never experienced before and something I hope to never have to experience again. As the receptionist of Alabama Cancer Care Stephanie spent her days welcoming and encouraging those who fight for their own lives daily. She was always so friendly with me, all the other patients the workers and it's hard as a friend. I've never known a friend like her to die like that and never known anybody to die like that. Stephanie greeted those entering the office with love and kindness, going above and beyond for the patient's friends and coworkers -- her murder creating a space in their hearts that can never be filled. Whether it is from driving patients to and from appointments that couldn't make it themselves, patients that needed gas money to get to our clinic for their treatment, Stephanie was just exactly what you wanted in an employee and unfortunately we'll never be able to fill that place again and leaving those who knew and love her to mourn her death until they meet again. Stephanie, I'll see you again someday because I'm coming and I will see you, so just look for me. Bell is in the Montgomery County Jail with no bond.

January 25 2023 - Crime Prevention and Law Enforcement, Public Safety

The Dallas County Jail is unusable after it was severely damaged by the January 12th tornado. So now what happens to someone arrested for a crime? Reporter George McDonald has some answers. Dallas County Sheriff Mike Granthum -- says his department continues to protect and serve the community. He says help from his brothers in blue -- and the state of Alabama -- has been invaluable. About 130 inmates at the Dallas County Jail -- had to be moved -- after the jail was severely damaged by the tornado -- that ripped through the Selma area January 12th. The main thing when it first hit was the safety and security of those inmates. But now you got to have, we're still making arrests. So, where do those inmates go? Sheriff Granthum says sheriff's offices near and far have stepped up -- to help his department -- house inmates. And we have inmates all the way from Cullman to Geneva County. We have local jails, your Lowndes County, your Perry County, your Wilcox, they have stepped up. And if we make an arrest now, we can actually use their jail, their facility as a booking procedure. Granthum says an agreement signed with the state -- will bring about 50 inmates a little closer to home -to be housed at the Perry County PREP Center. You know there's no manual to do this. So, we were flying by the seat of our pants. I mean, what do we do? But I mean, I called other sheriffs. Got some input like from Tuscaloosa. You know when they had the storms

from up there. We've been getting input from them. How do we do this? What's the best way to do that? And everybody's just been so helpful. Granthum says several sheriffs' departments have also donated cars to his department -- to replace the ones destroyed in the tornado. From the WAL Newsroom, GM, Alabama News Network

Selma police Chief Kenta Fulford has been placed on an indefinite administrative leave -with pay. Mayor James Perkins, Jr., made the announcement Wednesday. Perkins said the action was a personnel matter that will only be discussed in an executive session of the Selma City Council. He said Fulford will be afforded a pre-disciplinary hearing -- in accordance to state law. Meanwhile -- residents are feeling left in the dark -- and asking why something like this is happening in the midst of a city-wide tornado crisis. "I think it's somewhat troubling that no explanation has been given so far as I know. And I think the mayor should be more forthcoming, should be forthcoming and give us an explanation as to the reason for this. I have no opinion on the matter until I know the facts. And so far there are no facts to base an opinion on." "We don't know all the information that surrounds it. We're in a horrific time here in Selma. And of course most people are trying to get there home back together. And so, people are talking about it. And I just pray that it can work out and things can be well, especially in this season and time we're in now. We got to come together and, make this thing work, and help people to heal and get their lives back together." Perkins appointed former Demopolis Police Chief Tommie Reese -- to serve as the interim chief -- until a final determination is made.

January 27, 2023 – Economic Development

• A Signing ceremony for funding for the sewer improvement project in Hayneville took place today. Federal, state and local officials held the signing ceremony Friday to kick off a \$10 million project to repair and upgrade the town's sewer system. Leaders will discuss the Hayneville project and funding for other sewer and water projects in the Black Belt and throughout the state. to see this come to pass through the hard work by the mayor by the elective officials in Hayneville and throughout the state we've had just tremendous corporation working with them and I think the results will speak for themselves we are ahead of the curve on getting these funds put to use. the engineers there have their surveyors to come out as soon as we sign this paperwork and so sometime next week they going to be outside surveying going to house to house seeing what need to be done and as soon as they do the surveying the construction should start The funding is part of nearly \$500 million in grants and loans awarded by ADEM in 2022 to address the critical infrastructure needs of water and sewer systems in Alabama.

• There's a new sheriff in town -- in Marengo County. Robert Alston Junior is now the county's top law man after serving six years as the Chief of Police in Linden. Reporter George McDonald has more from the west Alabama newsroom. Sheriff Robert Alston Junior -- says he's going to build on the work of former Sheriff Ben Bates -- and make the Marengo County Sheriff's Office a top-notch law enforcement agency. It's not about

reinventing the wheel -- it's about taking what you have and building off of it. And building it to make it even better. Alston says his administration won't be all about locking people up -- but it will enforce the law without fail. The people who need to be address crime. Alston says his top priority and his biggest challenge are one and the same. It's gaining the trust, help us help them. Alston says putting more deputies on the street is another top priority. That would help deter crime by increasing officer visibility around the county. Plus reduce officer response time. Alston has 18 years of law enforcement experience. His career began as a patrol officer -- includes stints as a deputy -- a drug task force agent -- an investigator -- plus six years as the Linden Police Chief. Residents are excited about what he brings to the office of sheriff. Alston says he has an open door policy at his office. And his administration will be proactive and transparent. • Students, faculty and staff welcomed Faulkner University's new president today. Mitch Henry was officially inaugurated today, but was introduced last year. Greetings and speeches were given by student president Jay Lay and the chancellor of Troy University Dr. Jack Hawkins - as well as the city of Montgomery's mayor's office and Governor Kay Ivey. Our president will be inaugurated officially even though he began last June 1 of 2022. Mitch Henry has been a long time born and raised here in Montgomery he's a hometown boy and we are tickled to death to have him. It's important for us to reach out and help this community in ways that are important and critical you know in Alabama and in other states that's surround us there are a lot of improvements that need to be made we need to improve education we need to improve our economy we need to improve criminal justice we need to improve healthcare and we need to grow spiritually and that's what Faulkner is doing. Henry is Faulkner's 9th president in its 80 year history.

January 31, 2023 – Civic Affairs

• Montgomery public schools and the probate court are providing voter registration to high school students. MPS Superintendent Dr. Melvin Brown and Probate Judge JC Love discussed how to ensure students are registered and knowledgeable about voting. Voter registration kiosk machines will be put in all high schools. And any student with a mobile

phone can register through their app. They know they can also engage their community their neighborhoods to make sure their parents their grandparents their aunts uncles' cousins whomever have access to getting registered and knowing where to go and vote. Once they hit submit the information is transmitted directly to the Secretary of State's office they will go ahead and verify the information that's on the application and once they check out and verify it then their name Will be submitted to the board of registrars and they will send them there voters cards they'll do in advance of all elections let them know what precinct they will go to for that election. I believe this opportunity is a great way for the students at school to be able to actually take part in the community and register and make sure like they want the best for their neighborhood the people around them and just the state in general it costs about \$70,000 to buy kiosks for all the schools.

February 1, 2023 – Civic Affairs, Economic Development

Mayor Reed spoke with community leaders and citizens sharing that Montgomery is currently in one of the best chapters of its 200-year history. He also shared his vision for a better Montgomery now. This is the moment that Montgomery has hit its stride. Montgomery is experiencing one of its most successful physical years. In 2022 alone we recorded the best economic development year on record with 1.7 million dollars invested and 2,000 jobs created In addition to the creation of small businesses across the city large corporations like Amazon, FedEx and Premier, just to name a few have set their sights on Montgomery, but Mayor Reed says this isn't the time for citizens and officials to rest on their morals We cannot be complacent. We have to build on this banner year of investment and growth by diversifying our economy. If we are truly to transform the trajectory of our city. We don't believe in over policing and we won't but we will protect the citizens of our community. Our officers are solving cases faster than the majority of the departments across the country. The MPD clearance rate or the percentage of cases solved by our police department hovers at 70% that 50% higher than the two largest cities in our state. Mayor Reed's focus is on the community I want what you want and we want Montgomery to be the kind of place where not only can we raise our children but those children will return as adults because Montgomery has opportunities and chances for fulfilling careers, excellent education and immersive cultural experiences. Anyone who would like to gain public input through meetings, community groups or their neighborhood associations can do so. through the Montgomery Thrive campaign

"I'm really excited, really excited about this honor, um humbled, but really excited. It's something new. I've been in law enforcement for a little over 29 years but it's so much to learn, you're constantly learning so it's something new, I'm eager, I'm excited for the task. I'm ready for it." Although the police department is short staffed. officials are confident in the men and women that work for the department.

• It is Mardi Gras season and a lot of nearby cities were celebrating. The city of Prattville held their Mardi Gras parade downtown. This year the city honored area meteorologists as grand marshals'. For the hard work they did for the January 12-th tornado coverage. "We were just honored to be a part of the parade and I know we've had such an active January with storms around the area and the folks here in Prattville allowing us to be the grand marshals'. It was kind of nice being able to throw out the beads and participate in such a fun event on such a beautiful day because it's been so active here lately with a lot of severe weather but with things like this it gets everybody together and you can just kind of relax and enjoy the day. What better day to do it on than a Mardi Gras celebration." Prattville wasn't the only city to have a huge Mardi Gras celebration. The city of Millbrook also had its own festivities. The city of Millbrook has one of the largest Mardi Gras celebrations north of mobile with over 15 thousand attendees each year. The festival was held in village Green Park with tons of vendors and rides. The Mardi Gras parade started at noon where we had our very own Alabama news network lace up vehicle in the parade, giving out candy and beads to everyone who attended

February 5, 2023 – Resources, Community Events

• Montgomery's Saint Jude was once a staple in west Montgomery now it has a renewed purpose for a new era reporter Ja Nai Wright has more in "a calling for west Montgomery" and so is this sort of the end of Saint Jude?" that very question loomed in the minds of parishioners at St Jude once the Covid 19 pandemic hit. The city of St. Jude was erected in 1937 but became known worldwide for its pivotal role in the Selma to Montgomery march. In 1965 the church was a safe haven for marchers as they headed to the capital. "I was in the 11th grade during the time of the march and my mother and I we marched in the march" "At the time when the march was going on, did you realize the significance of the roles you all were playing during that time? No, I did not, but we were very aware of the danger." "I got a chance to be a one on one with some of those people

that you used to see on TV, entertainers and all Bill Cosby, Harry Belafonte, and there were other white entertainers there Danny Thomas Parnell Roberts" "Just to see, it was an experience I housed some of the civil rights children, families at my home. All of the teachers did, and we were a part of the celebration. I met the stars because they were housed beneath the church, and it was just an experience to see and to be able to participate" St Jude played a huge role, not just for the march, but the land was a safe place for all African Americans at a time when they were not welcomed especially in many parts of the south. "It's the place with the freedom riders who were many of them would be beaten. They were only treated at Saint Jude. It's the place where Martin Luther King Jr., when he was living here in Montgomery for that decade, his children were born at our hospital." although there is so much history tied to St. Jude, it has recently been disconnected from the community in west Montgomery, a large part due to the Covid 19 pandemic which forced the church to close its doors and stop its services provided to people in need. "It's a sense of loss that you can't recapture because it's I lost something that I was so used to and I was you know hands-on and I could see them and touch them and that was not there " "It's easy to blame Covid, but it really did hit us hard in the sense in a very particular way and so um we are ready to come back to bring back a lot of those social services that are so needed to this community " "It was definitely a tough time. Obviously one of the things that was just new to me was having to space out couldn't really have physical interaction. Hugs you know handshakes and not being able to see a lot of the older members of the church because you know of Covid it was a hard time. "But times are changing now, the church is under new leadership with father Andrew Jones joining the parish in 2021, he plans to bring back many of the services St Jude provided to the community providing food and clothing and other social services. Carrying on the legacy of the man who founded St. Jude, father Harold Purcell. "I'm just excited about a father Jones has so much energy and he wants so much for the people He's a lot like father Parcel. He just wants to reach out and just touch people and it's wonderful." prisoners at St Jude say the number one goal is to. "help everybody the ones who are in need whether they're non-Catholics or Catholics and that's what he's on the road with us trying to do now and he's doing a great job with it" "I love father Jones I love his enthusiasm. I love his energy. It's something that I feel like we need it here for a while. He's always texting me about ideas. I'm doing the same with what I may feel like would help West Montgomery. The overall message to the west Montgomery community is. "We are back and were not dead." "We are here and we are open." Father Jones hopes that the church will soon reopen the food and clothing pantries and begin providing social services again for community members in need. The church is also open to anyone who would like to help out with these community efforts.

February 6, 2023 – Public Safety, Community Events

• February marks a milestone for a nationwide program that started right here in Alabama. Teresa Lawson has more. Alabama plays a big role in the nation's safety 55 years ago on the 16th of this month the very first 9-1-1 call in the nation happened right here in the state of Alabama in Haleyville Since then 9-11 technology has gone from rotary phones and blotchy communication to. We have the ability in some centers to send videos to 911 we have a statewide text to 911 that way if you are in a situation where it's dangerous to

talk like domestic violence or an active shooter or something like that you can actually text 911. 9-1-1 call centers receive between 9 and 11 thousand emergency calls each day across the state with calls handled in your own community 911 centers across the state operate locally according to local decisions and staffed with folks who live in your hometown from its humble roots right here in Alabama to centers in every county in the nation the system's 55th birthday is a great milestone as many of us depend on its accuracy you want to get the call to the right 9-1-1 center immediately you want the person sitting in the seat to know where the emergency is and who to send. That's something that saves time, saves seconds; seconds saves lives. 9-1-1's origination place, Hayleyville, Alabama, celebrates the start of E-911 with a festival and parade each year.

February 7, 2023 – Economic Development

Many area schools need help filling open school bus driver positions. We spoke with one local school system. Reporter Teresa Lawson has more. Please we need drivers. School systems across the state are struggling to fill vacant positions but none more needed than the need for school bus drivers. At Pike Road we have about a 15% driver shortage we need about six or seven drivers to cover all our bus routes. The driver shortage is ongoing and it takes a special person to take on this important task. I called up the school because I'd heard that they were looking for drivers and I said how I can help and what I can do to be the most helpful and they said, please we need drivers. I'm one of the people that came to fill the shortage. I'm a new driver here so I'm actually; I'm making it easier for them because I'm taking up a route that they had to fill themselves. School bus drivers are the first face a child sees in the mornings and the last face they see in the afternoon making the role they play in a child's psyche an important one. What we do is we're carrying the most precious cargo that anybody has, our children so I think that it's important that there is a process that you go through the right training that you become a good driver, that's the most important thing. Getting your child to and from school is very important and it's most important to know that their means of transportation is safe because transporting children is a very huge responsibility you are responsible for people's children and you're out alone with them on the road and with so much going on in society today you have a huge responsibility to keep them safe and be safe while you're driving to ensure this safety school bus drivers go through intense training, certifications and recertification each year. Of course they have to go through a lot of training, a lot of training, the state of Alabama has requirements the federal government also have requirements and we have to meet all of those before that driver can be certified to drive a school bus. All bus driver certificates expire annually on December 31.

February 8, 2023 – Educations and Development

• Montgomery Public Schools received a sizeable donation to go toward STEM education. MPS has partnered with the Armed Forces Communication Electronics Association area chapter to support STEM education. The anonymous donor is referred to by the name Sarge. Sarge gave MPS a donation of 100-thousand dollars. The members went out to different schools sent out emails and had phone conversations to see exactly what the needs were came back and comprised it a schedule and a list of things that they needed and put it to action so that is why all the teachers the schools and principles are

here today so that we can showcase what he has done and how we are giving it right back to the community. Those calls are always wonderful and this one was so special to have a veteran a 92 year old veteran who wants to remain anonymous but provide this to our community and to our kids that's what the work is about how we live our lives and enables us to give back to our community so they can grow so kudos to him we thank him so much I hope I get the opportunity to meet him at some point and thank him in person. The donor wants the money to go towards stem education located in underserved communities.

February 9, 2023 – Economic Development

 Alabama Power customers are getting a refund this summer. On Tuesday the Public Service Commission approved the refund to be paid to eligible customers in August. In December, Alabama Power announced its third rate increase of 2022, citing federal mandates, inflation, and economic conditions. There's no word yet on how much customers will receive as part of that refund.

February 10, 2023 – Economic Development

A major South Korean automotive supplier plans to open its first U.S. plant in Tuskegee. Governor Ivey made the announcement this morning. The manufacturing facility will open in Tuskegee Commerce Park, creating nearly 200 jobs, and providing an economic boost to Macon County construction has already started at Samkee's new manufacturing facility in Tuskegee. Samkee will serve as a Hyundai parts supplier, specializing in die cast aluminum car parts, the company is making a 128 million dollar investment in Macon county and Tuskegee to open their first American plant officials say jobs will pay an average wage of 20 dollars per hour it's a great opportunity for us as a city because your brining in jobs and more people but it is also a great opportunity for the citizens because of the opportunity it will present to them, not only in terms of jobs you also have contracts for services that will be available and Samkee's bringing in an industry that will provide quality jobs, good price with benefits, and we're very excited about that. the center for business and economic research as the university of Alabama estimates that the Samkee factory will contribute 37 million dollars the GDP of Macon county, while also generating 1.3 million dollars per year in taxes the plant is expected to begin production sometime in 2024 with the plant reaching full production capacity in 2025.

February 11, 2023 – Community Events

If you don't come out and see me between now and 2, I'll be there from 3 to 7 so by all means come out and

see who we've got." all adoption fees for the dogs at camp bow wow were reduced and they are now just 75 dollars today.

February 12, 2023 – Civil Rights History, Community Events

Senator Warnock started his visit at the King Memorial Legacy center where he read his book, "Put Your Shoes on & get ready" to the children and adults who attended. He was joined by Congresswoman Teri Sewell who spoke to the children about the political process and the roles they play in Washington. As they entered Dexter Ave Baptist Church, He was joined by Montgomery Mayor Steven Reed to begin the black history program. The Georgia senator is the pastor of Ebenezer Baptist Church in Atlanta where Dr. Martin Luther King, Jr. was also Pastor. He says it was an honor to speak in the pulpit of Dexter Ave Baptist Church the second church where King was a minister and a pivotal location during the civil rights era. This visit is particularly special for me as Pastor of Ebenezer Baptist Church of course Ebenezer is the spiritual home of Dr. King where he was born and raised served alongside his dad from 1960 to 1968 but in the early days of his ministry A young Martin Luther King Jr. came here to serve at Dexter Avenue and the rest is history because he came to Montgomery I was able to go to Washington. For the fact is that Senator Warnock it's not only living history but he also pastor the church that Martin Luther King had in Atlanta so for him to be here at Dexter Ave., Baptist Memorial Church where Dr King actually started his ministry I think it's just a blessing. The connection between his church that he leads at Ebenezer Baptist Church and Dexter Ave., King Memorial Baptist Church is significant these were the two churches that Dr. King pastor and lead at different times along his journey and I think it shows not only his commitment to public service but his commitment to still being a pastor. The event was open to the public, and people of all faiths were welcome. Senator Warnock took the oath of office on January 20th, 20-21 and currently serves on several Committees in the senate.

February 13, 2023 – Health Issues

• A federal judge says Alabama prisons remain critically understaffed. The prison system has lost more than 500 security staff employees over the last 18 months, according to court filings. That's despite a court order to increase numbers. Lawyers for the state say prisons had just under 14-hundred correctional staff members on Sept. 30 of last year. But back on March 31, 2021, they had 1,920 staff members, according to earlier. The numbers include people who are not certified officers. Lawyers for inmates say those people shouldn't count. In 2017, a federal judge said mental health care in Alabama prisons is so inadequate that it violates the Constitution's ban on cruel and unusual punishment. The state says it's used pay raises and bonuses to keep officers but blames the tight labor market for not increasing the numbers.

February 14 2023 – Health Issues, Education and Development

• Troy University will start training mental health counselors for grade schools in central and south Alabama. It's all thanks to a 1-point-1-3 million dollar grant from the U.S. Department of Education. The program will help to address the shortages of mental

health service professionals in schools in the Troy, Dothan, Montgomery and Phenix City areas. In all, nearly 37,000 students in those areas will be served through this five-year grant. if students are not in school they can't learn if they are dealing with emotional and behavioral concerns in a classroom not only is it disruptive to their learning also disruptive to the other students in the classroom so it's important that they receive this mental health services as early as possible. The Troy University School Counseling Education Program will prepare school counselors in training to serve in grades K-12

February 15, 2023 – Public Safety

• A military helicopter crashed in Madison County this afternoon. It happened just outside of Huntsville. Everyone on board was killed. The helicopter belonged to the Tennessee National Guard and was on a routine training mission of Black Hawk helicopter it crashed around 3 p-m. Earlier, reports from the scene said that six people were killed in the crash. However, U.S. military officials say two people were killed.

February 16, 2023 – Public Safety

 A gun was found in a student's backpack this morning at Redland middle school in Wetumpka. Elmore County Public Schools Superintendent Richard Dennis. Says the school is secure and the administration and law enforcement are investigating the incident.

February 17, 2023 – Community Events

Alabama State University is gearing up to host Honda's Battle of the bands-- this weekend. Teresa Lawson shares details. Honda's Battle of the Bands is one of the nation's largest university based musical gatherings. Honda has supported historically black colleges and universities for over thirty years with several programs including the Honda Battle of the bands. And this year for the first time in its history the Honda battle of the bands is being hosted by an HBCU-- and of all the HBCU's to choose from across the country they chose Alabama State University. This is not new for Honda to actually have Honda Battle of the Bands definitely not new for us to be a part of it. Dr. Olive has been featured many times with our Mighty Marching Hornets at the Battle of the Bands but this is the very first time in Honda Battle of the Bands History that it has ever hosted on an HBCU campus so it's pretty exciting to be chosen as the very first stop ever in history to host it right here on this campus, Alabama State University. This year's Honda battle of the bands features marching band performances by six bands from across the country including the Alabama State University mighty marching hornets. The Battle of the Bands is hosted by Loni Love & alum Rickey Smiley. It Features a live Halftime Performance by 2 Chainz who is also an ASU Alum!

February 18, 2023 – Community Events

• The city of Montgomery held their 8-th annual Mardi Gras block party thanks to Montgomery's downtown business association downtown commerce street was in full swing for their Mardi Gras celebration. As Montgomery residents got into the spirit with

traditional New Orleans music and tons of food vendors and unique local art for sale. The block party started at 4 this afternoon and ended at 8 tonight.

February 20, 2023 – Civil Rights History

• The Elmore County Black History Museum is honoring those who helped pave the way for civil rights. Reporter Teresa Lawson has details. The Elmore County Black History Museum is hosting a soft opening this Tuesday-- taking a look at those Elmore county black history leaders whose stories often go unlearned. The museum's focus is to tell the stories of those in Elmore County who made a difference in black history. Exhibits feature artifacts, mostly donated by families of civil rights activists from Elmore County and tell the stories of how the sacrifice made-- impacted a nation. So, there's a lot of rich Elmore county history in that museum that the people in the community haven't had the chance to see. So that's why we wanted to get it open for black history month and to keep it open on a regular part time basis. Exhibits will also include well-known civil rights leaders, including a little known history of Elmore Counties influence on Doctor Martin Luther King's journey while in Alabama. The Elmore County Black History Museum's soft opening is next Tuesday from 9 a.m. to 3 p.m.

After five months of reconstruction. The restaurant is finally ready to open back up to the public! It melted everything and ruined everything in here and I just been redoing it but I'm ready to start cooking all my people are ready we enjoy it and we been enjoying it for 14 years and I'm ready to start cooking some gumbo some alligator some crawfish. Uncle Mick's is scheduled to reopen February 28th.

February 23, 2023 – Education and Development

• The Department of Defense Joined ASU & Tuskegee for a Student Empowerment Conference today. The event was dubbed "Taking the Pentagon to the People." students learned about staff opportunities within DOD among other topics. Our students are our

most precious resource and under our guides of Communiversity this is one way that we can extend to our students be up close and personal look at all the opportunities that all the opportunities that await them particularly in the department of defense. We are here for two reasons one to inform students faculty and staff on opportunities in the department of defense for career opportunities but also to connect those with staff responsibilities for growing The universities infrastructure connecting down to research and development opportunities contracts grants in those kinds of prospects. The exhibit will be open and free to the public -- during the Bridge Crossing Jubilee. "There's just so much to see. And behind every piece of art there's a story. And that's what we're hoping that we will inspire people to not just visually enjoy this but to learn the stories." A grand opening for the exhibit was held tonight. Toure says the African art exhibit -- will now be a permanent part of the museum

February 25, 2023 – Community Events

• A man being held in the Lee county detention center died Saturday afternoon first aid was administered to 36 year old Korey Scott Smith but the efforts were unsuccessful. Smith was booked at the detention center in October for drug charges. The Russell

County Sheriff's Office investigations division was contacted to perform an investigation. Smith was transported to the Department of Forensic Sciences in Montgomery for an autopsy. When completed, the findings will be provided to the Lee County District Attorney for presentation to a grand jury.

February 27, 2023 – Community Events

We want to know what you think. Do you think community involvement is making a difference in crime in Montgomery? And would you feel confident in going to the police when you know something? We hit the streets of Montgomery to find out. Is very important for the community to be involved more reporting things that they see could actually help the police officers you know called and letting them know what they see that's very important community as a whole need to look out to each other. Just keep doing what they are doing I mean nowadays things are a lot different and a lot harder a lot of people you know don't like them for what they do but if we didn't have then who would be so you know I think them for doing what they are trained to do and what they are supposed to do. I feel like if its boots on the ground and they are engaged then people feel safer because they know that they are present. If I had that Magic wand I will take all these guns off the street and then changing a law where you don't have to have a permit no more that made it worse so that's what I would do if I had a magic wand I would take all these guns off the street when I grew up we were throwing hands we didn't have to have no guns. You want to be in trust with the people who you protect and serve and we want to be able to call them and they come out and they serve and protect us to and all and everyone every race is very important trust is huge.

February 28, 2023 – Community Events, Civil Rights History

Details of the visit haven't been announced yet but he's expected to be in Selma on Sunday. The President of the United States of America, President Joe Biden will be at the Bridge Crossing Jubilee on Sunday, March the 5th. It was wonderful without him. It's super wonderful with him. And now with the President coming to the Jubilee security at the event just got a whole lot tighter. If you think you're going to be in a hurry please do not try to travel downtown. Find an alternate route to get out of Selma or around Selma. Because a lot of road closures will take place. Fulford says security sweeps on the ground in the air and on the river are being conducted. And the Edmund Pettus Bridge along with several downtown streets will be closed on Sunday as a result of the presidential visit we are working with the Secret Service and the partnering agencies to make sure that this is a safe trip for him. It's such powerful symbolism. Especially, with Selma having suffered this tornado on January the 12th. It's just great to be able to say that the President will be able to be here with us at the Bridge Crossing Jubilee. Sanders say this will be Biden's 3rd visit during Jubilee but his 1st as president. The Bridge Crossing Jubilee commemorates Bloody Sunday and the Selma-to-Montgomery marches. It's the biggest annual civil rights event in the country and people come from around the world to attend each year.

March 1, 2023 – Education and Development

• The closure is effective today. Troy's "Confucius Institute" opened in 2007. It was a joint venture with educational partners in China to provide language and cultural learning opportunities to people in Alabama. The university says hundreds of people took advantage of its programs. Troy says the federal government gave universities a deadline of October to discontinue the programs. or lose eligibility for defense funding. Troy says it will continue to recruit students from China. and maintain relationships with Chinese universities.

March 2, 2023 – Volunteer Opportunities

• FEMA is looking for volunteers to help tornado survivors with cleanup. in Equality this Saturday. The cleanup will be from 8 a.m. to 2 p.m. All skill levels are welcome. Volunteers are asked to bring chainsaws, heavy equipment, rakes, and shovels to help move debris to the curbside. And wear long work pants, and work gloves. Volunteers will meet up at Rehobeth United Methodist Church at 664 County Road 18 in Equality. If you are interested call 256-935-9561.

March 3, 2023 – Education and Development, Community Events, Civil Rights History

• Friday's activities feature nearly a dozen separate events -- with most centered around education and youth. Selma High School hosted the annual Children's Sojourn. And students at Tipton-Durant Middle School competed in the Voting Rights Bowl. Both events taught area youth -- about the historic events that happened in the city they live in. And the impact those events had on the world. People like marched. They risked their lives for us to vote. It made me feel like, like history is in my city. And it's full of things for you to learn. Our youth are not just our future, they are our present. They are right here. And that's why it's important to teach them this history. An Education Summit was held at Wallace Community College Selma. The workshop lectures and presentations on a range of the history of black people that went beyond slavery and civil rights. Education is the essence of life. We are who we are because of how we've been educated. So, what we're doing here at this summit is assuming responsibility for our thinking by instilling within the minds of those who are receptive to this knowledge, a correct historical interpretation. So that they know who they are. Author and cultural historian Dr. Anthony Browder was one of the presenters at the summit. This is not Black History, This World History. And we truly believe that to know this history will inspire our children to believe that they can do Math and Science. And they can do more than just play basketball and rap. The annual Mock Trial at the Dallas County Courthouse featured law students from Texas Southern University arguing against voting laws that suppress the black vote. The day's events wrapped up with a screening of the documentary Freedom Riders: Carrying Forward Their Legacy. And "A Public Conversation" about "Rebuilding Selma" with tornado victims and Rev. Dr. William Barber.

March 4, 2023 – Public Safety

• A search and rescue training exercise was conducted at Prattville airport today. The National Emergency Services Academy conducted their five-month training exercise which began in December. The exercises are designed to improve the civil air patrol's

search and rescue capabilities. The event today involved five aircraft from Alabama, Georgia, and Mississippi with over one hundred and twenty cadets and officers in training. search and rescue is one of three missions that the C.A.P. performs nationally. "The training scenario that we're conducting today actually involves electronic beacon targets that are put north of the Montgomery area. The aircraft you see behind me are going out and they're going to look for those electronic beacons and then they're going to guide these ground search teams to that target area. This replicates what we would do for an actual emergency search for a missing aircraft attempting to track that emergency locator beacon for that airplane." the training exercises are open to the public to observe and they end tomorrow around noon

March 5 2023 - Community Events, Civil Rights History

• The annual Martin and Coretta King Unity Breakfast was held this morning and it is one of the main events of the annual Bridge Crossing Jubilee festivities. Over a dozen national leaders were featured speakers at this year's Unity Breakfast. One of the speakers was Martin Luther King the Third the son of Martin and Coretta King. The event honors their civil rights legacy and it challenges people to join the effort to realize Dr. King's vision of the Beloved Community. "You know everybody doesn't have the same strength, everybody doesn't have the same interest. But bringing what you have, bringing the gifts and strengths that you have for a common cause. To me, that's what unity means." The Rev. Jesse Jackson was given the International Lifetime Achievement Award at the event and former Atlanta mayor Andrew Young, Jr. received the International Peace and Justice Award.

March 6 2023 - Community Events, Civil Rights History

• The president was in Selma for the annual Bridge Crossing Jubilee. He and thousands of others crossed the Edmund Pettus Bridge in remembrance of "Bloody Sunday" in 1965. Before the walk. Biden spoke to the crowd, saying that voting rights are under assault blaming the U-S Supreme Court for gutting the Voting Rights Act. Two years ago. He tried to get new legislation passed but it failed to make it through the Senate. Some activists have written to Biden expressing their frustration that more progress hasn't been made. It was voting rights that prompted people to take to the streets in Selma in 1965. The 58th anniversary of what became known as "Bloody Sunday" is Tuesday. It was March 7, 1965. That about 600 marchers crossed the Edmund Pettus Bridge hoping to make it to Montgomery in order to protest the lack of voting rights. Alabama State Troopers were waiting for them on the other side. Some state troopers beat the marchers severely that day. Later that month a successful march made it to the Capitol in Montgomery and helped lead to the passage of the Voting Rights Act.

March 7, 2023 – Civic Affairs

• The session is expected to last until about mid-June. Today the House and Senate met briefly then adjourned until March 21. That clears the next two weeks for a special session on what to do with 1-point-1 billion dollars in American Rescue Plan money from Washington. But there are also other issues on lawmakers' minds. An issue of storm

water has become a real challenge and I think that's the topic that we have not really had on the forefront until we've kind of gone through this process so I think that's an issue that many are going to be continuing to look at it's an important one throughout the state. we know we may have proration coming around the corner we must start looking at smart budgeting and how we're going to be able to save money going into 24 2526 and 27 and so some of those things I think we can do bipartisan and those things that we're going to do that we have to fight we will be willing to fight but in the end of the day we are state senators and we're going to be looking to do what's best for the state of Alabama. There is also an unusual 2-point-7 billion dollar surplus in the state education budget. Nearly one in every four lawmakers is new after winning elections in November.

March 8, 2023 – Civic Affairs

• Ivey made that proposal in her annual "State of the State" address last night. She's calling on the Legislature to return nearly one-billion dollars to taxpayers through this one-time rebate. Individual taxpayers would get the 400-dollars, families 800-dollars. Ivey says this would help families who are faced with inflation.

March 9, 2023 – Crime Prevention and Law Enforcement

• The body of the man whose bloody car was found on the Edmund Pettus Bridge has been recovered from the Alabama River. The body was found in the river in Wilcox County between Gees Bend and Millers Ferry. Sheriff Larry Colston says a fisherman spotted the body in the river Saturday then called authorities. The identity of the man has not been released at this time. The man's body was sent to forensics for an autopsy. His bloody car was found abandoned on the bridge in Selma about two weeks ago.

March 10 2023 – Health Issues, Community Event

• If you're in need of dental work. Listen up! strong tower is offering a free dental clinic through Saturday. The dental Clinic on wheels is giving free dental care to the community on the west side of Montgomery. Several groups - including *Send Relief*, *Maxwell Air Force Base dentists*, and *The Church at Liberty Park* - have partnered together to help make this happen. Around one hundred and fifty thousand dollars of FREE dental work has been performed already. there are individuals here on the west side might need some dental assistance maybe they can't get it from nowhere else or maybe health insights or information to have a quality of living were here to say they come on through you can be apart and learn if you need your teeth pulled or something we are here to help and serve. The clinic is located at 28-40 Boys Club Road and it runs from 8 a.m. until 5 p.m. through Saturday.

March 11 2023 - Community Event

• Governor Kay Ivey gave her state of the state address earlier this week. but a group of Alabamians were not happy with what they felt the governor left out. The Alabama poor people's campaign held a rally on the capitol steps. to give what they are calling the 'real'

state of the state address. About systemic poverty and injustice. the group organizers pointed out that more than forty five percent of Alabamians live in poverty. and they feel this part of the population was omitted from the governor's address. "we're bringing everybody together. We're dealing with issues of survival, really, that affect everybody and it's working. it's working. We have over 4 thousand members in Alabama and we're still growing. it's just a matter of getting the word out and educating people." The launch was held on the front grounds of Jackson hospital. He was a great baseball player a great football player just a good kid all it takes is one time chase wasn't an attic he was just experimenting like kids do sometimes and he had no idea he just took one pill just one time to completely change our lives forever. Someone who is naïve to taking these and they get a little sample of this or a peel from one of their friends can end up dying just with one single dose of this and even though we like to think our family are friends our kids are grandkids are all safe if they are out mixing with these people and sampling these drugs they are not safe at all and like I said it only takes one time with many of these people who are naive to narcotics to die. organizers say they will use every platform available to inform the public on how to protect themselves. from this deadly drug.

March 14, 2023 – Law Enforcement, Volunteer Opportunity

• The Alabama Law Enforcement Agency is partnering with an anti-littering campaign. The campaign is focused on keeping the roads clean from litter, and helping to protect and preserve the state's environment. That's why ALEA is teaming up with People Against a Littered State, to educate citizens, as well as visitors, well, it has a huge economic impact picking up litter weather its throughout ALEA our partners whether it's through volunteer groups the national average is about 33 cents apiece cost the state or the communities to pick up Alabama State Law allows a fine up to \$3,000, and 100 hours of community service for a misdemeanor littering offense.

March 15, 2023 – Economic Development

• Prattville has unveiled a new fountain downtown. The newest addition was added after the construction of the mill apartments and pedestrian bridge. The fountain was placed in honor of Dr. Tom and Linda Miller who donated property for the bridge. A ceremony was held this morning to honor the miller family. Dr. Miller was also recognized for the many ways he has given back to the community. "As we dedicate this, I think it's very appropriate since we are the fountain city and that way we will actually now have 2 bigger fountains here in Prattville we'll have our Musgrove fountain over here in heritage park and I'll call this 1 miller park - miller fountain right over here in our roundabout. It's just a great day for us to have partnerships and friendships and just building memories as we go." The fountain is located at the roundabout on bridge street.

March 16, 2023 – Economic Development

• Alabama lawmakers have given their final okay to spend one billion dollars in federal pandemic relief money. It'll be used on a mix of water and sewer projects, broadband expansion and health care reimbursements. Wording has been added to allow local governments to use some of the water and sewer funds for storm water projects to combat flooding. Last week, Governor Ivey called lawmakers into special session to allocate the state's remaining \$1 billion. sent from the federal American Rescue Plan Act. Here's a breakdown of where some of the money is going. \$339 million for health care costs, including \$100 million to reimburse hospitals for pandemic-related expenses, \$100 million to nursing homes and \$25 million for mental health. \$400 million for water and sewer projects, including \$5 million for septic systems in the Black Belt. \$260 million for expansion of broadband. Governor Ivey has already signed it.

March 17 2023 – Education and Development, Community Event

Republican lawmakers say the *good act* will enhance the *transparency* of documents issued by government agencies, which helps all entities including small businesses, workers, and households to comply with regulations. Regarding the legislation senator britt says quote. "Sunlight is often the best disinfectant" and that "unelected federal bureaucrats should *not* be taking actions that affect hardworking Americans' lives without robust transparency and the opportunity to hold them publicly accountable. This is a commonsense measure that my colleagues on both sides of the aisle should support." The bill was advanced by the senate homeland security and governmental affairs committee by a *voice* vote twice and it passed the house in 2018.

March 19, 2023 - Public Safety

We have some consumer news to tell you about tonight. Ford is recalling more than one point two *million* vehicles due to potentially faulty brakes. The recall includes fusion and Lincoln MKZ models from the years 2013 through 2017 plus a few from 2018. The national highway traffic safety administration says their brake hoses can leak fluid, making the vehicle harder to stop. Only about two percent of the cars have that problem and ford only knows of one related accident with no reported injuries. Ford says it will swap out the brake fluid hoses for free at dealerships. You can enter your car's vin number on the NHTSA website to check if it's part of the recall. Perrego company which makes Gerber's good start infant formula - is recalling some of it's *Gerber good start soothe pro powdered infant formula*. Because it may be contaminated with bacteria. The formula was made between January second and January 18th of this year. The company says so far.no products have shown any signs of bacterial contamination, and no one has become sick. But Perrego opted for the recall out of an abundance of caution. And Honda is recalling a half-million vehicles including CRVs, Accords, Odysseys, Insights and the Acura RDX. Honda says the seat belt in the driver seat and front passenger seat may not latch properly. The automaker says it has not received any reports of injuries due to the problem. Impact owners will be contacted by mail starting April 17th.

Public Service Announcements 1st Quarter 2023

ABA/ALABAMA DEPARTMENT OF PUBLIC HEALTH (ADPH)

The Alabama Department of Public Health (ADPH) received the initial allocation of more than 200 doses of vaccine for monkeypox virus infection on July 21, with additional doses expected to be delivered soon. To help prevent illness from the virus, ADPH will offer vaccine and monitor for early signs of illness in eligible persons. Due to the limited supply of vaccine at this time, post-exposure prophylaxis will only be made available to those who are known to have been exposed within the previous 14 days to a person with monkeypox, or to a person attending an event at a venue where monkeypox virus was known to have been transmitted.

Alabama is experiencing an outbreak of Hepatitis A, a contagious, vaccine-preventable liver infection that is spread in the feces of infected people. Failure to wash hands after using the restroom or changing a diaper can result in the spread of this vaccine preventable disease.

ABA/ADULT PROTECTIVE SERVICES (DHR)

The Alabama Department of Human Resources is working to bring attention to the abuse of elderly persons in Alabama.

ABA/ ALABAMA CLEAN COALS COALITION

The screenings are a key component of the law — which empowers VA to deliver care and benefits to millions of toxic exposed Veterans and their survivors. "Since we launched the

toxic exposure screening program, VA connected with 1 million Veterans around the country," said VA Under Secretary for Health Shereef Elnahal, MD. "Our health care teams reached an incredible breakthrough in a short length of time. These screenings are paramount to improving the health outcomes for Veterans and providing them with the health care and benefits they've earned as quickly as possible. This is among the first steps we have taken to deliver even more benefits and health care to Veterans who have been exposed to toxins during their service." The screening takes an average of five to 10 minutes and begins by asking Veterans if they believe they experienced any toxic exposures while serving in the Armed Forces. Veterans who answer "yes" are then asked about specific exposures, including open burn pits, Agent Orange, radiation, contaminated water and other exposures. If a Veteran has been exposed to toxins during their time of service, VA wants to know. It not only impacts their individual future care, but it can also improve overall toxic exposure-related care and outcomes. If you are a Veteran who has not been screened for toxic exposure or has never received care at VA, we encourage you to contact VA about enrolling in the VA health care system and about obtaining a toxic exposure screening. VA encourages all eligible Veterans and survivors to apply for their earned PACT Act-related health care and benefits now. Don't wait until something is wrong before coming to VA — our providers are trained to recognize issues and concerns unique to Veterans.
