**1. POLICE, THE COURT SYSTEM AND CRIME**

**AMERICA'S MOST WANTED**-Network/Public Affairs-Saturdays 8-9 p.m.: One hour show each week that asks for the public's help finding criminals police are looking for that are still on the run.

**FOX NEWS AT 9** - Local/News-Sunday, April 30, 2006, 9-9:30 p.m.: Thousands of immigrants are closing their businesses and not going to work to protest proposed immigration laws, including President Bush's push for a guest worker program instead of immediate citizenship . A 2:20 report.

**FOX NEWS AT 9** -Local/News-Thursday, May 25, 2006, 9-9:30 p.m.: Detectives are trained and go through years of experience before talking to kids about being victims of crimes such as kidnapping or child abuse . A 2:05 report.

**FOX NEWS AT 9**-Local/News-Saturday, May 27, 2006, 9-9:30 p.m.: There is a change is the law for anyone leaving the scene of a boating accident where there are injuries or fatalities. It is a serious misdemeanor for leaving the scene if there are injuries, and it is a felony when a person dies in the accident. A 1:15 report.

**FOX NEWS AT 9**-Local/News-Tuesday May 30, 2006, 9-9:30 p.m.: Johnson and Linn counties are the only counties in Iowa not taking advantage of a one-cent local option sales tax used for school structure improvements. A :36 report.

**FOX NEWS AT 9**-Local/News-Tuesday May 30, 2006, 9-9:30 p.m.: Americans have become quite impatient with just about everything. The “On Demand” generation has become quite demanding. **GOOD DAY IOWA**-Local/News-Thursday April 27, 2006, 7-9 a.m.: St. Luke’s Hospital unveiled a \$40 million expansion project, which will renovate the west entrance, expand the emergency department and pharmacy and remodel and move the rehabilitation center.. A 1:50 report.

**FOX NEWS AT 9**-Local/News-Thursday, April 27, 2006, 9-9:30 p.m.: A new study found the nation’s obesity problem has been under-reported by as much as 50% since 1988. A :45 report.

**FOX NEWS AT 9**-Local/News-Monday, May 29, 2006, 9-9:30 p.m.: State hospitals hope to save money by rewriting a rule, allowing them to open specialized wings for frail and long term patients. The wings would be separate hospitals within the hospitals. A :25 report.

### 4 **NEED FOR ECONOMIC GROWTH**

**FOX NEWS AT 9** -Local/News-Tuesday, April 25, 2006, 9-9:30 pm: President Bush unveiled a new four point plan to try and stave off rising gas prices. He temporarily halted deposits to the strategic petroleum oil reserve. The President is calling on Americans to turn to hybrid and clean diesel vehicles as a way to conserve oil, and suggests investing in alternative fuels like ethanol. A 1:20 report.

**GOOD DAY IOWA** -Local/News-Wednesday April 26, 2006, 7-9 a.m.: Rockwell Collins posted a 20% increase in its second quarter earnings on higher defense and commercial sales. A :31 report.

**FOX NEWS AT 9** -Local/News-Friday, April 28, 2006, 9-9:30 p.m.: Gas prices did not go up this week, but Iowans are still paying around \$2.75 a gallon, the highest since Hurricane Katrina. Governor Vilsack would like President Bush to limit profits that oil companies may earn, and pledge more federal money to fund alternative energy projects. A :35 report.

**GOOD DAY IOWA** -Local/News-Friday April 28, 2006, 7-9 a.m.: Governor Vilsack and party leaders have finally hammered out a budget deal: \$105 million over 5 years to increase teacher pay, \$15 million a year to bolster preschool programs and the "senior" tax will be phased out over the next 8 years. A :26 report.

**FOX NEWS AT 9** -Local/News-Saturday, April 29, 2006, 9-9:30 p.m.: 600 jobs will be eliminated in Iowa when Verizon, whose call centers were part of MCI, closes a call center in Sergeant Bluff at the end of June. A :30 report.

**FOX NEWS AT 9** -Local/News-Saturday April 29, 2006, 9-9:30 p.m.: Whirlpool officials said about 65 workers lost their jobs yesterday at Maytag's Newton plant. It leaves the workforce at about 950 people, the lowest in 60 years. A :25 report.

**FOX NEWS AT 9** -Local/News-Monday, June 19, 2006, 9-9:30 p.m.: A state probe into the "Iowa Values Fund" shows 2 dozen companies failed to create the jobs they promised and must return the money. The report says the companies had pledged to create more than 1700 jobs, investing \$201 million. Those companies either declined state assistance or failed to create the jobs they promised. A :26 report.

## 5. **ENVIRONMENTAL CONCERNS**

**FOX NEWS AT 9** -Local/News-Saturday April 22, 2006, 9-9:30 p.m.: Residents in Waterloo gathered to protest a proposed coal fired power plant. Opponents say the plant will not only harm the environment, it will also damage their health. More than 1000 people have signed petitions saying they do not want a proposed coal fired power plant built in their backyard A 1:50 report.

**GOOD DAY IOWA** -Local/News-Wednesday April 26, 2006, 7-9 a.m.: Hundreds of Iowans took to the highways to eliminate litter in their neighborhood which was part of "Keep American Beautiful's Great American Cleanup". Linn county residents picked up litter along I-380, McCloud Run and Cedar Lake. A :25 report.

**FOX NEWS AT 9**-Local/News-Wednesday, May 31, 2006, 9-9:30 p.m.: An Iowa company may soon play a critical role in preventing the introduction or spread of the Avian flu and other viruses in American. Quality Attributes Software of Ames makes control systems for a Florida company that builds a unit designed to quickly decontaminate airplanes. A 1:50 report.

**GOOD DAY IOWA** -Local/News-Wednesday, May 31, 2006, 7-9 a.m.: Governor Vilsack has signed new tax incentives for E-85 and biodiesel production, legislation that positions Iowa to become number one in renewable fuel consumption and may give drivers a break at the pump. Signed legislation bills also include requiring that 25% of all fuel burned in the state be renewable by 2020. Iowa would also spend \$13 million over 3 years for retailers to install special E-85 tanks. A 1:38 report.

**GOOD DAY IOWA** -Local/News- Wednesday May 31, 2006, 7-9 a.m.: Nitrate levels in the Cedar River are reaching dangerous levels. If water quality does not improve, Cedar Rapids could be forced to build 2 special plants to remove the poison with a cost of at least \$5 million each. A :46 report.

**GOOD DAY IOWA** -Local/News- Monday June 19, 2006, 7-9 a.m.: A state commission has voted to approve a controversial request by the Iowa Department of Natural Resources to have the ability to deny livestock confinement construction permits. A :20 report.

**FOX NEWS AT 9**-Local/News-Monday, June 19, 2006, 9-9:30 p.m.: The Iowa Public Interest Research Group claims that over the past 40 years air pollution has increased in the state by 97%. A :20 report

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Michael Paul Astorga** (Murder) -- Michael Astorga was already a wanted man when he shot and killed Deputy James McGrane, a member of the Bernalillo County Sheriff's Department. Now authorities say he's an FBI Top Ten Fugitive and one of the most hunted men in the world. On the night of March 22, 2006 on a rural highway in New Mexico, Deputy McGrane pulled over a pickup truck occupied by three men. It is unclear why Deputy McGrane stopped the truck or what he said to the occupants. However, what authorities are clear about is that Michael Astorga was in the vehicle and they believe he shot McGrane in the head with a 10mm glock. Astorga is no stranger to the law. He is currently on probation after serving time for selling drugs, stealing cars and other property crimes. In November 2005, just a few months before McGrane's murder, Astorga shot and killed a long-time enemy named Candy Ray Martinez. A warrant was issued, but Astorga had managed to avoid arrest. Michael Astorga uses the aliases Mike Paul and Michael Martinez. He has tattoos on his back, legs, arms, abdomen and left wrist. The tattoos include images of the Virgin of Guadalupe and a nude woman. He had a shaved head at the time of the shooting and he has been known to wear a goatee and/or light mustache. Astorga is 29, 5'11" and 160 pounds.

**Antonio Delacruz, Jr.** (Murder) -- The Harris County Sheriff's Office is searching for Antonio Delacruz. On August 31, 1998, Jose Garcia and Antonio Delacruz went to rob a house in Houston, Texas. The two men knew the owner of the house, Nicholas Acosta. Acosta was involved in drugs and had recently started dating Delacruz's ex-girlfriend. The robbery turned into violent murder. Garcia and Delacruz stabbed Acosta 17 times. Then Delacruz began beating Acosta over the head with a barbell. The scene was so frightening that Garcia fled, leaving Delacruz at the house. Garcia arrived back at his mother's house where Mrs. Garcia immediately called the police after she saw the bloody mess. Delacruz was on the way back to Garcia's when he heard that police were on the way. Delacruz decided he needed to burn all of the evidence.

He fled to burn his truck, but police caught up with him. They put out the truck fire, as well as Delacruz who was also on fire. Jose Garcia was arrested and is currently in Harris County jail. Delacruz was charged with murder on August 31, 1998. A \$100,000 bond was set for his bail. On October 28, 1998, Delacruz was charged with bond forfeiture. Delacruz's father owns a bail bonding business and contacted people in his business to help his son. Delacruz's wealthy family, especially his mother's side, may be hiding him. Delacruz's mother, maiden name Flores, is an associate president of a bank in Texas. He was last seen at a strip club in February 1999. Delacruz is 30, 5'8" and 170 pounds. **Jeremy Paul Duffer** (Aggravated Sexual Battery, Rape of a Child) -- Jeremy Duffer, a manager of a popular video game store, is accused of sexually abusing a 10-year-old boy. After being threatened and molested for nearly two years, the young boy finally revealed the shocking truth to his mother. Police investigated the allegations and were able to elicit a confession from Duffer. Duffer was arrested and sat in jail until he was bonded out a year later. As a condition of his release, Duffer had to wear an electronic monitoring device on his ankle. Five days before his trial, he cut off the device and disappeared. Duffer is an agoraphobic who goes to the movies on Wednesday mornings to avoid crowds. He enjoys role-playing and war games and may hang out in game stores that specialize in these activities. He may be driving a dark blue-colored Pontiac 6000 or Chevrolet Citation. The vehicle is described as having dents in the front, rust over the wheel wells, and missing a hub cap on right front tire. Police believe the car has a temporary tag. Duffer is 35, 5'11" and 190-240 pounds.

**Glenn Anthony Mitchell** (Rape, Robbery) -- On May 2, 1981 a 21-year-old woman was brutally raped in her home in Springfield, Va. It was not until May 2004 that police in Virginia were able to match the evidence from the vicious crime with a suspect -Glenn A. Mitchell. In August 2004 a grand jury indicted Mitchell for rape, sodomy, robbery and burglary. Mitchell was arrested a few days later but was let out on bond. When he missed his court date on April 4, 2005, a warrant was issued for his arrest. Police believe Mitchell may be in Prince Georges County, Maryland or staying with a female acquaintance in Washington, D.C. Mitchell is 58, 5'11" and 150 pounds.

**Clansie Banner** (Criminal Homicide) -- On February 16, 2005, Kenyattus Kyles was shot to death in broad daylight. Police in Harrisburg, Pennsylvania discovered Kyles' bullet-wounded body on a sidewalk after responding to a "shots fired" call that came from a residential area. Police rushed Kyles to a local hospital where he died from a gunshot wound to the chest into his chest. Police say Kyles was far from being an innocent victim. Police believe Kyles' death was directly related to the lifestyle associated with drug use and drug dealing. Officials believe Kyles was getting his drug supply from Clansie Banner. The native Jamaican had been living in Florida until 2002 and that's when police think he moved to Harrisburg. The connection between the alleged drug dealers soured when Kyles stole some marijuana from Banner. The incident set-off a feud between the men and the fight came to a head in February 2005. Banner and Kyles got in a car accident. They allegedly got out of the vehicles they were driving and started an argument in the street. Police say it wasn't long before Banner shot Kyles in the chest and then fled the scene. Police believe Banner could be hiding out in a number of places including Jamaica. Banner is bald now and has a slight mustache in some photos. He speaks with a heavy Jamaican accent.

He may now be bald. Banner is 37, 5'11" and 170 pounds. (See Shows #816 and #823, OADs 8/06/05 and 9/24/05)

**Edgardo Rodriguez** (1<sup>st</sup> Degree Murder) -- Police in Chicago suburb Cicero, Illinois are searching for Edgardo Rodriguez, who they say was only 16 years old when he killed a man. It all started when Lorenzo Ayala, a member of the Saint Disciples gang, and one of his friends ventured in to rival territory when they went to visit Lorenzo's grandmother on July 14th, 2003. On the way back home, detectives say that 19-year-old Lorenzo was confronted on the street by some "Pee Wee" members (junior, younger gangsters) of the Maniac Latin Disciples. The group exchanged words, and the battle escalated to a full-on street brawl. Amidst the street scuffle a shots rang out. Rodriguez had pulled up in a car during the fight and came out firing. He hit Lorenzo in the shoulder and the other bullet passed through his lung and heart. The man who had just gone to visit his grandmother died on the scene. Despite his age, Edgardo Rodriguez faces adult charges for Lorenzo's murder. Cicero Police also would like to question Rodriguez about a second homicide once he is in custody. Rodriguez is a self-proclaimed Maniac Latin Disciple gang member. He's described as short-tempered and is considered armed and dangerous. Edgardo Rodriguez has multiple ties to the Chicagoland area. Rodriguez is 18, 5'6" and 140 pounds. (See Show #821, OAD 9/10/05)

**Unknown Rashawn Brazell Killer** (Homicide) -- Around 3:00 a.m. on February 17, 2005, New York City transit workers found two suspicious bags alongside the track at the Nostrand Avenue station in Brooklyn. It would spark the investigation of one of the most gruesome crimes New York has seen. One of the bags was a black trash bag. Inside it was a blue trash bag, and inside that were the body parts of a young black male. The other bag was a beige and black tool bag with wheels and a insignia on the side that read "Rooster". Inside this bag the police found blood-stained drill bits and other tools. They later learned this bag was one of only 15 bags made as a prototype and sold to the Metropolitan Transportation Authority in 2001. On February 23, 2005, workers at the Humboldt Street recycling plant in New York made another gruesome discovery. Additional body parts were found inside a blue trash bag which had been stuffed inside a black trash bag. A day after that, workers at the recycling plant found yet another black trash bag which contained a blue bag of body parts. The killer had carefully traced the body of the victim with a sharp instrument before cutting it apart with an electric chain saw. Every cut was clean and on a joint, indicating the killer had a keen knowledge of human anatomy. But mysteriously, the head was never found. Without it, the actual cause of death is unknown. Cops finger printed one of the found hands. The prints matched those of Rashawn Brazell, who was once arrested on a minor marijuana charge. He'd been reported missing on Valentines Day - three days before the first bag of parts was found. Forensic work confirmed all of the body parts from the three bags belonged to Rashawn. Friends and family members describe 19-year-old Rashawn as a "good kid". He worked four jobs and he wanted to be a web page designer or go into the fashion industry. In fact, months before his murder, he actually had a stint in a New York fashion show modeling clothes. Rashawn was gay, but police say there is no indication it was a hate crime. So what could the motive have been? The medical examiner believes Rashawn was kept alive for two days before he was killed, dismembered and disposed of in the trash bags. The autopsy report shows cuts and stab wounds to the side of Rashawn's torso indicating there may have been some kind of a struggle. Investigators believe the killer may have been a transit worker due to his usual knowledge of the tracks. Police believe the killer placed the body parts in blue plastic bags and then carried the bags of body parts, one at a time,

in the beige and black tool bag. They believe the killer then transferred the blue bags into black trash bags in the subway. The killer probably thought the trash inside these bags would be crushed up. However, trash from the subway system is always sorted for recyclable material. Ray Pierce, a retired New York Police Detective helping to profile the suspect, believes the killer has killed before. Rashawn's family said that on the morning of February 14, 2005, Rashawn was scheduled to meet his accountant and then meet his mother for lunch in Manhattan. At 7:30 that morning, an unknown person rang the apartment building's security buzzer and Rashawn went down to meet them. According to other witnesses, Rashawn met a man outside his Brooklyn, New York apartment and the two men entered the subway together at the Gates Avenue J Line. Witnesses believe the two exited at the Nostrand Avenue A Line in Bedford Stuyvesant a short time later. Rashawn was never seen alive again. (See Show #823, OAD 9/24/05)

### **ALL POINTS BULLITEN:**

**Marvin Mercado** (Murder, Attempted Murder, Robbery) -- Los Angeles Police say Marvin Mercado and his partner, Sothi Menh, are the ringleaders of a vicious gang called the Asian Boyz. Menh goes by the gang name Player Number 1, and Mercado is known as Shy Boy. On December 3, 1993, the gang entered an LA pool hall which was in rival gang territory. When a member of the Boyz named Leah Mek, who went by the gang name of Kicker, began bragging to rival gang members a gunfight broke out. Kicker was killed that night and the Asian Boyz swore revenge. Police say it was the start of a three year gang war; in one 18 month period, the Asian Boyz pulled 12 murders. Not all the victims were rival gang members. Detectives say Asian Boyz broke into the home of Jon and Jennifer Gregory. When Jon confronted the gang, they killed him. This home invasion robbery was only one of the dozens of similar brutal crimes pulled by the Asian Boyz to finance their ongoing wars, police say. Los Angeles Police formed a special task force to bring down the gang. Little by they infiltrated and gathered evidence and several members were flushed out. One of these was the young man police say was a mastermind behind the Asian Boyz's home robberies - Sam Chan. On February 13, 1997, a warrant was issued for the arrest of Sothi Menh and Marvin Mercado. Menh, thanks to an America's Most Wanted viewer, was picked up in Cambodia and extradited to the United States. Mercado is still on the run. Mercado, a native of the Philippines, has a large dragon tattooed on his back. He is 32, 6'0" and 155 pounds. Authorities say Mercado should be considered armed and dangerous. (See Shows #451, #463, #498, #501, #571, #602, #702, #746 and #794, OADs 5/17/97, 8/30/97, 6/6/98, 6/27/99, 1/8/00, 9/2/00, 12/28/02, 12/27/03 and 2/05/05)

**Loren John Trites** (Illegal Wiretapping, Tampering With Evidence) -- Trites is wanted for the 1997-1998 unauthorized videotaping of teenage females in a swimming locker room. Trites was the swim coach at Franklin and Marshall College in Lancaster, Pennsylvania. He was also the coach of a large competitive swimming club in the area. Trites filmed the girls on his swim team, ages 13-21, in various stages of undress in their locker room at F&M. Trites would climb up onto the ceiling ducts and hide cameras under towels to film the girls. On January 23, 1998 the female swimmers turned over a tape from a camera they found under a pile of dirty towels. Trites was interviewed by police, but invoked his Fifth Amendment rights. Before he could be questioned further, he withdrew money from a Philadelphia bank and fled. He was traced to Trinidad and then to New London, Connecticut, but both times Trites escaped. Police suspect that Trites is running from more than just these charges because he deserted his home,

job, wife, and new car before he was even charged with the crimes. Trites, who was going through a divorce at the time he fled, is an unassuming and otherwise law-abiding person who likes the finer things in life, including nice SUV's and drove a new Lincoln Navigator prior to the incident. He sometimes changes his appearance with a beard and/or mustache. Trites is 44, 6'7 and 300 pounds. (See Shows #630, #659, #692, #737 and #794, OADs 4/28/01, 1/5/02, 9/28/02, 9/27/03 and 2/05/05)

**Unknown Selvin Cano Killer (Murder)** -- On Independence Day 2005, Selvin and his friends celebrated both his birthday and the national holiday. They'd heard there would be fireworks and girls up at Case Park, a local park with picturesque views of both Kansas City, Missouri and Kansas. Just before midnight, they headed out and one of them took a video camera to capture the fun. When Selvin and his friends arrived at the park, the place was jumping. The guys were checking out custom wheels on custom cars, talking with the girls on the scene and enjoying fireworks exploding in the night air. Later that evening Selvin defends a man who had been kicked, hit and stomped repeatedly by a group of men. He manages to free the victim from the beating and then becomes a target himself. When the brawl escalates, Selvin is shot and killed as a result of his heroic efforts. Although the entire incident was caught on tape, it was not clear enough for cops to make a positive identification of the man who shot Selvin. Investigators turned to Dr. David Hathaway at NASA for help. Investigators were hoping that through a unique and methodical process, Dr. Hathaway could clean up and enhance the videotape. They were hoping that he could bring the killer's face into focus. After watching the tape again and again, Dr. Hathaway found certain clues about the shooter that had not been previously confirmed. The killer was wearing a backward baseball hat and wore a chain with a large medallion on it. Also, it appeared as though the killer may have facial hair running along his jaw line, from ear to ear. Despite the new clues, they were not able to get a crystal-clear image of the killer's face. They are hoping someone in the public can identify the suspect. The suspect is a black male and police believe that he's associated with the Gangster Disciples street gang in Kansas City, Kansas.

Jennifer vanished on January 24, 2006 in Orlando, Florida on her way to work. Surveillance video shows a person of interest near her car the morning she went missing. Jennifer's car, a 2004 black 4-door Chevrolet Malibu with the Florida tag H90KYC, was recovered on January 26, 2006 about one mile from her Orlando condo. Authorities believe she may have been carjacked and abducted. Jennifer is an outgoing friendly young woman who has bright green eyes and a tattoo of a shamrock on the small of her back. ## **CAPTURED:**

**Arnulfo Vargas aka L.A. Riverbed Rapist** (Sexual Assault, Felony Rape) -- They call him "The Riverbed Rapist" because this serial rapist comes out of the darkness of the night to kidnap and rape unsuspecting women in the shadow of the Los Angeles River. He's been connected to seven rapes over the past three years. Now police say they know who he is: Arnulfo Vargas, 35, a part-time construction worker. The LAPD says Vargas targets women at bus stops or walking alone, then approaches his victims in his pickup truck and offers them a ride. Once these women are inside the vehicle, Vargas drives them to a secluded location and rapes them. On several occasions, Vargas drove off leaving his victim naked and alone after assaulting them. Police say they became suspicious of Vargas in September, after they got a tip from a victim who managed to get a partial license plate number. Vargas was later pulled over, questioned and later released due to lack of evidence. Then, Vargas, his wife and young child disappeared. Police searched Vargas' home where they obtained the DNA evidence they needed to charge him with the series of rapes. (See Shows #784 and #792, OADs 11/06/04 and 1/22/05) An AMW viewer tip lead authorities to Ensenada, Mexico. Working closely with Mexican authorities, Vargas' was eventually captured in November, 2005.

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Daniel William Hiers** (Criminal Sexual Conduct with a Minor) -- Local and federal officials are searching for Daniel Hiers. Hiers was supposed to turn himself in on March 15, 2005 after warrants were signed for his arrest charging him with criminal sexual misconduct with a minor and committing a lewd act on a minor. Hiers is accused of sexually assaulting a 9-year-old girl he met at a karate center in West Ashley, South Carolina. The former school resource officer is accused of sexually assaulting the girl at her house and in his car. North Charleston police arrested Hiers in late November, but he was released from jail on a \$25,000 personal recognizance bond. However, when he was supposed to show up for his prearranged surrender, Hiers vanished. When Hiers didn't show, his mother went to his house to check on him and saw her daughter-in-law's lifeless body in the bedroom. Ludimila Hiers had been shot in the back of the head sometime between 7 and 12 am. Police have not charged Hiers with the murder of his wife, but they are calling him an "extreme person of interest." Hiers met Ludimila, on a trip to Brazil in 1994. She was 14 at the time, but they married when she turned 18. From 1993 to 1998, Hiers was a certified firefighter for the Town of Hampton. He was also a police officer for the Town of Hampton, his first job in law enforcement. After leaving Hampton as an officer, Hiers worked at the Town of Allendale Police Department and then for the Charleston Police Department. Daniel William Hiers has blue eyes and blonde hair. He may speak Portuguese or Spanish. He began to gain weight before his disappearance so he may be much heavier than any of his pictures. He may have colored his hair and may have grown a beard. There's a good chance that he's in Mexico but there were unconfirmed sightings in Toronto. Hiers is 33, 6'2" and 190 pounds. (See Shows #800, #804, #826, #831 and #835, OADs 3/26/05, 5/14/05, 11/12/05, 12/17/05 and 1/28/06)

**Patrick Anthony Brown** (Murder) -- Police in Boston, Massachusetts have spent more than ten years trying to hunt down a cold-blooded killer with a quick temper. Patrick Brown

stabbed Zandera Sullivan to death after an argument about a woman. When Brown found out Zandera was dating his ex-girlfriend, Brown flew into a jealous rage and murdered Zandera. Zandera Sullivan's family has experienced their fair share of heartache and tragedy. Two weeks before Zandera's death, his father was shot and killed. Patrick Anthony Brown, who is also known as Derrick Mollay, might have a mustache or a goatee. Brown is 31, 6'0" and 200 pounds. (See Show #818, OAD 8/20/05)

**Juan Carlos Martinez** (Rape, Kidnapping) -- Police in North and South Carolina say that on the morning of May 13, 2005 Juan Carlos Martinez kidnapped a 19-year-old female and her boyfriend at gun point from outside their home. The couple was taken to an apartment in Mint Hill, North Carolina where the male victim was released. The female victim was released soon after but not before Martinez raped her. Martinez was charged with two counts of kidnapping in South Carolina and two counts of kidnapping and one count of rape in North Carolina. Martinez has a tattoo of an Aztec symbol on his shoulder and may have grown a goatee. He frequents Mexican bars and may be working in construction. Police believe that he may be in the Carolinas, but some tips have placed him in Florida, Texas, Arizona and Idaho. Martinez has been known to carry a semi-automatic 9mm handgun. Police believe he has ties to the MS-13 gang. Martinez is 34, 5'11" and 185 pounds.

**Morris Tyrone Jackson** (Attempted 1<sup>st</sup> Degree Murder, Unlawful Flight) -- Morris Tyrone Jackson has spent the past three decades of his life as a fugitive. It all started on June 11, 1976, when a social worker and detective paid a visit to the Jackson residence in Florida to follow-up on allegations that he was sexually abusing his children. Jackson was in the middle of a fantasy game with his stepdaughter when they arrived that day. When the nine-year-old girl answered the door, she was wearing a blond wig, and her bra was stuffed with tissue. Detectives immediately started questioning Jackson, and planned to arrest him. During questioning, Jackson allegedly grabbed a revolver and shot the detective. After a short gunfight, Jackson took off and headed for the woods. The wounded detective was rushed to the hospital, and later recovered from his injuries. Jackson's family told police that Jackson was shot during the gun battle, and probably died in the woods. Police believe that Jackson is still alive, living as a fugitive. Morris Jackson uses the aliases Jackson Brown, James Alan Harris, James Allen Harris Jr., Walter Lee Jackson, Joe Williams and the nickname "T-Ball." Jackson walks with a cane, speaks with a stutter and has a metal plate in his head. He's missing some of his upper teeth and has a deformed pinky finger on his right hand. He has a large scar over his nose and his left eye. Police think he could be living somewhere in Florida, and might be seeking work in migrant communities. Jackson is 61, 5'9" and 165 pounds. (See Show #825, OAD 11/05/05)

**Miguel Angel Sanchez** (Murder) -- Police in California are trying to track down Miguel Sanchez. On July 30, 2003, Sanchez allegedly shot and killed Eduardo Castellanos after the two argued over debt. According to authorities, Sanchez and Eduardo had fought earlier in the month about money that was owed on a truck. Eduardo's father owed Sanchez's father-in-law money and when Sanchez and his father-in-law came to collect the cash, things got out of hand. Sanchez and Eduardo started fighting, throwing punches left and right. The fight was broken up and Sanchez threatened Eduardo. Later, Eduardo's father decided to return the truck to settle the debt. Eduardo followed his father in another car and parked at a nearby corner to wait for his dad. But, before the two could leave, Miguel Sanchez ambushed Eduardo and shot him three times. Sanchez

hasn't been seen since. Sanchez, who is as known as Miguel Angel Gagea, may have a shaved his mustache and his head. Sanchez is 30, 5'4" and 180 pounds. (See Show #826, OAD 11/12/05)

**Larry Dean Castaneda** (Murder) -- This severely troubled repeat offender murdered his father in Sacramento in 1990. The father had let Larry hide in his house for a number of months following a parole violation. Known by the nickname "Mad Dog" due to his paranoid personality and violent temper, he is described as a "walking pharmacy" because he takes pills for epilepsy and depression, and uses cocaine and marijuana. He has twelve tattoos, including a beast on his back, a rattlesnake on his right biceps and lightening bolts on his forearms. He probably maintains an unkempt look with a full beard. He has dark hair and eyes, is 55, 5'8" and 180 pounds. (See Shows #220, #420 and #533, OADs 7/3/92, 8/3/96 and 3/13/99)

**Unknown Deputy Maria Rosa Killers** (Murder) -- Police in Lon Beach California are puzzled and saddened at the loss of one of their own Los Angeles County Sheriff's Deputy Maria Cecilia Rosa. On the morning of March 28<sup>th</sup>, Deputy Rosa was senselessly gunned down in front of the home of a longtime friend and fellow officer, Sheriff's Deputy Jenny Martin. Deputy Rosa's body was found lying in the driveway by a newspaper deliveryman. Her handgun was out, but had not been fired. She was dressed in jeans and a sweatshirt and appeared to be on her way to work at the Los Angeles County Jail. Based on the fact that she was dressed in street clothes, there did not seem to be any evidence that her killers could have known she worked in law enforcement. Authorities believe that Deputy Rosa was approached by two assailants in their late teens who were riding their bikes in the area around the time of the shooting. One of the suspects was seen wearing a black hooded sweatshirt. One of the bikes, a Giant brand "Frantic" kids' bike, was found abandoned near the scene and investigators are seeking information about its owner. Suspect #1 is a Hispanic male. He has a dark complexion, a Fu-Manchu style mustache and is roughly 20 years old. Witnesses say that he wore a black or dark blue hooded sweatshirt with the hood pulled over his head. He also wore dark pants, black boots, and a glove on one hand. He was riding the kids' bicycle. Suspect #2 is a Hispanic male. He has a lighter complexion and has a bald head with a thin mustache. He's 5'10" and roughly 160 lbs. Witnesses say that he wore tight fitting clothes on his upper body and rode a ten-speed or mountain bike. Both men were captured in photos by a bank surveillance camera approximately 25 minutes prior to the shooting. The blurry photos show both men riding the bicycles as described above. They were also seen by a witness from the neighborhood just minutes before the shooting on Eucalyptus Avenue, the street where the Deputy Rosa was killed. Police report that just minutes after the shooting, witnesses reported seeing someone abandon the kids' bike and as he ran away from the scene of the crime.

**Richard Lee McNair** (Escape) -- Police are searching for Richard McNair, a convicted killer who escaped from a Pollock, Louisiana prison on April 6, 2006. The 47-year-old fugitive was serving a life sentence for killing a trucker in North Dakota when he escaped. McNair hid in a prison warehouse and then escaped by riding out in a mail van. McNair is an extremely dangerous ex-soldier who is skilled in martial arts. He has scars on his left wrist and on both knees. McNair is 47, 6'0" and 210 pounds.

**Marlon Morris (Rape)** -- On November 18, 2002 Morris allegedly raped a thirteen girl for over two hours. Morris disappeared from a Massachusetts court house just before the jury returned its verdict, finding him guilty on seven of the nine charges he was facing. Morris has a very distinctive mole between his eyebrows, a small scar above his cheekbone and a scar under his left eye. Police believe that he may be going by the nickname "Remi" and may hiding in the Bronx or Brooklyn areas with the help of relatives. Morris is 29, 6'1" and 170 pounds. (See Show #838, OAD 2/18/06)

**CAPTURED:**

**Kenneth Glenn Hinson (Kidnapping, Sexual Assault)** -- Kenneth Hinson, a convicted sex offender, was captured on Friday, March 17, 2006 - just four days after he went on the run. Hinson allegedly abducted the two girls from their mobile home on the night of Monday, March 13, 2006. Police say Hinson quietly abducted the girls one at a time, bringing them to his hidden underground 5-by 8-foot room. The dungeon-like room was where Hinson bound the girls with duct tape and sexually assaulted them one at a time. After the assault, he left the girls bound in the hidden room. Fortunately the girls managed to open the trapdoor and escape. Darlington County police, U.S. Marshals and members of the South Carolina Law Enforcement Division captured Hinson after receiving a tip from a 9-1-1 caller.

**Michael Paul Astorga (Murder)** -- Michael Astorga was already a wanted man when he shot and killed Deputy James McGrane, a member of the Bernalillo County Sheriff's Department. Now authorities say he's an FBI Top Ten Fugitive and one of the most hunted men in the world. On the night of March 22, 2006 on a rural highway in New Mexico, Deputy McGrane pulled over a pickup truck occupied by three men. It is unclear why Deputy McGrane stopped the truck or what he said to the occupants. However, what authorities are clear about is that Michael Astorga was in the vehicle and they believe he shot McGrane in the head with a 10mm glock. Astorga is no stranger to the law. He is currently on probation after serving time for selling drugs, stealing cars and other property crimes. In November 2005, just a few months before McGrane's murder, Astorga shot and killed a long-time enemy named Candy Ray Martinez. (See Show #844, OAD 4/01/06) After 12 days on the run, Astorga was apprehended in Juarez, Mexico

**Richard Lee McNair** (Escape) -- Police are searching for Richard McNair, a convicted killer who escaped from a Pollock, Louisiana prison on April 6, 2006. The 47-year-old fugitive was serving a life sentence for killing a trucker in North Dakota when he escaped. McNair hid in a prison warehouse and then escaped by riding out in a mail van. McNair is an extremely dangerous ex-soldier who is skilled in martial arts. He has scars on his left wrist and on both knees. He has an infected molar that has lead to a sinus infection. His bad allergies may have flared up since he's been wandering around in the woods. McNair is 47, 6'0" and 210 pounds. (See Show #845, OAD 4/08/06)

**Ronald Fischer** (Escape) -- Authorities in East Greenwich, RI are on a nationwide manhunt for Ronald Fischer. Fisher is a wealthy Rhode Island doctor and a convicted rapist. Fischer started placing personal ads on-line in 1992 after he got divorced. According to officials, in 1994, Fischer was charged with meeting a woman on-line and raping her aboard his yacht, "The Lion King." Fischer was arrested and pled guilty to lesser charges to avoid jail time. In 2003, he met a college English professor on-line. He invited her to his yacht and wooed her with drinks and dinner. However, the romantic date soon took a dangerous turn. Fischer forced himself on the unsuspecting woman and raped her in the bedroom aboard his yacht. Fischer was arrested, charged and his case went to trial in 2005. However, midway through the trial, Fischer sent an e-mail to his attorney, telling him he was leaving the country. Fischer hasn't been seen or heard from since. A jury convicted him in absentia of two counts of first-degree sexual assault and one count of second-degree sexual assault, meaning that the former anesthesiologist could face up to life in prison. Fischer is an intelligent man who is Ivy League-educated and had an impressive career as a doctor. He was chief of the ob/gyn anesthesia department at the Rush University Medical Center in Chicago and chair of the anesthesiology department at Pawtucket's Memorial Hospital in Rhode Island. He also held the rank of an assistant professor of

anesthesiology at Brown University Medical School. Fischer has plenty of money and lots of worldwide connections. Fischer's victims say that he has a pock-marked face, a bad comb-over, a fiery temper and described himself as "handsome, blue-eyed and loveable" in the personal ads he posted on websites and in newspapers throughout the New England area. Fischer is balding and has red hair that may appear blond. Fisher enjoys playing computer chess, playing tennis, and working out with a trainer. He also enjoys boating and spending time on the water. Authorities believe he may be hiding out in a marina. People who know Fisher say that he passionately denounces France for not supporting the war in Iraq. Fischer is 50, 5'10" and 180 pounds. (See Show #804, OAD 5/14/05)

**Phoenix Serial Shooter(s)** (Murder, Attempted Murder) -- Phoenix police believe that a serial shooter or shooters may be responsible for 10 unsolved shootings, including three murders. On December 30, 2005 there was a rash of random shootings that targeted animals and people. By the next day, 3 dogs were dead, one man was shot in the back of his neck, one more was wounded and two people lay dead. Since that night, police have discovered that these and other shootings dating back to June 2005 support the theory that Phoenix may have a serial shooter, or shooters, on its hands. Investigators are asking for the public's help, hoping that the person or people responsible may have bragged about the incidents to someone that can help further the investigation. Police believe that the shooter(s) may have used an unusual combination weapon that uses small caliber bullets and shot gun shells. Some witnesses believe that the assailant(s) are driving a dark colored mid-1990's sedan - possibly a Honda.

**Bruno Arreola** (Conspiracy to Distribute Marijuana) -- The U.S. Marshals Service is trying to track down Bruno Arreola. They say he was part of a sophisticated drug operation that smuggled more than one thousand kilos into the U.S. Marshals say Arreola obtained marijuana in Mexico and smuggled it into the U.S. through San Diego, California. Then, the illegal drugs were shipped to Long Island, New York in tractor trailers. The marijuana shipments were delivered to a warehouse near Islip's MacArthur Airport, where they were retrieved and transported for local distribution. Through investigation, authorities seized two tons of marijuana and more than \$11 million in cash. The seized marijuana was estimated to have a street value of \$19 million. In 2003, Arreola was arrested by authorities in Las Vegas, Nevada. At the time of his arrest, Arreola had a fake ID. Arreola was released on bail and ordered to appear in court in New York on February 4, 2003. Arreola has not been seen since his release. Arreola is 47, 5'11" and 225 pounds. (See Show #824 and #829, OADs 10/01/05 and 12/03/05)

**Lewis Lee** (Custodial Interference, Unlawful Flight) -- Police say Lewis Lee, a former pastor, grabbed 15-year-old Elizabeth Thomsen and went on the run. Elizabeth became the target of this child predator when her relationship with her parents became strained. Elizabeth's parents questioned the attention Lee was giving their daughter and had him arrested for stalking and trespassing after he was caught peering into Elizabeth's window. As part of his arrest, Lee was banned from communicating with Elizabeth. Later, Lee relocated his family to Maryland. Regardless of the law and the distance between them, Lee continued to call Elizabeth on a daily basis. During these calls, police believe Lee and Elizabeth made a plan to run off together. Police say the two have been on the run since March 18, 2006. They have been traced to Sevier County and also other rural areas of east Tennessee. The Saturday before Easter, Lee was seen dropping

off five Easter baskets at a female relative's house in Maryland, about 45 minutes drive from Interstate 95. Lee is 54, 5'10" and 185 pounds.

**Hassan S. Simmons** (Murder) -- Police in Philadelphia say that when Hassan Simmons lost a street fight, he pulled out a gun and shot 17-year-old Terrell Johnson to death. Police believe he may still be in Philadelphia, but he also has ties to South Carolina. They also believe that he still may be armed. Simmons is 20, 6' and 160 pounds.

**Anthony Quick** (Grand Theft) -- Anthony Quick has already been convicted of 26 counts of Grand Theft and one count of Fraud for scamming unassuming elderly victims. Today officials say he's at it again, and this time, he's on the run. In 2004, an eighty-three year old female victim, Rose, was told her husband had terminal cancer. Shortly after hearing the devastating news, things just got worse. Rose went to a local market to pick up some groceries for her ailing husband. When she got back to her car, she noticed that her door was not completely closed. As she struggled to shut the door, Anthony Quick approached her and offered to help. Quick claimed that he was in the auto mechanic business and could help her, but the part needed to fix her door was \$4,250.00. Rose immediately became upset and confused and told him that her husband was very sick, and she needed to get home to take care of him. Quick offered to fix her car immediately if she could come up with the cash. Quick instructed Rose to drive to a local bank branch to get the money. Once he had the money, he put on a glove, pulled at the door, thanked Rose for money and took off. He hasn't been seen since. Anthony Quick has a tattoo of the name "Samantha" on his left arm and a tattoo of praying hands on the left side of his chest. He has green eyes and black hair. Quick is 42, 5'9" and 170 pounds. (See Show #818, OAD 8/20/05)

**Feature:** AMW went along with Suffolk County Police's Computer Crimes Unit as they set up a sting designed to capture suspected online predators.

**Waqas Rehman** (Molesting a Minor) -- Nicole was just 12-years-old when she met 27-year-old Waqas Rehman who police say called himself "Michael" online. Nicole had embellished her profile, claiming to be 15 rather than 12, but their major age difference didn't stop Rehman from setting up a real-life meeting with the preteen. On August 4, 2004 Nicole secretly agreed to meet Rehman in a parking lot after her mother, Jamei, left their home to run errands. Once in his car, Rehman began to compliment Nicole and then began to fondle her, touching her chest and thighs and even forcing her to sit on his lap in the backseat. Nicole was clearly shaken after their encounter, but Rehman was able to convince her to meet again and assured her that nothing else would happen. Just three days after the first attack, Rehman drove Nicole to his apartment where he molested her for a second time. Jamei questioned her daughter after the attack but, an embarrassed and frightened Nicole could not tell her mother the truth. Jamei knew something was terribly wrong and asked her older daughters to search Nicole's computer - what they discovered shocked them. They found Nicole's e-mail and IM mail conversations with Rehman. The women went to the police with the information they'd found and on September 9, police charged Rehman with several counts of lewd and lascivious acts on a minor. Rehman failed to appear in court on November 29, 2004 and has been on the run ever since. Rehman is of Pakistani descent and speaks with a heavy Middle Eastern accent. He has family in California and may be working in a fast food restaurant. Rehman is 30, 5'9" and 170 pounds.

**Richard Lee McNair** (Escape) -- Police are searching for Richard McNair, a convicted killer who escaped from a Pollock, Louisiana prison on April 6, 2006. The 47-year-old fugitive was serving a life sentence for killing a trucker in North Dakota when he escaped. McNair hid in

a prison warehouse and then escaped by riding out in a mail van. McNair is an extremely dangerous ex-soldier who is skilled in martial arts. He has scars on his left wrist and on both knees. He has an infected molar that has led to a sinus infection. His bad allergies may have flared up since he's been wandering around in the woods. Marshals believe McNair may have cut his goatee and dyed his hair blonde. McNair is 47, 6'0" and 210 pounds. (See Shows #845 and #846, OADs 4/08/06 and 4/15/06)

**Michael Dale Benson** (Escape) -- Michael Benson escaped from the St. Peter Regional Treatment Center in St. Peter, Minnesota on April 15, 2006. Benson used hacksaw blades to saw through a steel and concrete window bar and then smashed an 8-by-14-inch hole through the security glass in his room. Benson and three other patients squeezed through the tiny hole, slid down a makeshift rope of bed linens and escaped from the facility. Three of escapees were back in custody within hours, but the manhunt continues for Benson. Benson had been in the treatment facility for more than 13 years and is a Level 3 sex offender, which police say is one of the worst types of criminals. Benson was civilly committed to the treatment center in 1993 after serving three and a half years in prison for breaking into a woman's home, sexually assaulting her, and threatening to kill her. Police consider Benson a person of interest in the 1987 disappearance of Vickie Sundgaard of Alexandria, Minnesota. Benson was one of the last people to see her and that he has even suggested that he was somehow involved in her disappearance. On April 24, 2006, police arrested Benson's father Dale Blue on charges of aiding and abetting his escape. Authorities say Blue sent his son a pair of boots with a hacksaw blade hidden in the sole. Hospital officials found that blade hidden in the air vent of Benson's room after his escape. Benson never called his father to show up at the bowling alley because one of the other escapees' parents showed up at the bowling alley for "getaway duty." Police say Katherine Hill, the mother of St. Peter resident Donald Hill, was likely waiting for the escapees when a police car showed up to investigate a suspicious person hanging out in the bowling alley parking lot. According to police, that suspicious person was Michael Benson. Another tipster called police to say Benson threw a bag of clothes into Katherine Hill's car. When the police arrived, Benson ran off and Katherine Hill drove away from the rendezvous spot. Officers spotted her car a short time later and pulled her over for questioning. Katherine Hill was arrested for DUI. Without a getaway vehicle, the escapees were left hanging - literally. After leaving his co-conspirators behind, Benson stole a forest green 1997 Crown Victoria with Minnesota license plate MXB801 on Easter morning. Police bloodhounds picked up his scent from the farm where the vehicle was stolen. In the days after the escape, there was one credible sighting of the stolen green Crown Victoria on April 17 in northern Minnesota near Bemidji. Michael Benson, who also known as Michael Dale Blue and Michael Robinson, has a tattoo of a small dagger on his right hand, an eagle and a peace tattoo on his right shoulder and a design tattoo on his left shoulder. He has psoriasis and eczema on his hands and feet that requires anti-itch medication. He is described as being a very intelligent man who is an avid chess player. He may have shaved his head and face to change his appearance. Police say that he is very dangerous and is likely to strike again. Benson has friends and family on Indian reservations in Minnesota. He is 42, 5'11" and 170 pounds.

**Derrick Lloyd** (Murder) -- Derrick Lloyd is wanted for murder in Brooklyn, New York. Lloyd got into a fight during a New Year's Eve party in 1991 and fatally shot William Smith in the face. After the shooting, witnesses say that Lloyd nonchalantly went back to the party, retrieved his coat and has not been seen since. Lloyd was released on parole in late 1990 after

-serving seven years for killing another man. Lloyd, who also goes by the name Abdul Azziz and Darryl Cunningham, has very distinct light green/hazel eyes and has freckles on the bridge of his nose, cheeks and near his eyes. When Lloyd was in jail he became a Muslim and may be practicing Islam. He is 45, 6'0" and 220 pounds.

**Unknown Child Molester/Internet John Doe #5** (Child Pornography) -- The FBI needs your help again to identify this child predator. You have already identified four of these unknown child predators, and they are hoping you can help them find this man. Agents say they've found disgusting online images of this man abusing children. Based on those images, they've obtained a "John Doe" warrant charging the unidentified man with transporting child pornography images over the Internet. The FBI has released an image of his face, and want to put him behind bars before he hurts any more children. Internet John Doe #5 has a distinctive mole on the left side of his face. (See Show #792, OAD 1/22/05)

**Joseph Jermaine Woodbury Jr.** (Drug Possession) -- Police in South Carolina are looking for Joseph Woodbury. They say he is a cocaine dealer with a long record of violent crimes. In addition to the drug charges, they want to question him about the murder of his friend Ricky Lamar Cook. Woodbury has a tattoo of a pitbull on his back and a tattoo of a cross on his inner forearm. He is 32, 5'4" and 135 pounds.

**Warren Villalta** (Murder, Failure to Appear) -- Warren Villalta is accused of shooting 21-year-old Richard Denson to death in November 2003 and intimidating witnesses. Villalta has been hiding out in different places since the murder. Police believe Villalta stayed in a hotel in Fairfield, N.J. before moving to the Bronx. In 2004, he was spotted in Willimantic, Connecticut working in construction and in Puerto Rico in 2005. Villalta has family members in Elizabeth and Newark, N.J and authorities believe that he may be back in the Bronx. No matter where Villalta is, police believe he is probably picking up girls at bars and clubs and smoking marijuana. Villalta has his street name, "Buck", tattooed across his stomach. He is 26, 5'10" and 150-180 pounds.

**George Joseph Munoz** (Escape) -- San Diego Sheriff's Department is currently searching for two inmates who escaped on April 22, 2006 from the George Bailey Detention Facility in San Diego, California. Joe Morales, George Munoz and Mark Estrada were able to break through a fence located on the facility's south side. US Border Patrol were able to nab Estrada the next day, but the manhunt continues for Joe Morales and George Munoz. George Munoz was behind bars for kidnapping with intent to commit a sex crime and three counts of forced oral copulation. He is 31, 5'11" and 180 pounds.

**Dallas, Texas...OPERATION FALCON II FEATURE...**AMERICA'S MOST WANTED teams up with the U.S. Marshals Task Force for Operation FALCON II; a nationwide fugitive apprehension operation. **Colonial Heights, Virginia...CHRISTOPHER ADAMS...**Police in Colonial Heights, Virginia are looking for the sick man they say sexually molested two girls for almost four years. Christopher Adams' trial was scheduled for Mar. 29, 2005 but he never showed up and hasn't been seen since.

**Rowland Heights, California...DAVID LAM...**Although David Lam and his wife, Susan had been married for 25 years, cops say that were still arguing over the same problem -- David's disastrous gambling addiction. The couple was drowning in his debts, owing fifty thousand to just one of David's lenders. Officials say their argument on Sept. 12, 2005 drove David over the edge and that after he strangled her with a necktie, he buried her in their backyard.

**Greensboro, North Carolina...EVANGELINA VAZQUEZ...**Evangelina Vazquez is accused in the beating death of an eight-month-old boy she was babysitting. Cops say she's on the run with her own three-year-old child -- and they fear that child is in danger.

**Louisville, Kentucky...TOREE SIMS...**The Louisville U.S. Marshals are on the hunt for fugitive Toree Sims after he slipped through the cracks of a DEA nationwide round-up of his organization, the Black Mafia Family. The indictments

came down in October of 2005 and all the major players fell -- except Sims -- who cops say managed to get away.

**Mesquite, Texas...JOE AARON...**Joe Eugene Aaron is accused of sexually assaulting a 10-year-old boy who lived near him in Mesquite, Texas. AMW teamed up with cops on Operation FALCON II, and tracked him down in Fairfield, Texas. Days later, Aaron posted bond and is now a free man, awaiting trial.

**Dallas, Texas...CHARLES CAPDVILLE...**Charles Capdville is accused of sexually assaulting a girl. He allegedly saw the girl on a street, came up behind her, put her in a choke hold before dragging her into a house where he then sexually assaulted her. When AMW teamed up with cops on Operation FALCON II, they were able to positively I.D. Capdville as the assailant.

**Assumption Parish, Louisiana...LINE OF DUTY – JEREMY NEWCHURCH...**Sergeant Jeremy Newchurch of the Assumption Parish Sheriff's Department in Louisiana was shot to death by a suspect during a narcotics bust. When not in uniform, Sergeant Newchurch enjoyed cooking, playing golf, and coaching a local softball team. He leaves behind his parents, two brothers, and two sisters.

**Richard Lee McNair** (Escape) -- Police are searching for Richard McNair, a convicted killer who escaped from a Pollock, Louisiana prison on April 6, 2006. The 47-year-old fugitive was serving a life sentence for killing a trucker in North Dakota when he escaped. McNair hid in a prison warehouse and then escaped by riding out in a mail van. McNair is an extremely dangerous ex-soldier who is skilled in martial arts. He has scars on his left wrist and on both knees. He has an infected molar that has lead to a sinus infection. His bad allergies may have flared up since he's been wandering around in the woods. Marshals believe McNair may have cut his goatee and dyed his hair blonde. He recently was spotted in Canada. Police McNair is 47, 6'0" and 210 pounds. (See Shows #845, #846 and #847, OADs 4/08/06, 4/15/06 and 4/29/06)

**Marion Pegeses** (UAPF) -- Authorities in New York are looking for the remaining suspect in the murder of a New York police officer. Marion Pegeses is the alleged ringleader of a group of armed thugs who robbed a jewelry store in Freehold, New Jersey on August 26, 2005. Detectives quickly identified the members of the gang after reviewing surveillance images from the store's security system. While investigators hit the streets of Philadelphia, searching for Pegeses and crew, police say they were already out of town working on another job in New Hartford, New York. On February 27, 2006, Officer Joseph Corr responded to a robbery call at a local jewelry store. Officer Corr arrived at the store in time to engage in a high speed pursuit of one of two suspicious vehicles leaving the crime scene. The dangerous chase ended when the suspects' vehicle slammed into a gas pump. When Officer Corr caught up with the suspect, he was shot and killed. The beloved officer's murder sparked a massive manhunt for the gunman who was later identified as Walter Richardson. Investigators tracked down Richardson to his hideout in Philadelphia. When Richardson refused to go quietly, he was killed in a gun battle with police. Investigators learned that Richardson was a member of Pegeses' crew, and that

Pegeses himself, along with another suspect from the New Jersey jewelry store robbery surveillance video, were in the second getaway car. Police rounded up most of the crew but Pegeses is still on the run and hasn't been seen since the day of the New Hartford jewelry heist. Pegeses, who is also known as Billy Bump, almost always wears a beard but police believe he may have shaved it off. His body is covered with tattoos. Pegeses is 33, 6'2" and 190 pounds.

**Warren Jeffs (Sexual Conduct with a Minor)** -- The Arizona Attorney General's Office and the FBI began investigating reports of child abuse, domestic violence, incest and polygamy that stem from a powerful congregation called the Fundamentalist Church of Jesus Christ of Latter Day Saints (FLDS) and its leader, Warren Jeffs. According to the FBI, Jeffs took control of Colorado City ten years ago and over time started similar communities in Utah, Texas, and Mexico. Jeffs' teachings and sermons were designed to keep his flock loyal, unquestioning, and living in fear of reprisals. He also arranged marriages involving girls as young as 14. For years, law enforcement officials were unable to move against Jeffs since his followers refused to testify against him. His followers consider him a prophet and are determined to do anything for him. The FBI say that this devout allegiance raises possible comparisons to events like those in Jonestown or Waco, making Warren Jeffs a very dangerous man. Jeffs has been formally charged with sexual conduct with a minor and conspiracy to conduct sexual conduct with a minor. The FBI maintains that Jeffs has not been back to Colorado City in almost two years and may be hiding out at other polygamist communities in British Columbia, Texas, or Mexico. Now that Jeff has gone underground, authorities believe Jeffs' loyal followers are protecting him. Jeffs also had control of a \$200 million dollar trust, built from profits and tithes from the communities he controls. While the state of Utah has frozen Jeffs' assets, the FBI believes that he funneled money out of the trust. Jeffs may be surrounded by his followers dressed in their congregation's traditional fashion. Men are always clean shaven and wearing long pants and long sleeves. Women wear their hair very long and are always in dresses styled from the 1800s. Authorities say Jeffs is fascinated with Adolf Hitler and Nazism. He is 50, 6'3" and 155. (See Show #848, OAD 5/06/06)

**Orson William Black (Sexual Conduct with a Child)** -- Orson William Black was once part of the same FLDS community as the FBI's Most Wanted's newest addition, Warren Jeffs. However, Black broke away from FLDS practices in Colorado City, Arizona and began marrying multiple underage girls and sexually abusing them. Now, authorities believe that Black is in Mexico and they are looking to arrest this "prophet" who claims to speak directly with God. Black is 45, 5'10" and 185 pounds.

**Unknown Deputy Maria Rosa Killers (Murder)** -- Police in Long Beach California are puzzled and saddened at the loss of one of their own Los Angeles County Sheriff's Deputy Maria Cecilia Rosa. On the morning of March 28<sup>th</sup>, Deputy Rosa was senselessly gunned down in front of the home of a longtime friend and fellow officer, Sheriff's Deputy Jenny Martin. Deputy Rosa's body was found lying in the driveway by a newspaper deliveryman. Her handgun was out, but had not been fired. She was dressed in jeans and a sweatshirt and appeared to be on her way to work at the Los Angeles County Jail. Based on the fact that she was dressed in street clothes, there did not seem to be any evidence that her killers could have known she worked in law enforcement. Authorities believe that Deputy Rosa was approached by two assailants in

their late teens who were riding their bikes in the area around the time of the shooting. One of the suspects was seen wearing a black hooded sweatshirt. One of the bikes, a Giant brand "Frantic" kids' bike, was found abandoned near the scene and investigators are seeking information about its owner. Suspect #1 is a Hispanic male. He has a dark complexion, a Fu-Manchu style mustache and is roughly 20 years old. Witnesses say that he wore a black or dark blue hooded sweatshirt with the hood pulled over his head. He also wore dark pants, black boots, and a glove on one hand. He was riding the kids' bicycle. Suspect #2 is a Hispanic male. He has a lighter complexion and has a bald head with a thin mustache. He's 5'10" and roughly 160 lbs. Witnesses say that he wore tight fitting clothes on his upper body and rode a ten-speed or mountain bike. Both men were captured in photos by a bank surveillance camera approximately 25 minutes prior to the shooting. The blurry photos show both men riding the bicycles as described above. They were also seen by a witness from the neighborhood just minutes before the shooting on Eucalyptus Avenue, the street where the Deputy Rosa was killed. Police report that just minutes after the shooting, witnesses reported seeing someone abandon the kids' bike and as he ran away from the scene of the crime. (See Show #845, OAD 4/08/06)

**Isreal Or (Armed Robbery)**

**Yossi Hananiya Bensadon (Armed Robbery)** -- Israel Or and Yossi Bensadon allegedly posed as florists in order to con their way into an office in Manhattan and steal more than \$150,000 in cash. On February 23, 2003 officers responded to an armed robbery call at the Win Caf Carwash. A victim, Thalia Chin, described how two delivery men put on ski masks and forced their way into the office. Armed with a 9mm handgun, the men threatened to shoot Thalia before taking off with \$150,000. After her terrifying ordeal, Thalia was able to provide detectives with important details to help identify the robbery suspects. When the men came to the office door Thalia was able to see their faces before they put off their ski masks. She recognized the distinctive blue eyes and muscular build of one of the suspects. He had inquired about a job the week before. The second suspect has a slim build and an Israeli accent. The suspects were identified as Isreal Or and Yossi Hananiya Bensadon. Isreal Or is a bodybuilder who is very vain about his appearance. He has bright, light blue eyes and a tribal band tattoo on one of his biceps. Or is 30, 6'0"-6'1" and 210-220 pounds. Bensadon enjoys fishing and is known to use marijuana. He thinks of himself as a ladies man and goes to nightclubs regularly to meet women. He is a religious man and is well-versed in Jewish practices and customs. He has worked as a roofer in the past. He may be seeking work in construction. Bensadon is 33, 5'10"-6'10" and 180-185 pounds.

**Mark Anthony Petersimes (Absconding from Civil Commitment)** -- After serving 12 years for molesting a 5-year-old and a 7-year-old girl, Mark Petersimes was placed in the Wayback Halfway House, in downtown Dallas. On May 2, 2006, Petersimes cut off his electronic monitoring device and escaped from the halfway house. Police believe that it's only a matter of time before he assaults another young girl. Petersimes has two piercings in his left ear. He has a tattoo of a dragon on his on his upper left arm, a parrot on his upper right arm and a parrot on his left shoulder blade. Police believe that he will seek out locations near children. Petersimes is 46, 6'0" and 240 pounds.

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Larry Burns** (Murder) -- Burns is charged with the May 23, 1986 murder of his estranged wife, Vicki, and the attempted murder of his mother-in-law, Linda Oliver. At 8:00am that morning, Vicki Oliver Burns was upstairs at her mother's house. She looked out the back window and saw Burns approaching the house with a gun in each hand. Vicki called downstairs to warn her mother, who grabbed her gun and headed into the kitchen just as Burns blew off the back door with a shotgun. A shoot-out ensued between Vicki's mother, Linda, and Larry Burns. When one of Burns' guns jammed, Linda escaped out the front door to seek help. Burns went upstairs where he and Vicki exchanged fire. Burns finished off Vicki with two shotgun blasts to the head. Adding Vicki's weapon to his arsenal, Burns walked away from the crime scene in broad daylight, wearing one shoe. Burns has a gold front tooth, an unidentified tattoo on his right forearm, and probably bears a scar on his shoulder from the shootout. He is an experienced dog trainer and may be working at a kennel, or as a handyman or repairman. He has also worked as a laborer in the steel industry and for trucking companies, and has good mechanical skills. He is known to wear a beard and/or a mustache. He is an outdoorsman who enjoys fishing and hunting. He is very outgoing and social, with a distinctive hearty laugh. Burns is 55, 5'10, and 215 pounds. (See Shows #400, #547, #750 and #822, OADs 3/9/96, 6/19/99, 1/24/04 and 9/17/05)

**Byron Keith Perkins** (Violating Conditions of Supervised Release)

**LeaAnn Howard** (Persistent Felony Offender) -- Police say that LeaAnn Howard assisted her boyfriend's (Byron Perkins) escape from a Louisville-area jail on January 24, 2006. The day of his escape, Byron was granted a provisional release from jail to undergo critical medical testing for compatibility with his son, Destin, who is in desperate need of a kidney

transplant. Instead of showing up for his appointment, Byron fled with his girlfriend LeaAnn Howard. LeaAnn was out on bond for robbery and felony firearms charges. Aside from the charges she's currently facing, LeaAnn pled guilty to conspiracy to commit murder in 2002. Police say she borrowed a car and money from her mother. The car (a 1994 Blue/Green Crown Victoria with Kentucky plates 784BHS) has been reported stolen. Following national media coverage, US Marshals have confirmed an early March sighting of the pair in a small fishing village outside of Puerto Vallarta, Mexico. They are still together and are likely traveling through Mexico as hitchhikers. Byron has several small bald spots and scars on his scalp and has a metal plate at the top of his head from a childhood injury. He has numerous tattoos including a tattoo of a sunset and clouds on his left shoulder; a cross with a snake (that is covering up the names Byron and Angie) on his left forearm; a dagger on his right shoulder; a small heart in the middle of his thigh, and other unidentified tattoos above his knee, upper left arm, right forearm and upper right leg. Byron uses the aliases Keith Perkins and Eric Perkins. He dresses very neatly and always irons his jeans and t-shirts and wears bright white tennis shoes. He is 37, 6'3" and 240 pounds. LeaAnn is diabetic and is dependent on insulin. She usually wears her hair long and wears glasses. She always wears hiking boots, even at the beach. LeaAnn uses the aliases Leighann Howard, LeaAnn Spradlin, LeaAnn Alford and LeaAnn Perkins. She is 35, 5'7" and 120 pounds. (See Shows #842 and #843, OADs 3/18/06 and 3/25/06)

**Tampa Band-Aid Bandit** (Armed Robbery) -- Since December 2000, police in Florida have been scrambling to find the elusive bank robber they've nicknamed, "The Tampa Band-Aid Bandit." For a couple of years, the robber wore a bandage on his left cheek. Florida Department of Law Enforcement officials say this bandit and his partner in crime have robbed about 38 banks in more than five years. Authorities say they have stolen over \$500,000. FDLE is assisting dozens of police agencies and banks through the creation of a task force established in 2003. They share information regularly to try to keep on top of the bandit's MO, disguise and other details that may help solve the crime. The Tampa Band-Aid Bandit was active from the end of 2000 to late 2003. Then after laying low for nearly a year, the bandit struck a couple of times in late 2004 and again in February, May, October and December of 2005. Detectives have become more concerned with the robber's demeanor after his February 17, 2005 hold up in an Inverness bank. Tellers described the suspect as outspoken, bold and demanding. While asking for money, the Band-Aid Bandit waved his pistol around and pointed it at customers. While no one was injured, the robber appeared more desperate. He wore his trademark wig and bandage. Detectives say his take was \$14,000. In the earlier robberies the Tampa Band-Aid Bandit appeared calm and cool, and most of the hold ups were low-key. However his more brazen tactics have police worried that future robberies could escalate into violence. The FDLE task force still remains unsure if the robber lives in Florida or travels through the state to target banks. Detectives believe the suspects use different getaway cars, possibly stolen vehicles and/or tags during the hold ups. The Band-Aid Bandit uses various disguises including a fake mustaches, baseball caps, wigs and sunglasses. He is known to carry a large flashy silver revolver. The Band-Aid Bandit is described as a middle-aged Hispanic man weighing between 200 and 300 pounds, with discolored skin on his hands and forearms.

**Pedro Peralta** (Murder) -- On April 15, 2006 Pedro Peralta confronted neighbors who were playing loud music outside of his mobile home in Enigma, Georgia. Peralta flew into a rage and shot three people, killing one man. Pedro Peralta uses at least two different aliases and has government documents issued under these names Efram Yanez and Lazaro Lopez Benitez. Peralta is described as a quiet man who becomes an intolerant and violent person when he drinks. Peralta has worked at a mobile home factory and may be in Texas or Illinois. He is 40, 5'8" and 160 pounds.

**Darnell William Randle** (Armed Robbery, Assault with a Deadly Weapon, Grand Theft) -- Police in California say that Darnell Randle belongs to a gang that has pulled off a series of jewelry store heists in the Bay Area. Randle and his partner Christopher Hodges robbed Kern's Jewelry store on February 8, 2006 and got away with \$200,000 in merchandise. Police believe that Hodges, Randle, and others in this ring are responsible for robberies starting back in February 2006. Although no one has been killed, the ring as a whole has been getting increasingly aggressive and violent. Hodges has been captured but Randle is still on loose. Darnell Randle, who is also known as Darnell Hodges, has tattoos of the letter "D" and "Hodge" on his body. Police believe he may have changed his appearance by cutting off his dreadlocks. Randle is 19, 6'3" and 200 pounds.

**Darnell Mallory** (Drug Trafficking, Firearm Possession) -- Marshals in Louisville, Kentucky are looking for Darnell Mallory. In March of 2005, federal indictments identified Mallory and 20 other defendants in a drug trafficking ring that had been terrorizing their city. Federal agents say the 21 individuals used guns to push and sell crack, heroin, cocaine and large quantities of marijuana. They say the drug ring began in August of 1999 and continued all the way up until the indictments being issued in 2005. Marshals rounded up most of the defendants immediately, but Mallory slipped through the cracks. Police in the Detroit suburb of Southfield came close to nabbing Mallory after he led them in a dangerous high-speed chase in October 2005. Mallory wrecked his rental car, flipping and totaling the 2006 Dodge Charger. Although Mallory was injured, he still managed to get away. He hasn't been seen since. Mallory's past criminal history includes trafficking in marijuana, drug possession, burglary, receiving stolen property and even possessing cocaine within 100 yards of a school. There's even an outstanding weapons warrant for Mallory under one of his favorite aliases, Terrance Moore. Investigators warn that Mallory likes to misspell his name when he is arrested, to avoid being identified. They say that he uses dozens of variations of his own name as aliases which include Terrance Moore, Darnail Alan Mallory, Darnal Mallory, Darnail Allen Mallory, Darneil Allen Mallory. Marshal say he's armed and dangerous and that he always carries a small loaded handgun. Mallory, who goes by the street name "Tiger" is short in stature and has scars all over his stomach and chest. He likes luxury vehicles and Timberland boots. He is from Detroit, Michigan and still has family there. Marshals think he may be returning to Motown frequently. He is 26, 5'4" and 145-165 pounds.

**Paul Herman Clouston** (Parole Violation, Failure to Register as a Sex Offender) -- The U.S. Marshals Service and police in Virginia are on the lookout for Paul Clouston. Clouston is a convicted cop killer and child molester who skipped town after violating his parole. Clouston's a heavy smoker who has bad eyesight and takes medicine for an enlarged prostate Clouston is



described as a charming old man. He is a competent handy man who likes to work on kids' bicycles. He is known to stay in hotels, churches, and shelters and hangs out around fast food restaurants drinking coffee. He hates the police and is known to brag about killing a California police officer. He speaks fluent Spanish. Clouston has used the aliases Herman L. Clouston, Herman Cloisten, Herman Anthony, Michael Paul Drago and Ray Randolph. Police believe he's headed west. Clouston is 70, 6'0" and 185 pounds.

**Amber Marie Harris Killer** (Murder) -- More than five months after 12-year-old Amber Harris vanished while walking home from a school bus stop; police recovered Amber's skeletal remains from a shallow grave in Hummel Park. Authorities were tipped off to a location in the park on May 11, 2006. Twelve-year-old Amber Harris was supposed to go straight home from school on November 29, 2005. Police believe she was intending to do just that when she mysteriously disappeared. A little over two months after Amber disappeared, her backpack was found about a mile and a half from where she disappeared. It contained a notebook with Amber's name on it, but authorities are conducting forensic tests for confirmation. The backpack was delivered to the Omaha crime lab, but no new information has been released by police since it was found. (See Show #834, OAD 1/21/06)

**Mark Anthony Petersimes** (Absconding from Civil Commitment) -- After serving 12 years for molesting a 5-year-old and a 7-year-old girl, Mark Petersimes was placed in the Wayback Halfway House, in downtown Dallas. On May 2, 2006, Petersimes cut off his electronic monitoring device and escaped from the halfway house. Police believe that it's only a matter of time before he assaults another young girl. Petersimes has two piercings in his left ear. He has a tattoo of a dragon on his upper left arm, a parrot on his upper right arm and a parrot on his left shoulder blade. **Proboodat Joucoo** (Attempted Murder, Assault) -- Gaytri Collet came to New York from Trinidad with her husband Proboodat Joucoo in 1996. Gaytri says her time in the U.S has been anything but good for her and her family. From the moment she arrived here, her husband began abusing her. In fact, New York police have arrested Joucoo a number of times for allegedly assaulting Gaytri in front of their five kids. Gaytri eventually had a protective order taken out against her estranged husband. Despite the protective order, Gaytri continued to stalk the family. Nevertheless, on May 20, 2005, Gaytri thought she may have a brief respite from his antics. She planned a birthday party for one of her kids inside their Brooklyn apartment. But just as the party was getting started, Joucoo barged into the apartment and disconnected the phones. Then, in front of all five kids, Joucoo took a machete out of his bag and began viciously slashing Gaytri with the machete. After the brutal attack, Joucoo nonchalantly walked out of the apartment building and hasn't been seen since. Although doctors were able to save Gaytri's life, her entire family is still living in fear. Proboodat Joucoo is extremely aggressive with everyone he meets. He likes to play pool, exercise, and his favorite beer is "Hurricane" malt liquor. He has worked as a courier, a videogame salesman and in construction. He has ties to almost every state in the U.S. Joucoo is 48, 5'5" and 175 pounds.

She was the type of kid who would call home if she was going to be just a half-hour late, which makes it even harder to understand why this honor-roll student and certified "good girl" would simply leave without telling a soul. Her father was the last person to see her, when she left for school with the \$30 he gave her to get an oil change. They're trying to figure out if she ran away, was abducted, or simply got into some kind of back road accident. All they have to go on is that she stopped by an ATM and a Premium gas station at about 10:30 in the morning on March 8, 2006. No leads have emerged since. She didn't get the oil changed in her black Volkswagen Golf. She didn't go to school. And Laura MacKenzie failed to appear for a court date for a felony shoplifting charge. She was slated to be arraigned in Manchester District Court on the same day she disappeared. The shoplifting charge stems from an arrest in Manchester, New Hampshire, where police picked Laura up for allegedly stealing \$900 worth of clothes from Filene's Basement in the local mall. Her brother posted her \$500 bail, and her parents had no idea that Laura had been arrested until police told them later during their investigation. If any of her friends know what happened to Laura, they're not saying. Her 17-year-old boyfriend had dinner with Laura and her parents the night before she vanished, but tells police he has no idea what happened to her. He's since been out of touch with her family, and his parents have since hired him an attorney. With no direct information to go on, police are hoping that anyone who knows anything about the case will provide the lead that could unravel this mysterious disappearance, and help bring Laura home. Laura was driving a 1995 four-door black Volkswagen Golf, license plate # 211 0126 with a Marines bumper sticker on rear.

## CAPTURED:

**Rafael Andres** (Grand Theft 3rd Degree, 1st Degree Murder, Burglary with Assault or Battery, Arson) -- On Sunday, January 24, 2005, a woman's dead body was pulled from a burning apartment in Miami-Dade, Florida. When detectives arrived at the scene, they discovered evidence which suggested that the woman was murdered prior to the fire. The victim was identified as 31-year-old Ivette Farinas. Police say she had been severely beaten and stabbed. An eyewitness provided detectives with a partial description of a man she saw leaving the victim's home the day of their murder. He was described as a tall man with bushy hair and a stocky build. When the description of the man ruled out Farinas' boyfriend as a suspect, they began to investigate a handyman named Rafael Andres after they learned he had keys to Farinas' home. According to investigators, Andres admitted he had been in Farinas' home, but said he had left to go to another job after replacing an electrical switch. When they looked into Andres' story, it didn't check out - there wasn't a replaced switch and Andres hadn't showed up at his next job.

Police believed Andres was Farinas' killer and began to obtain key evidence to prove their case. During an interview they took photographs of fresh bruises and cuts on Andres' hands and arms and collected DNA samples. Farinas' father gave police his daughter's bank statement which helped them to obtain evidence which proved that Andreas used the victim's bank debit card to purchase power tools at a Miami Home Depot days after her murder. Later, DNA results confirmed that his blood was on a bloody wash cloth that was found at the crime scene the day of the murder. By the time police were able to issue a warrant for Andres' arrest, he was gone. Andres has a birthmark on the back of his neck and several tattoos including a joker and the word "Gorila" on his back; a Latin Kings gang symbol (a crown) on his chest; a shark on his right arm and a snake tattoo on his left arm. Andres is a handyman who likes to gamble and is known to use cocaine. He doesn't like to show his tattoos when he works, so he usually wears a tank top with a long sleeved shirt on top. He has bushy hair and a stocky build. He may not like to talk about his past - he was charged with the first-degree murder of another woman in Miami in 1987. Andres is 41, 6'1" and 260 pounds. **Eric Rosenstrom** (Murder) -- Rosenstrom worked as a death investigator for the Dallas County Medical Examiner's Office and wrote crime novels in his spare time. He had an impeccable resume. He also liked to control situations, even during investigations, despite the fact that he wasn't a registered Sheriff's Deputy. Rosenstrom claimed to have played for professional football in Canada, but after a miserable performance in a practice game, the Sheriff began to have doubts about his employee. Upon further investigation, it was uncovered that Rosenstrom had fabricated his resume. Rosenstrom landed a job as a desk clerk at the Hunts Castle Hotel in Rockport, Texas. He worked his way up to general manager by using his people skills. He was fired from his position by the owner, Erik Lower, when he demanded payment for alleged back wages. Rosenstrom took refuge at the home of another employee who had been terminated, Mike Garland. Garland says that Rosenstrom laid out a detailed description of how he was going to kill Eric Lower. Garland also claims that Rosenstrom threatened his life in an attempt to keep Garland from reporting him. On August 16, 2001, Rosenstrom put his plan into action. Garland informed authorities that he believed a murder had been committed after he called the hotel and no one answered. Rosenstrom has not been seen from since. He may be passing himself off as a retired police officer or writer. Rosenstrom 45, 6'0" and 195 pounds. (See Show #838, OAD 2/18/06)

**Kevin Bruce Cooper** (Failure to Appear) -- Kevin Cooper wanted children, so he adopted two of his own and even tried to buy a child from overseas. But police say Cooper wasn't being charitable - he wanted these kids to fulfill his own sexual fantasies. Cooper was convicted of traveling overseas to have sex with a child and being in possession of child pornography images, but took off before serving his sentence. Deputy Russ Fields of the U.S. Marshal Service cautions that Cooper is extremely manipulative and easily evokes sympathy by telling stories of

his abuse as a child. Cooper has been known to get money and other assets by manipulating people with these stories. Police say their latest leads place Cooper somewhere on the West Coast - possibly even in Canada or Mexico. They have information that he has taken up surfing, and is currently traveling with a pet Chihuahua. Police believe that it's a matter of time before he finds another child to prey upon. Kevin Cooper, who is also known as "KBC," has both his earlobes pierced. He has several tattoos including a large angel on his upper left arm, a skull tattoo on his upper right arm, and the letters "RISN" and the outline of a sun and a bird on his upper back right underneath his neck. Cooper is very distinguished looking. He likes to wear stylish clothes that make him look younger, especially the brand Abercrombie and Fitch. He is a habitual marijuana smoker and may hang out in gay bars. Cooper is 41, 6'4" and 225 pounds.

**Sucha Singh (Murder)** --When Jagot Kaur's parents moved to the United States, all they hoped for was a better life, full of opportunity. Little did they know their lives would be shattered by a man they thought they could trust. In February 1994, Jagot Kaur's parents arranged for her to marry thirty-one-year-old, Sucha Singh, a local businessman in Dallas. Seven years into the marriage, Jagot Kaur realized her husband wasn't the man she or her parents thought he was. He had a violent temper, especially when he drank. So, Jagot decided she was tired of Singh's possessive nature and wanted out of the marriage. She filed for divorce and moved in with her parents. On July 25, 2003, three days after receiving divorce papers, Sucha broke into Jagot's apartment and assaulted her mother before brutally stabbing Jagot more than two dozen times. After the assault, Sucha he slid Jagot's wedding ring off her finger and took off. He hasn't been seen since. Sucha often wears a turban and almost always wears a gold bracelet on his left wrist. Police believe that he may be hiding in New York or Toronto. Sucha is 43, 6'0" and 200 pounds. (See Show #816, OAD 8/06/05)

**Jade Martin Young (Murder)** -- Police in Charleston, North Carolina are looking for Jade Young. Young is accused of shooting Floyd Rivers to death following an argument on May 13, 2005. Young, who goes by the nickname "New York," is a convicted drug dealer who may be working for a drug lord in the North Charleston area. Young likes to make jokes and is known to wear New York baseball caps and jerseys. Police say that he has ties to the Bronx and Columbus, Georgia. Young is 30, 5'11" and 220 pounds. (See Show #843, OAD 3/25/06)

**Juan Antonio Peña (Murder, Unlawful Flight)** -- Gregory Cuyler, a semi-professional boxer, was in for the fight of his life on April 10, 2005. Jose Antonio Peña, a man he knew only from hanging out at a local bar, would start an argument that ended in Gregory's death. Authorities thought they would get their man when Peña made arrangements to pick up a pair of gold teeth in New York, but he was tipped off and hasn't been seen since. Juan Antonio Peña has used the aliases Antonio Peña, Andrew Taylor, Anthony Liriano, Anthony Peña, Thomas Wright, Arthur Harriot, Greg Jenkins, and the nicknames "Tone," and "Nut". Peña is a transient and may stay in motels or shelters. Police believe he's trafficking illegal narcotics to support himself. Peña is 35, 5'11" and 225 pounds.

**Unknown Vanessa Sosin Killer (Murder, Arson)** -- On February 8, 2003, a woman and her daughter noticed a black woman enter Vanessa Sosin's consignment clothing store as they were leaving. The woman was wearing a pillbox hat and a dark puffy coat and she was carrying



two shopping bags full of clothes. Twenty minutes later, a mailman down the street saw a person in a dark coat run out of the clothing store, and then he saw smoke. The mailman called 9-1-1 and firefighters got to the store quickly. To their horror, they found Vanessa dead in the back of her store, doused with gasoline and stabbed 14 times. There was blood spattered all over the walls, and unexploded plastic bottles full of gasoline scattered along the floor. Montgomery County Police Detective Paula Hamill says her first gut reaction to the crime scene was that it looked like someone was very angry with Vanessa, but after a three year investigation, she has yet to find a single enemy. DNA swabs taken from the crime scene include DNA from both a man as well as a woman. No money was taken from the store, Vanessa's purse and wallet were still there, none of her jewelry was taken and her Mercedes was also left behind. Vanessa's husband Cliff says the only thing missing was a full length dark mink coat that she wore to work that day. Arson investigator Lt. Brian Anderson of the Montgomery County Fire Department determined the killer came in intending to set the fire. He says the killer brought a funnel, a gas can, rubber gloves, and plastic bottles. The bottles were all filled with a mixture of gasoline and 2-cycle oil generally used for power lawn equipment, like chain saws. Despite this, Lt. Anderson does not believe it was a professional arsonist. Blood spatter expert Dr. Bill Vosburgh analyzed the crime scene and theorized Vanessa was dragged back to the store's bathroom at knifepoint, then stabbed in the carotid artery. Smudges on the doorframe indicate her attacker is likely to be anywhere from 5'10" to 6'2" tall. This height could indicate her attacker was a man. Police checked out homeless shelters and homeless service organizations in the neighborhood. They checked her business associates. They checked her friends, both new and old, and found no one among them to have any motive or means or opportunity to hurt her. Her husband Cliff, came under investigation when detectives got a tip he was actively dating women he met on the internet. Detectives learned he even had a date scheduled the night Vanessa was killed. The outing of his hidden life caused a rift in the family, and Cliff is now estranged from Vanessa's mother and sister. He blames the police for this, but they say he is no longer a suspect in his wife's murder and welcome his help in their investigation.

**Carlos Cervantes (Murder)** -- On August 4, 2001, Patrick Reyes brought his car to Cervantes to install a car stereo. After picking up the car, Patrick discovered that Cervantes took the car out joy riding. Adding insult to injury, Patrick thought Cervantes did a shabby job of installing the stereo. Patrick asked his best friend Alex Angelo to go with him to confront Cervantes and to demand his money back. Cervantes agreed to refund the money, but allegedly told the two friends he had to go to his father's house to get the money. The two friends took Cervantes to his father's home, but instead of getting the money, Cervantes grabbed his father's Glock automatic pistol. Then, in an effort to conceal the gun in his waistband, he put on a heavy woolen poncho and wore it outside into the August heat. Cervantes got back in Patrick's car after telling the friends he needed to go to yet another place to pick up the rest of their money. Only minutes later, while the car had slowed for a speed bump, Cervantes shot each of the men in the back of the head, killing them instantly. The car, still in motion, came to a stop after hitting a tree. Witnesses watched as a man in a poncho climbed out of the back seat of the car, stepped over the dead driver, then ran away. Cervantes later confessed the murders to his family, claiming self-defense. He has never been seen again. He may have fled to Mexico, but authorities believe he couldn't make a go of it there. He is probably back in the U.S., possibly in California, working on cars installing stereos and alarm systems. Cervantes, who sometimes

uses his father's name, Enrique, has numerous tattoos including an Aztec bird on his upper right arm, the two names "Maria" and "Jesus" on his upper left arm, and a star-like figure on his chest. He studied to be an airplane mechanic and hangs out with "gear heads". Cervantes is 30, 5'7" and 150 pounds. (See Show #705, OAD 2/01/03)

**Mikhail Drachev** (Murder, Kidnapping) -- Konstantin Simberg was an informant for Phoenix, Arizona Detective Tom Britt. On December 14, 2001, Tom received a call on his cell phone from Konstantin. While on the phone, Tom heard a scream from Konstantin, then the line went dead. Two days later, Konstantin's body was found in Fossil Creek, Arizona - a rural area more than 100 miles from Phoenix. Through his own phone records, Tom learned that Konstantin called him from a cell phone belonging to an Arizona State freshman named Chris Andrews. Detectives went to Andrews' apartment and found evidence linking him to the murder. 20-year-old Dennis Tsoukanov and 19-year-old Mikhail Drachev were also involved in the killing. All three are acquaintances of Konstantin's. The three men attacked Konstantin while he was on the phone with Detective Britt. The gang held Konstantin overnight, then drove him to Fossil Creek the next morning. The men stabbed Konstantin in the back with a knife. The men then lit him on fire, covered him with rocks and left him for dead. Andrews and Tsoukanov are in jail awaiting trial. Drachev is currently on the run. Drachev is a Russian national who speaks English without an accent. He may be driving a 1973 Mercedes-Benz 280-SEL with Utah plate 182-XS. Drachev is 23, 5'11" and 170 pounds. (See Shows #689, #721, #761, #780 and #801, OADs 8/31/02, 5/31/03, 4/24/04, 9/18/04 and 4/02/05) Drachev has drastically changed his appearance since his last profile on AMW. Police recently uncovered a new photograph from Canada. He has dyed his hair blonde and wears glasses. He could be hiding in New York or Canada.

#### **William "Billy" Smolinski**

Age: 33

Height: 5'11"-6'0"

Weight: 200 pounds

Billy Smolinski, an air conditioner repairman and tow truck driver from Waterbury, Connecticut, vanished without a trace over a year ago. So far, no one has come up with an explanation for why Billy would suddenly take off. Police in Waterbury do not suspect foul play. His disappearance is a true mystery, especially since he left his wallet and keys in his truck. Before Billy went missing, he had broken up with his girlfriend after they had returned from a trip to Florida. His family says that he wasn't deeply upset by the breakup and that it was a positive release after a turbulent relationship. Billy has no history of drug use or a police record and his bank account and social security number have not been used since he vanished. At the time he left, he had been prepping to paint his home. Billy is bowlegged and has his left ear pierced. He usually wears size 36-32 pants, size 10.5 shoe and extra-large shirts. At the time he went missing, Billy was wearing a gold chain necklace with a cross pendant, blue jeans, blue work shirt and work boots. He loves

fishing, demolition derbies and riding snowmobiles. Billy was last seen in at his home on Holly Street in Waterbury on August 24, 2004.

**John Casey: Unknown Helen Walker Killer (Murder)** -- On October 5, 2004, 34-year-old Helen Walker was finishing her shift at the Best Western off the I-295 in Jacksonville, Florida. She worked the 11 p.m. to 7 a.m. shift as a night auditor, which was typically quiet. Being a busy mother of three with a husband in the US Navy, Helen liked this shift because she could be home in time for her children in the morning. Her husband, Harold, says Helen would make breakfast, get the kids off to school, and then go to bed. Helen would be home and ready for the kids to help them when they returned home from school. However, on October 5 she wasn't there for her kids. Around 5 am, surveillance cameras in the hotel's lobby caught a man walking in. Officials say the unknown assailant asked Helen about the cost of a room, but the exchange quickly turned into an attempted robbery. The man caught clearly on surveillance demanded money from Helen. She was prepared to give him money, when he shot and killed her. Thanks to confidential information from America's Most Wanted tipsters, police were able to identify Casey as Helen's killer. Casey was arrested and was later sentenced to 25 years in prison on April 6, 2006. (See Shows #783 and #790, OADs 10/22/04 and 1/01/05)

**Jose "Joey" Miguel Garcia (Rape)** -- In September 2004, a pregnant wife and mother fell asleep on the family room couch while watching television with her 14-month-old daughter in rural Ledbetter, Ky. Late that evening, the victim awoke to sharp stabbing pains in her abdomen. She felt someone looking at her and awoke to a man in head-to-toe camouflage standing over her and her daughter armed with a stun gun. Anxious about the welfare of her unborn child and infant daughter, the woman did everything she could to get rid of the masked man. She told police she offered him money, jewelry, and her car--anything to get rid of him. But he wouldn't budge. At her wit's end, the woman offered the intruder one last thing: herself. Finally, he nodded "yes." The masked man forced his victim into her bedroom at gunpoint as she held her daughter in her arms. Then, while her infant daughter slept on the bed, the assailant raped the woman. Thinking only of survival and her children's safety, the young mother complied with the brutal attack, all the while, carefully gathering clues about the masked man. During the rape, he removed one of his gloves, and the woman was able to see his skin. She described it to police as that of a man who is either Hispanic or a light-skinned African-American. She also stared at his eyes which she recognized. After the rape, the attacker left his victim and her daughter alone in the bedroom. Twenty minutes later, the woman realized her attacker was gone and she bolted out of her home. Neighbors next door called police and the woman walked law enforcement through the harrowing attack. Then, she quickly went to the hospital's neo-natal unit to check on her unborn child. Fortunately, she and her children all survived with only minimal wounds. Police now had a brutal rape to solve and they feared the woman's attacker knew her. The fact that he never said a word led police to believe that he had likely been worried she would recognize his voice. Also, there was no sign of forced entry and the woman was certain she had locked all the doors before falling asleep. The detective asked her if anyone in her life matched the attacker's size and skin tone. That's when she put it all

together. When Livingston County Sheriff's deputies told the woman to think if anyone could do this, her mind started to race. She says that the man who attacked her resembled her co-worker, Jose Garcia. Garcia had worked with the woman for about two years in a small shop and office in nearby Paducah. The woman thought he was the same height and build as her unidentified rapist, and she thought her rapist's skin tone matched Garcia's. At work, Garcia and the woman were often the only two people in the shop while their colleagues were off on service calls. She says that he always seemed to pay special attention to her and in hindsight, she reflected on what now seemed like suspicious behavior. Four months before her attack, someone had put a peephole in the co-ed bathroom of the woman's office. Her boss filled the hole as soon as she mentioned it to him, but it was later reopened. On that day, the woman says there were only three people in the office: her boss, Jose and herself. The boss pulled Garcia aside and spoke to him about the spy hole, which remained covered after that. Two months after that incident, the woman lost her keys at work; they seemed to just vanish from her purse. Again, Jose Garcia was the only other person at work that day. As the woman started to recount these incidents, the link to Garcia seemed more and more plausible. The morning after the rape, police went to their workplace to question Garcia about the attack. Garcia was cooperative until he was asked to provide a DNA sample, then he invoked his right to a lawyer. Armed with a warrant, detectives got a sample of Garcia's saliva, but by the time the test came back as a positive a hit, Garcia was already on the run. Garcia is known to use the aliases Jose M. Estrada and Joey. He has brown hair and likes to wear it short. He's usually clean-shaven and was last seen with a goatee and a mustache. He is a Puerto Rican native who speaks Spanish fluently and also speaks English well - with a slight accent. He likes to work out and drinks protein shakes like Creatine. He's flirtatious and talkative and is believed to be a stalker. Garcia has previously worked at Wal-Mart and as a truck driver and may be seeking employment as a fire extinguisher maintenance worker. Police describe him as armed and dangerous. He was last seen driving a 3-door 1991 blue Honda with either temporary Illinois tags or expired Kentucky plates, 733-JTT. Garcia is 31, 5'9" and 180 pounds. (See Show #826, OAD 11/12/05)

**Darren Roy Mack** (Murder) -- On Monday, June 12, 2006 swat team swarmed a court house after a sniper wounded a judge who was standing at his office window. At the same time, miles away from the courthouse, detectives were investigating a murder at a townhouse complex. Someone had stabbed 39-year-old Charla Mack to death. Police soon realized that these were not isolated incidents. The wounded judge was handling the Charla's bitter divorce from her husband Darren Mack. An arrest warrant was immediately issued for Mack but he has disappeared. Mack owns a pawn shop in Reno, Nevada and has access to guns. He may be driving a 2006 Ford Explorer with California plate #5PORQ72. Mack has a pilot's license and may have rented a plane. He is 45, 5'11" and 205 pounds.

**Midtown Jane Doe** (Unknown Victim) -Police in New York City need the public's help to determine the identity of a Jane Doe. Police say that on February 10, 2003, construction workers removing debris from the basement of a building in Times Square cracked through a cement slab and found a human skull. Police investigated and determined this was a 'bone case' so they called in the medical examiner's office. Once the full remains of a skeleton were recovered, the medical examiner determined that the deceased was a white female, 18-20 years old and 5'1." It was also determined that the woman was killed in the mid-to-late 1980's. Police

believe that the young woman may have been a prostitute because her remains were found in a building that was known as a favorite haunt for drug dealers and prostitutes. In fact, the building is just a few blocks from the Port Authority Bus Terminal, which had a reputation for attracting runaways and vagabonds from all over the United States. Police found a gold-plated signet ring near the woman's remains with the initials "PG Mc," which could possibly be the initials "P McG." They also found a woman's gold colored Bulova watch and a green plastic toy soldier. (See Show #755, OAD 3/06/04)

**Justin Austin** (Murder) – Police in Englewood, Colorado say Justin Austin shot an auto mechanic to death following an argument about poor repairs on his prized truck. Police believe Austin could be headed to Arizona or Mexico. Austin is 27, 6'1" and 260 pounds.

**Michael Baraka Mason** (Person of Interest) -- Michael Mason is wanted for questioning in the shooting death of two people in a home invasion robbery in San Diego, California. Authorities say that he's a member of the Lincoln Park gang and goes by the name Don Diego. Mason is 29, 5'10" and 150 pounds.

**Pedro Montiel Reyes** (1<sup>st</sup> Degree Murder) -- Police in Prince George's County, Maryland are on the hunt for Pedro Montiel Reyes. Reyes allegedly murdered his girlfriend in a fit of jealousy and rage. Reyes has a bad temper which flared up when he suspected his girlfriend, Josefa Arias, was cheating on him. On March 15, 2005 Reyes stabbed Josefa to death. Her body was found two days later. Police recovered a pair of Reyes' pants from the crime scene that turned out to have Josefa's blood on them. Authorities are certain Reyes is responsible for the murder but he hasn't been seen since the day of Josefa's murder. Reyes is a day laborer who works mainly in construction. He is 52 and 5'5."

**Neil Stammer** (Criminal Sexual Penetration, Criminal Sexual Contact of a Minor, Kidnapping) -- Neil Stammer has traveled the world as a juggler, but in the late 90's he settled in Albuquerque, New Mexico. He owned and operated a magic and juggling shop. His store Roy's Magic and Juggling Shop was a magnet for Albuquerque kids. Every Friday, kids from the neighborhood would descend on the shop after school. Stammer would host free juggling lessons and tell the kids his stories of juggling in circuses and traveling the world. Kids were enthralled with his stories. Stammer also ran a juggling club that would meet once a month at the University of New Mexico. A large number of people involved in the club were adolescent boys. According to police, Stammer would have some of the boys help him clean up the store after it was closed. In May of 1999, one of the boys who was in Stammer's juggling club and helped out at the store was able to build up courage to tell his family a horrible secret he had been keeping from them. The 13-year-old boy told his parents that he had been molested a couple of times, but he was too afraid to tell anyone. He said Stammer had threatened him. His family immediately called police. During the investigation, police say, a couple of other children came forward and said Stammer had done the same thing to them. Police charged Stammer with several counts of child abuse after interviewing the children. Before police could arrest Stammer, he fled, leaving his beloved business behind. Police have discovered Neil Stammer's name was Andrew J. Allen, but legally changed it. They believe he could be going by Andrew Allen. Stammer learned several languages while traveling as a juggler, so they believe could be hiding anywhere. The families of the

victims and police fear wherever Stammer is hiding, he could be harming more children. Stammer is 39, 5'10" and 160 pounds. (See Show #839, OAD 2/25/06)

**Shane Matthew Magan** (Attempted Murder of a Peace Officer, Armed Robbery) -- Magan is wanted by Riverside and San Bernardino, California authorities for attempted murder of a peace officer and a string of supermarket and convenience store robberies in Southern California. On February 25, 1993 during a suspicious vehicle traffic stop, Magan, who was high on speed, opened fire on a Riverside sheriff's deputy. The officer returned fire, but Magan and his friend, Justin Flint, managed to escape. Minutes later, in nearby San Bernardino County, the two youths robbed a gas station convenience store at gunpoint. Flint surrendered to authorities shortly after the robbery, but Magan remains at large. Magan was spotted in a gang round-up, but authorities at that time did not know Magan was a fugitive from justice. Magan has a noticeable hare lip. He shaves his head, wears black hooded sweatshirts and black caps and fancies himself a Hispanic gangster. He may associate with Pomona's local 12<sup>th</sup> Street Sharks gang, and may run with a gang of armed graffiti Taggers. He uses amphetamines and speed, and should be considered armed and extremely dangerous. Magan is 28, 5'7" and 145 pounds. (See Shows #299 #335, #629, #722 and #776, OADs 1/11/94, 10/8/94, 4/14/01, 6/07/03 and 8/21/04)

**Ralph "Bucky" Phillips** (Escape) -- A convicted felon who escaped from the Alden County Correctional Facility in upstate New York on April 2, 2006, is now suspected of trying to kill a police officer. Ralph Phillips fled from the medium security prison by using a can opener to pry his way out. On June 10, 2006, two New York State Troopers stopped the driver of a vehicle that was reported stolen. As the two troopers approached the car, the driver - who police say was Bucky Phillips - pulled out a gun and fired. One of the troopers was hit in the abdomen and was seriously injured. Bucky has been in trouble with the law for most of his life. His long criminal history documents a life of burglary, car theft and stalking old girlfriends. Bucky, who is as known as Daniel Aaro, Ralph James Phillips, and Harold Phill, had long hair and a beard at the time of his escape but police believe he may have cut off his hair and shaved off his beard. He has allegedly been squatting in cabins around New York's Southern Tier and police believe he might be staying on an American Indian Reservation. Bucky is 44, 6'0" and 220 pounds.

**Unknown Michael Scrocca Killer** (Arson, Murder) -- On April 30, 2005, Michael Scrocca and his seven fraternity brothers decided to throw a party to celebrate their upcoming graduation and a roommate's 21st birthday. However, what seemed like a great idea at the time would end tragically for the students at the University of Maryland. On the night of the party a mysterious fire engulfed their home. Everyone managed to get out safely except Michael. As investigators searched the burned rubble they discovered a can of gasoline on the front porch and which leads him to believe that an unknown arsonist planned the fire and Michael's death. In May of 2006, tips led investigators to a student named Daniel Murray. He was charged with first degree murder after he confessed to setting the fire. Police aren't sure if he was alone the night of the fire but they are positive that someone has additional information regarding this case.



## **CAPTURED:**

**Lewis Lee** (Custodial Interference, Unlawful Flight) -- Police say Lewis Lee, a former pastor, grabbed 15-year-old Elizabeth Thomsen and went on the run. Elizabeth became the target of this child predator when her relationship with her parents became strained. Elizabeth's parents questioned the attention Lee was giving their daughter and had him arrested for stalking and trespassing after he was caught peering into Elizabeth's window. As a part of his arrest, Lee was banned from communicating with Elizabeth. Later, Lee relocated his family to Maryland. Regardless of the law and the distance between them, Lee continued to call Elizabeth on a daily basis. During these calls, police believe Lee and Elizabeth made a plan to run off together. Police say the two had been on the run since March 18, 2006. Both Lee and Elizabeth were taken into custody on April 17, 2006 in Western Maryland. (See Show #846, OAD 4/15/06)
