1. POLICE, THE COURT SYSTEM AND CRIME

AMERICA'S MOST WANTED-Network/Public Affairs-Saturdays 8-9 p.m.: One hour show each week that asks for the public's help finding criminals police are looking for that are still on the run.

GOOD DAY IOWA Local/News-Monday, January 30, 2006, 7-9 a.m.: Governor Vilsack wants to restore voting rights to felons, but some lawmakers want him to restore voting rights on an individual basis, opposing restoration for sec offenders and others. A :27 report.

FOX NEWS AT 9 -Local/News-Monday, January 30, 2006, 9-9:30 p.m.: There is a bill at the Statehouse that would require all state-funded libraries to install filters, blocking pornography for all computer users as well as restricting children from checking out adult movies. A :19 report.

FOX NEWS AT 9-Local/News-Tuesday, January 31, 2006, 9-9:30 p.m.: A group of teenagers is pushing for tougher laws in hopes of preventing underage drinking. They are supporting a law that would require adults to register their name when they buy keg beer, allowing the keg to be traced. A :43 report.

GOOD DAY IOWA-Local/News-Wednesday, January 31, 2006, 7-9 a.m.: Area federal immigration agents are shifting their focus away from catching illegal immigrants to catching potential terrorists. A :20 report.

FOX NEWS AT 9-Local/News-Wednesday, February 28, 2006, 9-9:30 p.m.: Jetseta's family asked lawmakers to bring back the death penalty for those who commit violent crimes against children. A 1:40 report.

FOX NEWS AT 9-Local/News-Wednesday, February 28, 2006, 9-9:30 p.m.: In 2001 Iowa's rate of incarcerating African Americans was one of the highest in the country, Since then, the rate has steadily climbed. 23% of the cells in Iowa's prisons are home to African Americans. The black community represents just over 3% of the state's overall population. A 2:00 report.

GOOD DAY IOWA-Local/News-Friday, March 31, 2006, 7-9 a.m.: The state ethics board will investigate campaign finances of Republican candidate for Governor, Jim Nussle. A :14 report.

2. EDUCATION AND CHILDREN

FOX NEWS AT 9 -Local/News-Friday January 27, 2006, 9-9:30 p.m.: Computer software has made filing taxes easier. Iowans are among lots of Americans who are getting educated in filing their own taxes. A 1:30 report.

FOX NEWS AT 9-Local/News-Sunday January 29, 2006, 9-9:30 p.m.: The number of preventable child deaths has dropped in Iowa. The Department of Public Health says that 148 children died in 2004 in cases where death could have been prevented, and that is down from 169 in 2003. Preventable deaths include vehicle accidents, homicides, suicides, and SIDS. A :35 report.

FOX NEWS AT 9 -Local/News-Sunday January 29, 2006, 9-9:30 p.m.: The Mid-America Housing Partnership helps low-income Iowans find affordable housing. MAHP is trying to educate those in the housing business. MAHP has teamed up with Coldwell Banker Hedges Realty to help educate and make the search for housing easier. MAHP uses apprentices to show houses to prospective buyers, thus reducing costs to sell homes. A 1:20 report.

FOX NEWS AT 9 -Local/News-Monday January 30, 2006, 9-9:30 p.m.: Iowa's high school children could be required by law to stay in school if state lawmakers can push another bill forward. The bill would require all students to stay in school until they graduate or turn 18. A:23 report.

GOOD DAY IOWA -Local/News-Tuesday January 31, 2006, 7-9 a.m.: Faculty, students and staff at the University of Iowa want to stay involved in the search for a new president and they have made their voices heard. Members of the faculty senate and staff council passed a resolution asking the Board of Regents to keep the school involved in the search. A :40 report.

FOX NEWS AT 9 -Local/News-Wednesday March 29, 2006, 9-9:30 p.m.: The old fashioned cardboard containers of milk in school cafeterias now have a new and improved look and are made of plastic, and it's increasing milk consumption. A 1:19 report.

3. **HEALTHCARE**

FOX NEWS AT 9-Local/News-Friday January 27, 2006, 9-9:30 p.m.: A new study finds that an extra cup of coffee may not give you a boost when you exercise. Researchers found that drinking 2 cups of coffee decreases blood flow to the heart during exercise. Doctors say that drop-off may not be an issue with those in good health, but could pose a risk to anyone with coronary artery disease. A :31 report.

FOX NEWS AT 9-Local/News-Monday January 30, 2006, 9-9:30 p.m.: Researchers have linked the overconsumption of alcohol to a heightened risk of several cancers including those of the mouth, larynx and liver. Moderate amounts of alcohol is proven to help prevent cardiovascular disease. A :27 report.

FOX NEWS AT 9-Local/News-Wednesday February 15, 2006, 9-9:30 p.m.: President Bush proposed tax cuts for those who are unable to afford healthcare. An estimated 45 million Americans are not insured and the Bush administration says by putting more money in their pocket, they hope to bring that number down. President Bush also promoted tax-free health savings accounts to help people pay for future health needs. A :23 report.

GOOD DAY IOWA -Local/News-Tuesday, February 28, 2006, 7-9 a.m.: It is not too late to get a flu shot. A state epidemiologist says this year's flu season is peaking much later than normal and will be widespread across the state in the next few weeks. A :30 report.

FOX NEWS AT 9-Local/News-Sunday, March 26, 2006, 9-9:30 p.m.: Thousands of Iowans will be affected by the new Medicare prescription drug plan. People eligible for the drug plan have until May 15th to sign up. If they miss that deadline, they cannot get coverage until January 1st and will have to pay a late fee. A 1:46 report.

4 NEED FOR ECONOMIC GROWTH

FOX NEWS AT 9-Local/News-Monday, January 30, 2006, 9-9:30 pm: President Bush went before Congress with a plan about what to do about the country's addiction to oil. He proposed spending more federal money on alternatives to foreign oil such as bio-diesel and ethanol. A :20 report.

GOOD DAY IOWA-Local/News-Tuesday January 31, 2006, 7-9 a.m.: Record-high natural gas prices at the start of winter along with record-low temperatures in November and December have depleted the low income heating assistance money available to low income families. The Hawkeye Area Community Action Program joined with Alliant Energy and representatives from several area towns in signing a letter to Iowa's Congressional delegation asking Congress to immediately approve an extra \$2 billion for low income heating assistance nationwide. A 1:40 report.

FOX NEWS AT 9-Local/News-Tuesday, January 31, 2006, 9-9:30 p.m.:Senate Republicans want to freeze property taxes for Iowans who are 65 or older and earn less than \$25,000 a year. A :23 report.

GOOD DAY IOWA-Local/News-Tuesday January 31, 2006, 7-9 a.m.: Iowa Democrats are calling for a \$26 million plan to fund research and bring ethanol to more Iowa gas stations. A :21 report.

GOOD DAY IOWA-Local/News-Tuesday, January 31, 2006, 7-9 a.m.: Governor Vilsack and Attorney General Tom Miller have proposed a bill that would limit interest on car title loans to 21%. A :20 report.

GOOD DAY IOWA-Local/News-Tuesday February 28, 2006, 7-9 a.m.: The Iowa House Committee has approved a bill to remove all touchplay machines from Iowa stores and restaurants. A Senate Committee will begin looking at a similar ban on touchplay machines. A 2:00 report.

GOOD DAY IOWA-Local/News-Thursday, March 30, 2006, 7-9 a.m.: Iowa Republican lawmakers have proposed a \$450 million teacher pay increase and a plan to phase out Iowa's income tax on pensions and social security income over five years. Fiscal advisers say eliminating the tax will cost the State \$197 million a year in revenue. A :36 report.

5. ENVIRONMENTAL CONCERNS

FOX NEWS AT 9-Local/News-Friday January 27, 2006, 9-9:30 p.m.: The Des Moines Blank Park Zoo Board has voted to move forward with plans to more than double its size. A :37 report.

FOX NEWS AT 9-Local/News-Sunday January 29, 2006, 9-9:30 p.m.: The Chronic Agricultural Complainer Bill is on the House floor. It is a bill that would make a person liable for administrative costs and damages to the accused when that person submits 4 or more unactionable complaints to the Dept.of Natural Resources or a County Board of Supervisors within a 2 year period. A 1:40 report.

FOX NEWS AT 9-Local/News-Sunday, January 29, 2006, 9-9:30 p.m.: A Washington think tank report says the quality of life in Iowa is good and the opportunities for a high standard of living are among the best in the nation. A :37 report.

GOOD DAY IOWA -Local/News-Tuesday, February 28, 2006, 7-9 a.m.: The Iowa Senate Judiciary Committee's considering legislation that will tighten the government's ability to seize land. A :45 report.

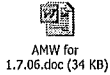

New York, New York and Memphis, Tennessee...PETER BRAUNSTEIN CAPTURE... Peter Braunstein adores the limelight -- so police weren't surprised when he admitted to logging on to public computers while on the run in order to track his media coverage. One of his favorite sites to peruse was AMW.COM. In the weeks since the high-profile capture of Peter Braunstein, the man who allegedly sexually abused a woman on Halloween and then led police on a six-week chase across the U.S. Police now have a glimpse of his bizarre thought process while on the run.

Dallas, Texas...STEVEN VALADEZ... Cops say 18-year-old Steven Valadez shot and killed Ronnie Hubbard over a missing ring. According to authorities, Ronnie died in his girlfriend's arms and Valadez sped off and disappeared.

Hillsborough County, Florida...DARREN WILLIAMS... Cops say Darren "Fat Man" Williams has little respect for the law - he fights officers who try to arrest him and gives them fake names when he's in custody. Williams has a violent past - and now he's on the run from drug and prostitution charges.

Cameron, North Carolina...JAMES MARVIN JOHNSON... U.S. Marshals say James Johnson - an avid hunter - not only hunts animals but also preys on young children. According to officials, Johnson sexually molested two young girls in North Carolina, but took off before his trial date.

San Diego, California...NASSER ALAVI... In May 2003, a 22-year-old woman began going to her general practitioner for the treatment of anxiety and depression. The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

This will confirm that I have screened the air copy of the above-captioned episode and have the following comments:

Unknown Ronald Bridges Killer (Murder, Attempted Robbery)

Unknown Ronald Bridges Killer Accomplice (Accomplice Robbery) -- Authorities say an unknown black male entered a video game store in Houston, TX on September 16, 2002 to rob the store. The assailant wore a hat, sunglasses, a black stocking over his face and was armed with a handgun. The gunman calmly spray painted the security cameras while his accomplice waited in the getaway car. After covering the lenses, the gunman removed his disguise and ordered the clerk to empty the cash register and fill a bag with popular video games and consoles. When a customer entered the store, the gunman threatened the clerk to play cool and pretended to browse the store. The employee caught the customer's eye and mouthed for help. The customer immediately left and called the police. The accomplice is believed to have been scared off by the police sirens. In a panic, the gunman dropped the bag containing the money and games as he fled into the nearby neighborhood. Authorities believe that the gunman came across the unlocked home of Ronald Bridges and hid in his attic. Bridges was off from work that day, investigators believe he was asleep when the gunman entered his home. Around 3:30pm Bridges' wife called to remind him for pick her up from work. He told her he was up, and then the phone went dead. Police believe that around this time, Bridges heard the intruder fall through ceiling and went to investigate. Investigators say that a struggle ensued and Ronald Bridges was strangled to death. Police say that the man who had crouched in the attic for hours killed Bridges before stealing his truck and fleeing. The gunman is described as Black, bald, age range in the 20s, height between 6'3"-6'5", with a slim athletic build. The accomplice is described as Black, with braids, may have a medium or heavy build. The accomplice's vehicle is described as a white 1995 Chevrolet Caprice with chrome rims and grill.

Marvin O'Brien Pierre (Murder) -- On February 7, 2005, Pierre shot Kofi Appiah to death. After shooting Appiah several times in the chest, Pierre fled on foot and has not been seen from since. Police believe that he is armed and extremely dangerous; he is ex-military from Trinidad. Pierre is described as Black, 30, 5'6" and 175 pounds.

Scott King (Cocaine Distribution, Money Laundering) -- When a street level drug dealer in Greenville, South Carolina was arrested by the DEA in 2004, investigators worked the case and eventually uncovered an organized drug ring that they say moved significant amounts of crack and powder cocaine through the southeast. Investigators tracked the operation all the way to Atlanta, GA and to a high-end auto dealership called 404 Motor Sports, which dealt with some famous celebrities. Ten people were charged in connection with the case, including Scott King and Tremayne Graham. All of the key players turned themselves in, except Scott King, who drove off in a white 500 series Mercedes. King is a former college football standout, who played at Mars Hill College in Hendersonville, North Carolina. King and his associates lived a lavish lifestyle, using their drug proceeds to purchase extravagant homes, jewelry, luxury cars and vacation in exotic locales. With the money King's group made through their drug trafficking activities, they managed to run in circles of elite company, regularly socializing with professional athletes, and well-known celebrities. Scott King is 36, 6'5" and 225 pounds. (See Show #814, OAD 7/23/05) Authorities believe King may be hiding out in California.

Alejandro Gutierrez (Murder) -- The night of June 18, 2005, Gutierrez and friends went out drinking at some bars in the area of Statesville, NC. The party moved to a rented house. Around 2 a.m. the following morning one of his friends said something that offended Gutierrez, at which time Gutierrez left the house under the guise of getting more beer. Authorities say that Gutierrez instead drove home to retrieve his gun, returned to the rental house where another fight ensued. Gutierrez opened fire killing three of his friends. Gutierrez is Hispanic, 18, 5'8" and 160 pounds.

Daniel Keo Kung (Murder) -- Massachusetts police say Daniel Keo Kung, a member of the Tiny Rascals Gang, shot to death 19 year old Ponarith Uong on June 24, 2004 as he sat in his younger brother's car in rush hour traffic. According to police, Kung was looking for the victim's brother for bad-mouthing the gang, but got the wrong man. Authorities traced Kung to a Rascals Gang safe house in South Carolina, but he was long gone by the time the police raided the safe house. Kung is described as Asian, 25, 5'6" and 135 pounds.

Claudia Librett (Kidnapping) -- On January 10, 2003, Librett kidnapped her 3 year old daughter, Rachel Librett Marran, after a heated custody battle with her ex-boyfriend, Michael Marran. Librett, a successful New York interior designer, met Marran in 1999 while working at a property, she as a decorator and he as the owner of a fencing company. The two began dating, Librett became pregnant and the two built a house on Long Island and planned to marry. On May 21, 1999, Rachel was born. Shortly after her Rachel's birth, Librett became distant and moved to Penn Valley, Pennsylvania to live with her mother. A Pennsylvania judge awarded joint custody to Marran and Librett on January 9, 2003. The next day, Librett picked up Rachel from school and neither has been seen since.

Brian Michael Jones (Rape, Sexual Assault, Kidnapping) -- Jones is wanted for the rape and kidnapping of a Las Vegas woman, "Mary". On August 28, 1999 "Mary's" car got stuck in the desert sand. She began walking for help when Jones stopped and offered to help her pull her car out. He told her that he had a truck at his house and it would be able to pull her car out of the sand. "Mary" got into Jones' car and went to his house. Instead of just getting his truck, Jones held "Mary" hostage for 18 hours while he raped and performed sexual acts on her. After 18 hours of abuse, "Mary" was able to escape and run to safety. Jones was arrested on September 2, 1999. He was released on bail in November 1999. Jones checked in weekly with a parole officer while he was awaiting trial. In September 2000, Jones failed to report to his parole officer and hasn't been seen since. Jones worked in the real estate business. He likes to work in landscaping, is a handyman, collects guns and makes his own bullets. He is known to have driven a 1979 orange/red Stingray Corvette and a 1980's white Chevy pickup truck. He may be in Canada. Jones is 49, 5'11" and 180 pounds. (See Shows #633, #727 and #780, OADs 5/19/01, 7/19/04 and 9/18/04)

East Coast Gate Cutters Crew (Burglary) -- This team of four or five men have broken into over 50 jewelry stores along the east coast by cutting the metal roll gates on the store front with bolt cutters, giving them their moniker. The thieves are in and out in just a few minutes, taking gold rings, bracelets, chains and pricey Movado watches, leaving behind precious stones and never going after the store safes. Authorities believe robbers only take what they can easily sell to someone waiting for the goods. Former jewel thief, George Feder, after reviewing the Gate Cutter's file recognized a pattern, that more than two thirds of the robberies were taking place on Sundays, Mondays and Wednesdays. It also appears that the first 16 robberies took place in New York or within a two hour driving radius. Descriptions of the robbers are unknown, however, authorities say they have surveillance footage of the men they believe responsible for the robberies.

Francisco Martinez (Murder) -- Martinez shot his boss, Michael Cerullo, in the back of the head on September 14, 2001. Cerullo was an owner of Yofi Textiles in Passaic, New Jersey. Martinez, the warehouse manager, was also the lead suspect in an arson that occurred a few weeks prior to the murder. Friends and family of the two men were puzzled by the murder because the two were also very good friends. They had known each other for thirty years and would often spend time together outside of work. Martinez was stealing textiles from the company, selling material for cash and not reporting the money. Francisco tried to burn down the factory to cover up the crimes. Cerullo became suspicious of Francisco and may have had a confrontation about the theft and arson. Cerullo was found in the basement of Yofi Textiles with a bullet wound to the head. A few days later police divers found the murder weapon in the Passaic river. By this time Francisco had disappeared. Martinez, who has used the alias Francisco Martinez Seminari, has a scar on his abdomen, psoriasis on his head and neck leaving bumps and a rash that looks like a birthmark, a discolored front tooth. He always wears baseball caps to cover his discolored balding head, and has an extensive collection of caps. Martinez is 44, 5'8" and 350 pounds. (See Shows #688, #703 and #743, OADs 8/24/02, 1/04/03 and 12/06/03)

Arthur Leon Vitasek (Unlawful Flight to Avoid Prosecution) -- January 2005, a Mesa, Arizona detective was called to a middle school to speak to a student who was being teased mercilessly. Normally, the school's principal wouldn't call law enforcement to settle schoolyard disputes, but this incident was different. Although he initially denied it, the boy eventually divulged that he had been sexually molested by his mother's boyfriend - Arthur Vitasek.

Detective

Robert Rash contacted the boy's mother who agreed to keep the boy away from Vitasek. However,

two days later, when Rash tried to contact the boy, he found that Vitasek had taken him and two of his friends. The boys were found after an Amber Alert was issued and they all eventually admitted that Vitasek had molested them. Police say they have probable cause to charge Vitasek with upwards of 30 counts of abuse and molestation. Authorities also have evidence that Vitasek has been molesting boys since 1990 and think that there are other unknown victims who haven't come forward. Detective Rash says Vitasek manipulates his victims in a number of ways. He brainwashes the boys into believing that their sexual behavior is normal and then mixes his perversion with trips to amusement parks and gifts. Police believe that in the past, Vitasek even groomed boys to recruit their friends for him. Vitasek also targets boys raised by single mothers. Police say one of the main reasons why Vitasek hasn't been put behind bars is his ability to cover his tracks. Police note that he rarely leaves a paper trail and has correspondence sent to post office boxes. Vitasek may have stolen someone's identity and may also be using an extensive network of friends across the country to leave false clues to keep police off his trail. Arthur Vitasek lived in many places and held different jobs as he continued his spree of molestation. He has lived in Phoenix, Las Vegas, Shreveport, Louisiana, Los Angeles, eastern Texas, Oklahoma and New York. Police investigations have found that he's an experienced cook and mechanic and may be working in the restaurant industry. They say he can also be violent and may carry a licensed gun. Vitasek is fastidious about his appearance and usually wears designer clothing. During his time in Phoenix, he wore his hair bleached and parted down the middle in a bowl cut, but he may have cut it shorter and changed the color. He's a neat freak and suffers from insomnia and claustrophobia and is known to bite his fingers. Police learned that Vitasek dislikes smoking and drinking and loves playing video poker. When he lived in Las Vegas he often gambled at casinos frequented by locals, but preferred gambling at gas stations where he thought his odds were better. Vitasek was a big spender on his victims and their families, but he also had expensive hobbies like scuba diving and he may have been taking flying lessons in order to gain a pilot's license. He also loved automobiles, particularly sports cars and classic cars. Vitasek has two small moles on his right cheek and one on the right side of his neck. He is 42, 6'1" and 200 pounds. (See Show #830, OAD 12/10/05)

On January 10, 2003, Rachel Marran was picked up from school by her mother, Claudia Beth Librett and has not been seen since. (see Claudia Librett above).

CAPTURED:

Jody Kenneth Thompson (Escape, Robbery, Kidnapping, Burglary) -- In Las Vegas, Jody Kenneth Thompson was known as "The Cancer Guy Bandit." He earned the nickname after robbing a string of bars and grocery stores and telling his victims that he was only ripping them off because his child had cancer. Little did they know, Thompson did not have any children. Police say Thompson and his girlfriend used their stolen loot to go on extravagant vacations to Mexico, and to buy expensive furniture and cars. When police finally caught up with Thompson in 2003, he pleaded guilty to a number of armed robberies. He was later sentenced to 10 to 50 years in the Nevada State Prison in Carson City. While behind bars, Thompson began a close relationship with a prison dental assistant, and managed to get a cell phone from her. He also had a job in the prison that gave him access to a prison industries van. On Aug. 25, 2005, Thompson hid in the van that was headed to Lovelock, Nev. and that's where Thompson broke out of the locked rear compartment and fled. Thompson then made some phone calls and was picked up by an ex-cellmate, who drove him to Las Vegas. Las Vegas police say it didn't take long for Jody Thompson to jump right back into a life of violent crime. On Sept. 1, 2005, Thompson robbed the Blue Diamond Saloon at gunpoint. They say he then fled on a stolen motorcycle, which was later recovered in a nearby parking lot where he was picked up by an unknown accomplice. The next day, Las Vegas police and the U.S. Marshals Service, along with the "F.I.S.T." task force, had developed information as to where Thompson may be hiding. Surveillance was set up on a residence, and police watched as a vehicle operated by a woman pulled out of the garage and drove away. A marked squad car conducted a traffic stop of the vehicle, and the woman exited. Suddenly, the vehicle sped off. Thompson was hiding in the car and jumped behind the wheel when the woman got out. As police chased Thompson, he wrecked the car, jumped out and fled into a residential neighborhood. Thompson broke into a nearby residence and stole a car, and fled. The stolen car was recovered in the desert later that day but there was no sign of Jody Thompson. Thomson, who uses the aliases Jody Tony and Kenneth J. Thompson, has a slender build. Thompson is 25, 5'11" and 135 pounds. (See Show #828, OAD 11/26/05 -- AMW records sight Show #592, OAD 12/17/05 but our records do not show this, please verify.) Jody Thompson was picked up on November 29, 2005 in Las Vegas after an AMW tipster notified authorities that he was living with a woman in the area. Thompson was using the alias, Chase Erickson and led the woman to believe that he was a handyman. When Thompson realized the police were closing in on him, he slipped into the home of an elderly couple and held them hostage. Before the police stormed the house, Thompson called 911 to surrender, telling the operator that he was on AMW. The two hostages were unharmed and Thompson is back behind bars awaiting trial on new charges.

Andre Neverson (Wanted for Questioning for Murder) -- On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He has a "L" shaped scar in the middle of his forehead and is now known to wear dreadlocks. He may still be armed. Neverson is 41, 6'2" and 225 pounds. (See Shows #684, #697, #723, #743, #755, #769, #792, #797 and #808, OADs 7/27/02, 11/16/02, 6/14/03, 12/06/03, 3/06/04, 6/19/04, 1/22/05, 3/05/05 and 6/11/05)

Douglas Sturman McCall (Failure to Register as Sex Offender) -- In 1992, McCall admitted to sexually assaulting 16 boys, all under the age of 14. He served five years, for those crimes. After his release in 1997, McCall moved to the state of Georgia where he failed to register as a sex offender. During his stay in Georgia, authorities say he began sending photos of Hispanic male children to a sex offender in prison. In February of 2004, cops issued a warrant for McCall for failure to register as a sex offender. When authorities went to his house to arrest him, he had already fled with his new wife, Maria Guadalupe Perez. McCall speaks Spanish and seems to target young Hispanic males. McCall is described as a Caucasian male, 37, 6'4" and 195 pounds.

John Anthony Pesina (Murder, Burglary) -- On November 30, 2005, Pesina and two accomplices staged a home invasion robbery and shot Bertin Perez and Pedro Solis to death. Pesina's two accomplices were apprehended in December of 2005, but Pesina is still at large. Pesina is described as a Hispanic male, 21, 5'11" and 215 pounds.

Eric Cassineri (Attempted Murder, Drug Possession) -- While Cassineri served time for drug possession and trafficking, his girlfriend began seeing a new man. On July 15, 2005, a little more than a month after his release from jail, authorities say Cassineri and an accomplice drove to the new boyfriend's house and gave him a beating that should have ended his life. The victim was kicked and struck on the back of the head with a cinderblock brick. Cassineri is described as a Caucasian male, 20, 6'2" and 160 pounds, with a very slender build.

Edgardo Perez (Murder) -- Perez befriended Gordon Machek, 55, at a fitness center in October of 2001 and later killed him, put his body inside a steamer trunk and dumped the body in a local lake or river. Authorities believe that Perez had laid out a plan to befriend Machek in order to steal his ID and his money to flee the country and escape a court appearance for a probation violation. Police found books on identity theft and banking at Perez's home. Surveillance video shows Perez boarding a plane to Mexico. Perez is described as 23, 5'6" and 140 pounds.

Robert Carey (Child Pornography) -- Carey worked as a weather watcher for the National Oceanic and Atmospheric Administration for more than 30 years. His job required him to download satellite images. After 9-11, the Government stepped up security and began checking computers. What authorities found on Carey's computer were downloads of more than half a million images of clothed, partially clothed and nude photos of young girls, including images of Carey abusing young girls. Carey fled before the police could arrest him. Train station surveillance videos show Carey buying a ticket to LAX, where he flew to Canada. Carey was last spotted in Prague. Carey likes to collect Star Wars memorabilia and hang out in cyber cafes. Carey is a Caucasian male, 52, 6'0" and 240 pounds.

Unknown Robin Cornell and Lisa Story Killer (Murder) -- Jan Cornell left home her 11 year old daughter, Robin, and her roommate, Lisa Story, on the evening of May 9, 1990. Jan returned home around 4am to get ready for her job as a lab technician, but was unable to enter through the front door because a second lock had been placed on the door. When she went around to another entrance, she saw that the back door was wide open. Believing that the house had been robbed, Jan went to go check on her daughter, only to find Robin lying dead on her

bedroom floor. Authorities believe that an unknown assailant entered the home, double locked the front door, went up stairs, suffocated Lisa first and then Robin. Afterwards, he sexually assaulted the bodies. Instead of leaving the scene of his heinous crimes, the assailant rifled through the home. The killer took items not of much value like Lisa's driver's license and an engraved watch she had bought for her boyfriend. The assailant also laid out pictures of Robin on an ironing board. Authorities found a set of keys on an "Etienne Aigner" keychain, on it a key to a Toyota car which the killer may have driven. Authorities believe the killer is a Caucasian male with type "O" blood.

Unknown Las Vegas Baby Doe Killer (Murder) -- On January 12, 2006, police found the body of a little girl in a dumpster outside of a Vegas apartment complex. The coroner determined that the little girl is between 3½ - 4½ years old. She had black, curly, shoulder length hair. Authorities believe she is either Hispanic, Middle Eastern or Pilipino. The little girl was found wearing pink sweat pant, a white fleece jacket covered in pink hearts. Blunt force trauma is believed to be the cause of death; she was beaten several times.

Michael J. Coppola (Murder) -- In the early morning hours of Easter Sunday, 1997, John "Johnny Cokes" Lardiere was murdered gangland style outside a hotel in Bridgewater, New Jersey. Police knew Lardiere was a member of the Genovese crime family but it would take almost twenty years for them to get a break in the case. That break came in 1996 when another mobster who had been arrested on murder and extortion decided to cooperate with authorities. The mobster told police that Lardiere's killer was Michael Coppola, who was now a top man in the Genovese organization. However, authorities knew they had little weight with the testimony of their informant so they decided to take another look at the evidence. That's when they realized that hair samples had been preserved from a hat found at the scene of the crime. The hair was sent to the FBI lab in Quantico, Virginia where DNA was successfully extracted. A judge then gave a court order for Michael Coppola to provide saliva samples on August 8, 1996. Michael Coppola never showed for his scheduled date. He has since been charged with the murder of John Lardiere. Coppola, who has used the nicknames Mikey Cigars, Filma and Little Mike, is a workout enthusiast who runs and cycles. He is very fit and muscular for his age, and as an avid golfer may be living in a warm climate. He is known to gamble. He has a thick New Jersey Accent, is well groomed and extremely neat, and may smoke a cigar occasionally. Coppola is 59, 5'7" and 160 pounds. (See Shows #697, #724 and #760, OADs 11/16/02, 6/21/03 and 4/17/04)

MISSING:

Brooke Carol Wilberger

Age: 20

Height: 5'4"

Weight: 105 pounds

Police believe that Brooke was abducted on May 24, 2004, while cleaning outdoor lamp posts outside the Oak Park Apartments. She was visiting her sister and brother-in-law in Corvallis, who are residential managers of the complex. When police arrived, they found signs of a

possible struggle leading them to believe she may have been kidnapped. Her sandals were found askew near a bucket of water. Her purse, keys, and other personal items were left in her sister's apartment and her car was still in the parking lot. Compelling evidence leads police to believe that she did not leave willingly. Brooke Wilberger just completed her freshman year at Brigham Young University. She is enrolled for next fall term to continue her studies in speech pathology. She is a graduate of Elmira High School near Eugene, Oregon. Brooke is a devout Mormon, an honor student, an athlete and described as very responsible, reliable and likeable by her friends and family. She was last seen wearing a Indigo hooded sweatshirt, a gray Brigham Young T-shirt, dark blue jeans, small hoop earrings, possibly a silver watch, a ring with "CTR" engraved on it and no shoes. Brooke has a scar on her right forearm that extends from her wrist to her elbow. She also has a piercing on the top of her right ear. Local authorities have identified Sung Koo Kim as a possible suspect. Kim has been arrested for burglarizing a dorm room at Oregon State, near where Brooke disappeared. Evidence found on Kim's person ties him to the building where Brooke was staying. Kim, however, has not been charged in connection with Brooke's disappearance. UPDATE: Authorities believe that Joel Patrick Courtney abducted Wilberger. He raped a woman in Albuquerque, NM consistent with the disappearance of Wilberger, with the exception that the victim escaped and is alive. Courtney was living near Corvallis had rented a van matching the description of a van sighted in the area at the time of Wilberger's disappearance. Hair found inside the rental van matches the DNA of Brooke Wilberger.

Amber Marie Harris

Height: 4'8" at the time of disappearance

Weight: 120 pounds at the time of disappearance

On November 29, 2005, Amber Marie Harris was last seen getting off of a school bus in Omaha, NB. A video tape from the bus shows Amber getting off the bus at 5:41pm, about 4 blocks from her home. That is that last time Amber was seen.

Dallas, Texas... ISRAEL BARRETERO CAPTURE... AMW tipsters helped authorities in Dallas, Texas bring down two accused killers -- within 24 hours. Although their cases are unrelated, accused triple-murderer Israel Barretero and alleged killer Steven Valadez now have one thing in common: lifelong infamy as AMW captures.

Sarasota, Florida... GARTH MALLOY... Police in Sarasota, Florida have been looking for a man they say sexually molested a 15-year-old boy in 2001. Police say Garth Malloy has been committing these type of crimes since 1984, and they want to prevent him from abusing other children.

Fort Wayne, Indiana... YONI AVILLA... On October 13, 2005, Yoni Avilla, Eduardo Lopez Sepulveda, and a few others gathered at an apartment in Fort Wayne, Indiana for drinks and poker. Hawthorne, California... MARK EVERETT... Little Manuel Benitez was just nine years old when he began his transformation into Mark Everett -- child star. As a kid, Everett appeared to have it all. He starred in commercials, television shows, and even motion pictures like "Pee Wee's Big Adventure," and "Stand and Deliver." But, according to police, like so many young, successful actors, Everett eventually turned to drugs and his acting career dried out. Now cops say he's a killer on the run.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

This will confirm that I have screened the air copy of the above-captioned episode and have the following comments:

Lesley Mondesir (Aggravated Battery) -- In June of 2005, Mondesir and two other men allegedly got into an altercation which resulted in one of them shooting a man in Pompano Beach, Florida. A judge ordered house arrest as part of a pre-trial release with the condition that Mondesir wear an ankle monitor. On December 31, 2005, he cut off the ankle monitor and fled. A warrant has been issued for his arrest. He has a tattoo of praying hands with the words "Lord Knows" on his right arm. Mondesir is Black, 22, 5'10" and 200 pounds

Steven Volgyi (Aggravated Battery) -- In July of 2002, Volgyi got into a fight with his girlfriend and allegedly pulled a hunting knife on her and cut her throat. In the past, he worked as an unskilled laborer. Cops say that he has a history of marijuana use. Volgyi is White, 35, 5'11" and 210 pounds.

Christopher Edwards (Parole Violation) -- At a Fourth of July party in 2002, police say that Edwards got into argument and began beating some of the party attendees with a golf club. Edwards was placed on probation. Police say he stopped reporting his whereabouts to his probation officer, a condition of his probation, on December 9, 2005. He has not been seen since. Edwards is Black, 23, 5'11" and 150 pounds.

David Cauthen (Murder) -- In the summer of 1983 Cauthen allegedly raped 16-year-old Paulette in South Carolina, a girl that he had gone out with a few times. After he raped her, he set her car on fire. When the car exploded, Cauthen allegedly commented that she was lucky she wasn't in the trunk. She was able to escape from her captor when he went into a tool shed, to

presumably look for a weapon to kill her. Cauthen disappeared before authorities could arrest him. In 1991 Cauthen returned to South Carolina and began dating Jeannie, a 26-year-old bartender. When she broke up with him, he didn't want to let go. On October 27, 1991, Cauthen yanked open her car door one night and repeatedly beat her. He jumped into the driver's seat and took off. Jeannie tried to jump from the moving car, but Cauthen had her by her hair as her feet dragged along the pavement. Jeannie says that he forced her from the car and demanded that she start digging. Jeannie tried to reverse the situation by telling Cauthen that she had made a mistake and that she loved him. It worked, she convinced Cauthen to take her to a store, when his back was turned she escaped. Cauthen was arrested and served three years for that attack, but she was not his last victim. Cauthen met Brenda Steen in 1996. The two began dating and in 1998 the couple had a baby girl. According to Brenda's family Cauthen began abusing Brenda. After Brenda ended their relationship, Cauthen went to her home with the intention of killing her on September 11, 2004. He was arrested but quickly made bail. On October 17, 2004 Cauthen allegedly stabbed her to death and put Brenda's body in the trunk of her car. Authorities say he abandoned the body in a remote area. Cauthen is a self-proclaimed handy man and enjoys working on cars; he may be working as a roofer or car mechanic. He has a chipped front tooth and a homemade tattoo of a heart on the back of his left hand and a koala bear on one leg. Cauthen is 41, 5'9" and 165 pounds.

Jesse Caron (Possible Rape; Criminal Threatening with a Firearm) -- Halloween night 2005, a female guest was allegedly drugged and raped at a party hosted by Caron. When police went to search Caron's home to investigate, they found evidence of the crime, as well as cocaine and an illegal assault rifle. On January 17, 2006, a warrant was issued. When police came to arrest Caron, he saw their approach on a surveillance camera and proceeded to hold his girlfriend hostage at gunpoint. Caron escaped through a window. He is considered armed and dangerous. Caron is 28, 6'0" and 200 pounds.

Michael Mitchell (Murder) -- Authorities say Mitchell shot and killed Varion Mines in April of 2004, after fighting with in him in the parking lot outside of a bar in Cincinnati, Ohio. Mitchell may be using the alias Flonoy Smith or Behanen Anderson. Mitchell is Black, 35, 5'10" and 225 pounds.

Leeroy Suarez (Murder, Aggravated Assault) -- On November 20, 2004, cops say Suarez stabbed Diego Saenz to death and wounded Saenz's 16-year-old brother. Police say friends call Suarez "Fish Lips" because he has big lips. He has the letters "LS" tattooed on his left hand. He may have connections to the Mexican Mafia. Suarez is 22, 5'10" and 190 pounds.

Juan Lopez (Murder) -- In August of 2005, Lopez allegedly shot and killed, Moises Ortiz Mendoza, a member of a rival gang. Lopez is believed to have ties to the MS 13 gang. Lopez has "JL" tattooed on his upper left thigh. He may be going by the alias "Lobo." Lopez is 30, 5'9" and 150-190 pounds.

Unknown Gold Coast Casino Robber (Robbery) -- Police say an unknown man robbed the Gold Coast Casino in Las Vegas, Nevada on January 11, 2006. Surveillance video show the robber firing several shots in the parking lot as he fled, one bullet stuck a security guard in the leg. The same suspect is believed to have robbed the same casino in August of 2005. Police say

the robber is black; he wore a baseball hat, wig and a sport-coat type jacket over a white T-shirt. According to police, he robbed the same casino change clerk and used the same disguise, except for the wig -- a new touch.

Unknown Simon Shanks Killer (Murder) -- Simon Shanks, former linebacker for the Arizona Cardinals was murdered by three unknown men on January 5, 2006. Shanks and his friend, Lajuris Estelle, were working out in Shanks' garage when three men in a white Ford Expedition stopped and asked for directions. According to police, when Shanks and Estelle approached the vehicle, the driver brandished a gun. Shanks and Estelle were ordered back into the garage where they were pistol whipped by the driver while one of the assailants watched and the third man went into the house. The third assailant ordered Shanks' wife, Yolanda, to stay in the bedroom with her newborn baby while the other two Shanks children slept. Yolanda ran to a neighbor's house after she and the baby escaped through a bathroom window. Simon Shanks was shot dead and Estelle was shot in the neck, but survived. The three attackers disappeared leaving no clues behind. Authorities believe another friend, Antonio Benjamin (aka Frenchie), was at the Shanks' residence on the evening in question. He took off before he could be questioned by police. Benjamin is wanted for the 2002 shooting death of a party promoter in New York. Police say that this is a case of mistaken identity and that Benjamin was the intended victim. Authorities believe the three assailants are Hispanic.

CAPTURED:

Norris Gillins (Unknown) -- Gillins allegedly beat and choked his girlfriend. When she ran out of the residence, he smashed her on the side of the skull with a brick. The suspect was apprehended by South Florida's Broward County Sheriff's Department Fugitive Squad.

Vernon Florence (Child Molestation) -- Florence was wanted for 92 counts of child molestation. Florence was apprehended by South Florida's Broward County Sheriff's Department Fugitive Squad.

Leach: Pedophile Bust (-) -- Southern Florida authorities apprehended a man preying on minors. Nicole Rossini, a Broward County Sheriff's Officer, pretended to be a 14 year old girl on the internet to capture possible pedophiles. The suspect claimed to be 24, in actuality he was 52. Agent Rossini says that during their online sessions, the suspect asked "her" out to dinner, a movie, and a hotel to make love. He allegedly propositioned her to skip school, that he would bring the wine coolers and condoms. When the suspect went to the parking lot, as planned during their online chat, he was arrested by authorities. The suspect was found with condoms and various pills in his possession.

Peter Hommerson (Arson, Murder) -- On January 23, 1996 firefighters battled an arson blaze at the home of Marvin and Kitty Lichtman. Their bodies were found in the rubble, but they had died of gunshot wounds before the fire started. Hommerson, a local handyman and glass installer, had known and worked for the couple for years. Police speculate that Hommerson killed Kitty Lichtman, looted the multi-million dollar house, killed Marvin when he arrived home, then set the fire to cover his crimes. Hommerson has been charged with murder. He is believed to have fled into Mexico, but may have returned to the states. Hommerson is a native of

Hungary who used to go by the name Lajohs Farengi. He speaks English with a thick accent. He also speaks Italian, German and Hungarian. Hommerson may have died his brown hair black. He has a distinctive line tattoo on his left wrist, which he tries to hide under his watch. Hommerson is an outdoorsman and should be considered armed and dangerous. He is 60, 6'0" and 220 pounds. (See Shows #407, #424, #454, #654, #669, #749 and #801, OADs 4/27/96, 8/31/96, 6/16/97, 11/10/01, 3/23/02, 1/17/04 and 4/2/05) UPDATE: Two separate tipsters told authorities that Hommerson was running a restaurant and bar in Ixtapa, Mexico. FBI agents passed this information on to the Mexican authorities since they had no arresting powers in Mexico. An operation was set up to arrest Hommerson, but the restaurant was abandoned right before the plan to move in on Hommerson was put into action. Two months later, the restaurant mysteriously reopened. Hommerson was finally apprehended on August 10, 2005.

Jack Wiley (Rape)

Glenna Faye Marshall (Child Abuse) -- On January 15, 2006 a woman in a convenience store in Evergreen, Alabama noticed a little girl with a suspicious older man, Jack Wiley. The woman jotted down the license plate number of the SUV the man was driving. Her suspicions were warranted. When Wiley and Marshall were questioned by the authorities about the two children living with them, a 3-year-old girl and a 17-year-old boy, the couple's stories didn't match. Upon further investigation, police were able to charge Wiley and Marshall with multiple sex crimes against the two children found in their trailer. Both Wiley and Marshall are in custody.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

This will confirm that I have screened the air copy of the above-captioned episode and have the following comments:

Michael Bohannon (Murder) -- According to police, Bohannon and Adornous Hazelwood had a physical confrontation on April 1, 2002. Bohannon allegedly shot Hazelwood in a daytime execution style murder in Roxbury. Bohannon is 22, 5'9" and 135 pounds.

Unknown Polly Ester's Nightclub Killer (Murder) -- Authorities say on August 15, 2001, an unknown man came into the Polly Ester's nightclub during daytime hours and shot both the manager and the assistant manager. The manager, Todd Thomasco, was killed. The killer is described as a male between 5'8" and 5'9" with a heavy build.

Juan Carlos Gutierrez (OWI Causing Death) -- On February 20, 2005, while allegedly driving under the influence, Gutierrez struck Ramonda Washington's vehicle. Washington died almost instantly. Gutierrez fled before formal charges could be made. Gutierrez is 22, 5'8" and 180 pounds.

David Longberry (Forcible Child Rape) -- Authorities believe Longberry raped a friend's 11-year-old granddaughter. Longberry may be working as a truck driver and using the alias James Witlatch. Longberry is 64, 6'0" and 225 pounds.

Sherry Halligan (Murder) -- On November 26, 2005, Halligan allegedly shot her boyfriend, Dennis Campbell, to death when he tried to end their relationship and cut her off financially. She has three previous arrests for prostitution and may be using the alias Denise. Halligan is 47, 5'5" and 110 pounds.

Otto Espinoza (Murder) -- Authorities say Espinoza got into an argument with Omar Simmons because he parked in Espinoza's private parking space. Espinoza allegedly pulled out a handgun and shot Simmons in the head. Espinoza is 37, 5'5" and between 121-140 pounds.

Robert Howell (Aggravated Rape) -- Cops say that Howell broke into a woman's home and raped her at gunpoint during the home invasion. Howell is 34, 5'6" and 180 pounds.

Kurt W. Thompson (Armed Robbery) -- Authorities say that on July 10, 2005, Thompson severely beat a 16-year-old boy for his cell phone. The victim required 16 stitches as a result of the lacerations to his eye. Thompson is 20, 6'0" and 170 pounds.

Nathaniel Robinson (Cocaine Trafficking) -- Robinson was allegedly involved in a drug operation before he took off running from authorities. Police obtained a search warrant; in his home they uncovered an illegal firearm and various narcotics. Robinson is 41, 6'0" and 230 pounds.

Kendall Petty (Assault & Battery with a Deadly Weapon) -- On July 17, 2005, Petty allegedly threatened to kill his former girlfriend by putting a gun in her mouth during an argument. She was able to flee before she was seriously injured. Petty is 39, 6'0" and 250 pounds.

Andre "Mac Minister" Dow (Murder) -- Police say this West coast rapper is wanted for the deaths of rappers Anthony "Fat Tone" Watkins and Jermaine "Cowboy" Atkins. The murders allegedly occurred on May 23, 2005 after attending a Snoop Dogg concert in Las Vegas. Dow is 35, 5'8" and 165 pounds.

Jean & Walter Lampron Killers (Murder) -- On December 2, 1984 Walter Lampron was gunned down behind a gas station 3 or 4 blocks from his house. The reasons for the murder and the identity of his killer are unknown. Walter's mother Jean was the glue that held her family together following her son's death. At the age of 68, she walked a half mile to catch the bus to go to work. On October 14, 2005, an unknown suspect tried to mug Jean just four blocks from where her son was murdered. The mugger tried to steal her purse, while riding by on his bike, but Jean didn't give up without a fight. Jean suffered a ruptured spleen as a result of fighting off her attacker. She was able to flag down a passer and call 911. Shortly after the call, Jean suffered a heart attack and died a day later. The bike the assailant used was a Magna 15 speed metallic brown girl's bike. The bike is missing the right foot pedal. Authorities believe the bike was either stolen from the area or borrowed from a neighbor or relative. The assailant wore a long black coat and a tan baseball hat. He is described by the authorities as light-skinned.

Eric Salazar (Assault with Intent to Murder) -- Cops say that on December 30, 2005, Salazar entered a crowded hip-hop clothing store and shot Erick Zhanay in the stomach. Zhanay survived the shooting. Salazar's age is unknown, but he is 5'6" and 180 pounds.

Unknown Kathleen Ann Mayer Killer (Homicide) -- Mayer, 14-years-old, was walking to a baby-sitting job in her neighborhood when she was struck and killed by a hit-and-run driver on February 7, 1981 in Westford, Massachusetts. According to Mayer's brother, now a sergeant with the Westford Police Department, the driver was probably not traveling more than 30 mph due to the lack of skid marks or the sound of screeching tires.

Pierre Louise Sandley (Gun Charges) -- Sandley is wanted on gun charges and for allegedly badly beating two cops. He was apprehended by Boston authorities. Sandley is 24 years old.

Jack Wiley (Rape)

Glenna Faye Marshall (Child Abuse) -- On January 15, 2006 a woman in a convenience store in Evergreen, Alabama noticed a little girl with a suspicious older man, Jack Wiley. The woman jotted down the license plate number of the SUV the man was driving. Her suspicions were warranted. When Wiley and Marshall were questioned by the authorities about the two children living with them, a 3-year-old girl and a 17-year-old boy, the couple's stories didn't match. Upon further investigation, police were able to charge Wiley and Marshall with multiple sex crimes against the two children found in their trailer. Both Wiley and Marshall are in custody. (See Shows #836, OADs 2/4/06) UPDATE: Marshall stated in an interview with AMW producers that it all started twenty years ago when she met Wiley in Lansing, Michigan at a truck stop. She admitted that she and Wiley worked the truck stops, and that she occasionally prostituted herself. While she was working as a stripper, Marshall stated that Wiley propositioned her to have sex with him and a boy. Marshall recalls a time when she and Wiley came across a young woman with an 11-year-old daughter. Marshall claims that Wiley admitted to having sex with the 11 year-old girl. Authorities cannot confirm whether any of Marshall's stories are true. While Jack denies any sex charges, he admits that he is not the most honest citizen. Wherever a disaster hit, the pair would follow scamming their way into free cash and living arrangements. The pair sold key chains at NASCAR races. They may be the key to uncovering their past.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

This will confirm that I have screened the air copy of the above-captioned episode and have the following comments:

Eric Rosenstrom (Murder) -- Rosenstrom worked as a death investigator for the Dallas County Medical Examiner's Office and wrote crime novels in his spare time. He had an impeccable resume. He also liked to control situations, even during investigations, despite the fact that he wasn't a registered Sheriff's Deputy. Rosenstrom claimed to have played for professional football in Canada, but after a miserable performance in a practice game, the Sheriff began to have doubts about his employee. Upon further investigation, it was uncovered that Rosenstrom had fabricated his resume. Rosenstrom landed a job as a desk clerk at the Hunts Castle Hotel in Rockport, Texas. He worked his way up to general manager by using his people skills. He was fired from his position by the owner, Erik Lower, when he demanded payment for alleged back wages. Rosenstrom took refuge at the home of another employee who had been terminated, Mike Garland. Garland says that Rosenstrom laid out a detailed description of how he was going to kill Erik Lower. Garland also claims that Rosenstrom threatened his life in an attempt to keep Garland from reporting him. On August 16, 2001, Rosenstrom put his plan into action. Garland informed authorities that he believed a murder had been committed after he called the hotel and no one answered. Rosenstrom has not been seen from since. He may be passing himself off as a retired police officer or writer. Rosenstrom 45, 6'0" and 195 pounds.

Yazeed Essa (Murder) – Essa's wife lost control of her SUV. Although little damage was done, she died shortly later at a local hospital. When questioned about his late wife's medical history, Essa, an ER doctor, informed police that he encouraged her to take calcium pills. A crime lab analysis determined that the capsules had been tainted with cyanide. After speaking

with police, Essa allegedly dropped off his children with relatives and has not been seen since. Essa likes to smoke cigars and enjoys body building. Essa is 37, 6'2" and 215 pounds.

Marlon Morris (Rape) -- On November 18, 2002 Morris allegedly raped a thirteen-year-old girl for over two hours. Morris disappeared from a Massachusetts court house just before the jury returned its verdict, finding him guilty on seven of the nine charges he was facing. Morris has a very distinctive mole between his eyebrows. Morris is 29, 6'1" and 170 pounds.

Cecil Allen (Vehicular Homicide) -- Arkansas authorities say Allen was driving a truck from the carnival where he worked, when he struck another vehicle in a head on collision. Allen fled the scene and the driver died as a result of injuries. Allen is 33, 6'0" and 160 pounds.

Jose Manuel Torres Miranda (Murder) -- North Carolina authorities say that Miranda stabbed to death a 75-year-old man in his home. Miranda may wear a glove on one hand to cover scars from being burned. Miranda is 24, 5'6" and 234 pounds.

Unknown Tony Jones Killer (Murder) -- The evening of October 20, 2003, Tony Jones was at home watching his two sons. Believing it was his wife, he allowed his son to open the door when the buzzer rang. Unfortunately, it wasn't his wife. Jones was shot by a disguised assailant in front of his six year old. Jones' son recalls the man asking "Where's the money?" The boy called 911, but the operator was unable to directly track the call because he was using his father's cell phone and he didn't know his address. The operator asked him what school he went to and authorities rushed to the school to locate his address, but it was too late to save Jones. Authorities believe the assailant may have known Jones because wore a disguise.

Ernest Ferguson (Murder) -- On January 20, 1992, Ferguson went to warm up his car and was shot close range in the face. He survived the shooting but was scarred. Police never found the shooter. Ferguson had been convicted of manslaughter. After serving time, Ferguson wanted to seek his own justice against the person who shot him. Someone informed him that Brian Whitsey was responsible for the shooting. On August 5, 2005, Massachusetts authorities say Ferguson shot and killed Brian Whitsey. An investigation of the victim, a hard working, married man with five children led authorities to believe that he was not involved in Ferguson's shooting and that he had been given some wrong information. Ferguson has had noticeable extensive reconstructive surgery on the left side of his face. Ferguson is 33, 6'1" and 197-210 pounds

Charles Randall Brunson (Parole Violation, Failure to Register as a Sex Offender) -- In 1987, Charles Randall Brunson was sentenced to 35 years in a Texas prison for shooting a man to death and injuring a young woman who was caught in the crossfire. But, three years into his sentence, Brunson was released on an appeal bond. Outside of prison, police say Brunson continued his violent behavior. Brunson returned to his family and began to repeatedly sexually assault his own four-year-old daughter. Brunson was arrested, convicted of aggravated sexual assault of a child, sent back to prison, and was later paroled and monitored with an electronic tracking bracelet in March 2000. On November 19, 2000, authorities from the Texas Department of Criminal Justice Parole Division received a "tamper alert" from their fugitive GPS tracking system, indicating that something was wrong with Brunson's tracking bracelet. Officers rushed to Brunson's address in Del Valle and found that he had somehow cut off his tracking bracelet and skipped town. Warrants were immediately issued for Brunson's arrest due to his parole violation. Brunson has not surfaced since leaving the Austin area in November 2000 and he has not registered as a convicted sex offender as required by law. Brunson has a scar on his abdomen, upper left arm and left thigh. He has a tattoo of a skull with playing cards on his left chest, a lion head on his left shoulder, a skull with a hat and bandana on his right shoulder and a "mural-sized" tattoo of naked woman on his back. Brunson's Texas driver's license has been revoked. He has worked as a laborer installing drywall and has possibly done surveillance or security work at construction sites and apartments. He may be making leather crafts and jewelry. Brunson is 38, 6'2". (See Show #823, OAD 9/24/05) UPDATE: Brunson was living in the Mexican village of Chapala as a welder. Brunson began working for a retired Canadian couple residing in the

village. Shortly after beginning work, Brunson asked the couple for money and if he could live in their home. He told the couple that he had killed a man in self defense, was paroled and sentenced to life with a tracking device. He further explained to the couple that he cut off the device and was on the run. What Brunson didn't know was that the husband was a retired Royal Canadian Mounty. The couple quickly did an internet search and learned that Brunson was a convicted pedophile. After the couple's tip to AMW, US Marshals and Mexican Immigration officials set up surveillance and Brunson was arrested. The retired couple had truly found a needle in a haystack because Brunson had lost so much weight that he didn't look anything like the photos authorities had of him.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Karl Goeke (Child Sexual Abuse, 2nd Degree Sex Offense) -- Paul McLaughlin was 33 years old, with a wife and children, when he had a flood of memories that brought him back to his youth. From about age 11 to 15, Paul had been sexually abused by Karl Goeke and his two associates, Donald Acheson Smith and John Neisworth. The acts against Paul were so horrific and monstrous that he blocked out the painful memories. Back in the early 1980s, Goeke told Paul's parents he was a school counselor and an expert chess player. He convinced them that he should tutor and teach Paul chess. Once alone with Paul, Goeke began supplying him with alcohol and drugs. Officials say when Goeke started to molest him, he threatened he would tell his school friends that Paul was gay if he told. He also lied to Paul, telling him that he could have the state take him away from his parents. As the abuse continued, Goeke introduced Paul to Smith and Neisworth. Neisworth was a professor at Penn State University. The three men would take Paul on trips to various places in Delaware, New Jersey, Pennsylvania and Maryland. During these trips, Paul was subjected to many heinous sex acts. The abuse finally ended when Paul turned 15 and the family moved. After seeking treatment for his mental condition, Paul decided to seek justice. After he got in touch with Delaware authorities he was told that the statute of limitations had run out. Refusing to give up, Paul contacted authorities again and found out that he was given wrong information. The statute of limitations hadn't expired in Maryland. When Paul was told that his accusations could be easily dismissed, he used his experience as a private investigator to gather information. Paul called Jack Neisworth who admitted to molesting him. During the conversation, Neisworth also implicated Don Smith. In May of 2001 Paul called Goeke. During a half-hour conversation, Goeke admitted that he had a sexual relationship with Paul. But what Goeke did not know was that Paul was secretly taping the conversation as evidence to tell his story. To strengthen his case, Paul found another victim and was able to convince him to come forward. With the victim's statement, authorities in Maryland were able to press charges against Goeke, Neisworth and Smith. Neisworth and Smith

were arrested in September 2005 and will go to trial in April 2006. Goeke was tipped off and avoided arrest. Goeke is openly gay and may try to pass himself off as a comedian or he could be working as a cook somewhere on the west coast. He is an admitted drug and alcohol addict. He may speak German and has been known to color his hair red, purple, pink and blond. He claims to take medication for a seizure disorder brought on by years of alcohol abuse. Police traced Goeke to San Francisco last November and to the Comedy Store in Los Angeles in January, 2006. Goeke is 59, 5'7" and 140 pounds.

John Michael Manard (Escape)

Toby Young (Aiding and Abetting Aggravated Escape, Aiding a Felon) -- Toby Young ran a program called Safe Harbor. The program brings abused and abandoned dogs into prisons to help inmates learn compassion by training the animals so that they could be adopted. In August 2004, Safe Harbor began operating out of the Lansing Correctional Facility in Kansas. During her work at the prison, Toby met a convict by the name of John Manard. Manard was serving a life sentence for a carjacking that ended in murder. While the extent of their relationship is unclear, Toby Young and John Manard became close friends. According to authorities, in the week leading up to February 12th, Toby Young rented a storage space in Bonner Springs, Kansas. They also say that she withdrew more than \$10,000 from her bank account. Finally, authorities say she took two handguns from her house, a black 9mm Glock and a silver AMT .380. On Sunday, February 12, 2006, a number of inmates helped stuff Manard into a crate used for transporting dogs. Then, they lifted the 190-pound convict into a Safe Harbor van. From there, they say Young simply drove away. The following Tuesday, police acted on a tip and located a storage facility Young rented and found the abandoned van that was used in the escape. Both Young and Manard were gone. The latest information says the two may have purchased hair coloring and razors so they could look much different than the pictures. Also, a witness says Young may have been seen in a blue Chevrolet SUV in the week leading up to the escape. Police say she has a thyroid condition and takes medication daily. She suffers from back and neck pain and sees a chiropractor regularly - usually a couple of times a week. She might be wearing a wine-colored nylon down vest and tan "Uggs" boots. She has a thyroid surgery scar at the base of her neck that looks like a tracheotomy scar. She has significant scarring on her left wrist, just below the thumb from a severely broken wrist. Young is 48, 5'1" and 130 pounds. John Manard goes by the name Leo Manard and the nickname "Hooligan." He has hazel eyes and may have dyed his hair brown or black. Manard is 27, 6'2" and 190 pounds.

Unknown Cowboy Ray Killer (Leaving the scene of a fatal accident) -- Erich "Mancow" Muller is often called a rival to Howard Stern. He's the star of his own radio show, Mancow's Morning Madhouse, which is produced in Chicago and aired in more than 20 markets. Mancow's show features celebrity interviews, parody songs, prank calls, and lots of bantering. It's the bantering that seemed to attract the man who would ultimately become one of Mancow's most beloved sidekicks. In 1996, a man calling himself Cowboy Ray called in to the show and told listeners he was a cowboy on a ranch in Santa Fe. But in reality, Cowboy Ray was mild-mannered Ray Hofstatter who called the station from his mother's basement on the South Side of Chicago. Improbably, it was the beginning of a long friendship between Mancow and Cowboy Ray. Ray became such a popular caller that Muller brought Cowboy Ray into the studio for weekly radio segments. Hofstatter quickly became part of the morning show family and developed a special bond with Muller. Ray dug karaoke, cuckoo clocks, nut crackers and Jesus.

Chicago fell in love with "Cowboy Ray," but he never understood how popular he was to radio listeners. He just wanted to talk about "Dark Shadows" (an old TV show) and Sofia Coppola. Part of Cowboy Ray's charm was that no one knew what topic he'd be on next. But equally unpredictable was what happened to the beloved radio star on Nov. 20, 2005. Police say Cowboy Ray left the Bohica Bar & Grill on Chicago's Southwest Side around 3:45 a.m. While crossing the street near the 5500 block of South Archer he was struck by a speeding car. The driver allegedly sped off; leaving Ray sprawled on the ground with multiple injuries. Hofstatter spent several weeks in the hospital until he died on Jan. 10, 2006 - less than two months after the hit-and-run accident. According to witnesses, the driver was a petite, dark-haired woman who was speeding in a dark-colored car - possibly a Honda Civic. They say the impact of the hit threw Hofstatter into the air and knocked off his coat, sweater, pants and shoes. Witnesses also say two or three other passengers were in the vehicle that struck Hofstatter. No skid marks were found at the accident scene, indicating that the driver never slowed down or stopped after hitting Hofstatter. Mancow Muller is devastated by the loss of his old friend, and he's determined to find justice for him.

Salvador Ochoa (Reckless Homicide) -- On Dec. 10, 2005, 2-month-old Rubi was inconsolable. At about 10:30 p.m., her mother went into the bathroom leaving the crying premature infant with Salvador Ochoa. When Rubi would not stop crying, Salvador allegedly let his frustration get the best of him. According to officials, he punched Rubi in the abdomen, delivering enough blunt force to perforate her bowels. The next day her mother took her to the hospital where doctors performed surgery in an attempt to save her life. Sadly, Rubi went into multi-system organ failure. She died on Dec. 12, when her stomach, kidneys, intestines and uterus stopped working. Even worse, autopsy results showed that Rubi had a broken rib and skull fracture as well. Police say Ochoa fled when he found out they had ruled his daughter's death a homicide. Salvador Ochoa uses the aliases Salvador Ochoa-Lopez, Salvador Lopez-Ochoa, Luis Benitez, Alejo Betancourt, Rene Ochoa, Raphael Ochoa, Salvador Lopez, Jorge Ochoa, Manuel Ochoa, Raul Ochoa and Ramon Ochoa. Police believe that he may be in the United States illegally and that might seek employment doing manual labor. He is known to wear a mustache or goatee. Marshals say that Ochoa was last seen in Milwaukee, Wisconsin, but he could have fled anywhere. He's 30, 5'6" and 180 pounds.

Jonathan Clowers (Murder) -- Police in Jacksonville, Florida say that Jonathan Clowers shot his ex-girlfriend, Tiffany Satchel, when she came to pick up their one-year-old son. The routine meeting took place at the Lighthouse Bay Apartments - a neutral meeting site. At some point Jonathan and Tiffany got into a heated argument which turned violent. When Tiffany finished strapping their son into his car seat, Clowers shot her to death in the parking lot of the apartment complex. A murder warrant was issued for the arrest of Jonathan Clowers, but he managed to flee to Fort Lauderdale, where he has relatives. Police believe he may have lost some weight and grown a beard. Clowers is 27, 5'11" and 145 pounds.

Thomas Gilbert Longo (Possession of Firearms) -- From 1975 to 1999, Thomas Gilbert Longo was a prominent and successful attorney and prosecutor in Ohio. However, this well-known lawyer became the center of a series of sex and drugs charges, which disappointed the community of Solon, Ohio. Longo was charged with Gross Sexual Imposition for allegedly using a date rape drug on a woman who attended one of his parties. Longo pleaded guilty to the

charge. When police searched his home in connection with the sex and drug charges, they found 16 firearms, including an unregistered machine gun, and 3 silencers. Longo disappeared during the search. Police believe he planned to escape before he was indicted for the firearms charges. Police also say that Longo has written documents to start businesses under different names, such as Thomas G. Colpa. In addition to skirting the legal system, police say that over the years, he made connections with loyal, powerful people. Police believe they may be helping him now that he's a fugitive - such as a doctor who may be treating his chronic bladder infection. Longo enjoys parties and bars and that he also enjoys fishing. This wealthy man has enough money to move from one place to another, even internationally. Police say he has ties to Florida and Ohio but also to other countries. His son used to live in Italy and now lives in Japan. Police say that Longo has been to those places, but they also say that he has also traveled to Mexico for medication. His aliases include the names Thomas G. Colpa and Thomas G. Colpa-Longo. He is 61, 5'10" and 200 pounds.

Neil Stammer (Criminal Sexual Penetration, Criminal Sexual Contact of a Minor, Kidnapping) -- Neil Stammer has traveled the world as a juggler, but in the late 90's he settled in Albuquerque, New Mexico. He owned and operated a magic and juggling shop. His store Roy's Magic and Juggling Shop was a magnet for Albuquerque kids. Every Friday, kids from the neighborhood would descend on the shop after school. Stammer would host free juggling lessons and tell the kids his stories of juggling in circuses and traveling the world. Kids were enthralled with his stories. Stammer also ran a juggling club that would meet once a month at the University of New Mexico. A large number of people involved in the club were adolescent boys. According to police, Stammer would have some of the boys help him clean up the store after it was closed. In May of 1999, one of the boys who was in Stammer's juggling club and helped out at the store was able to build up courage to tell his family a horrible secret he had been keeping from them. The 13-year-old boy told his parents that he had been molested a couple of times, but he was too afraid to tell anyone. He said Stammer had threatened him. His family immediately called police. During the investigation, police say, a couple of other children came forward and said Stammer had done the same thing to them. Police charged Stammer with several counts of child abuse after interviewing the children. Before police could arrest Stammer, he fled, leaving his beloved business behind. Police have discovered Neil Stammer's name was Andrew J. Allen, but legally changed it. They believe he could be going by Andrew Allen. Stammer learned several languages while traveling as a juggler, so they believe could be hiding anywhere. The families of the victims and police fear wherever Stammer is hiding, he could be harming more children. Stammer is 38, 5'10" and 160 pounds.

Victor Edward Willis (Possession of Narcotics) – Police in California are looking for a former member of the popular music group the Village People. Victor Willis was arrested in Daly City, California after being caught with a large amount of crack cocaine and a loaded semiautomatic handgun. Willis pleaded no contest to the charges and bailed out on a \$100,000 to await sentencing. Willis co-founded the Village People in 1977. He co-wrote and sang lead on the band's biggest hits, including "YMCA," "Macho Man" and "In the Navy," where he was known as the Cop. Willis left the band in 1979 and his life began to fall apart in the early 90's when he faced a drug possession conviction and was acquitted of rape in 1993. Prosecutors say Willis was already on probation at the time for a 2003 drug conviction. When Willis missed his sentencing hearing on October 20, 2005, a California judge issued a warrant for his arrest. Willis had reportedly contacted his attorney the day before to inform him that a dental

appointment presented a conflict with his court appointment. After about three months as a fugitive Willis secured a new attorney and, according to that attorney, arranged his surrender. The place was the San Mateo County Superior Court. The date was January 25, 2006. A small crowd gathered to catch sight of the former "cop" but they left disappointed when once again, Victor Willis was a no show. He is 54, 5'11" and 185 pounds.

James Robert Loomis (Probation Violation) -- Authorities in Texas are searching for a man who was convicted of raping a 6-year-old girl back in 2003. James Loomis was given 10-years deferred adjudication probation and was ordered to register as a sex offender. In February 2006, authorities in Shelby County, TX learned that Loomis was living in a home with three young children - a violation of his probation. Before police could arrest him, Loomis took off. Police believe he's on the run with his girlfriend, 22-year-old Rachel Yarbrough, and her two boys, ages 5 and 3, and a 10-month-old girl. James Loomis is known by the nickname "Hacksaw." He is 21, 5'10" and 185 pounds.

CAPTURED:

David Rollins Cauthen (Murder) -- In the summer of 1983 Cauthen allegedly raped 16-year-old Paulette in South Carolina, a girl that he had gone out with a few times. After he raped her, he set her car on fire. When the car exploded, Cauthen allegedly commented that she was lucky she wasn't in the trunk. She was able to escape from her captor when he went into a tool shed, to presumably look for a weapon to kill her. Cauthen disappeared before authorities could arrest him. In 1991 Cauthen returned to South Carolina and began dating Jeannie, a 26-year-old bartender. When she broke up with him, he didn't want to let go. On October 27, 1991, Cauthen yanked open her car door one night and repeatedly beat her. He jumped into the driver's seat and took off. Jeannie tried to jump from the moving car, but Cauthen had her by her hair as her feet dragged along the pavement. Jeannie says that he forced her from the car and demanded that she start digging. Jeannie tried to reverse the situation by telling Cauthen that she had made a mistake and that she loved him. It worked, she convinced Cauthen to take her to a store, when his back was turned she escaped. Cauthen was arrested and served three years for that attack, but she was not his last victim. Cauthen met Brenda Steen in 1996. The two began dating and in 1998 the couple had a baby girl. According to Brenda's family Cauthen began abusing Brenda. After Brenda ended their relationship, Cauthen went to her home with the intention of killing her on September 11, 2004. He was arrested but quickly made bail. On October 17, 2004 Cauthen allegedly stabbed her to death and put Brenda's body in the trunk of her car. Authorities say he abandoned the body in a remote area. (See Show #836, OAD 2/4/06) Thanks to AMW viewer tips, David Cauthen was captured in Covington, Louisiana only five days after his profile aired.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Rafael Andres (Grand Theft 3rd Degree, 1st Degree Murder, Burglary with Assault or Battery, Arson) -- On Sunday, January 24, 2005, a woman's dead body was pulled from a burning apartment in Miami-Dade, Florida. When detectives arrived at the scene, they discovered evidence which suggested that the woman was murdered prior to the fire. The victim was identified as 31-year-old Ivette Farinas. Police say she had been severely beaten and stabbed. An eyewitness provided detectives with a partial description of a man she saw leaving the victim's home the day of their murder. He was described as a tall man with bushy hair and a stocky build. When the description of the man ruled out Farinas' boyfriend as a suspect, they began to investigate a handyman named Rafael Andres after they learned he had keys to Farinas' home. According to investigators, Andres admitted he had been in Farinas' home, but said he had left to go to another job after replacing an electrical switch. When they looked into Andres' story, it didn't check out - there wasn't a replaced switch and Andres hadn't showed up at his next job. Police believed Andres was Farinas' killer and began to obtain key evidence to prove their case. During an interview they took photographs of fresh bruises and cuts on Andres' hands and arms and collected DNA samples. Farinas' father gave police his daughter's bank statement which helped them to obtain evidence which proved that Andreas used the victim's bank debit card to purchase power tools at a Miami Home Depot days after her murder. Later, DNA results confirmed that his blood was on a bloody wash cloth that was found at the crime scene the day of the murder. By the time police were able to issue a warrant for Andres' arrest, he was gone. Andres has a birthmark on the back of his neck and several tattoos including a joker and the word "Gorila" on his back; a Latin Kings gang symbol (a crown) on his chest; a shark on his right arm and a snake tattoo on his left arm. Andres is a handyman who likes to gamble and is known to use cocaine. He doesn't like to show his tattoos when he works, so he usually wears a tank top with a long sleeved shirt on top. He has bushy hair and a stocky build. He may not like to talk

about his past - he was charged with the first-degree murder of another woman in Miami in 1987. Andres is 41, 6'1" and 260 pounds.

Alan McLean Carter (First Degree Reckless Homicide While Armed, First Degree Reckless Injury While Armed) -- On May 2005, Alan Carter shot a neighbor's friend, Brian Gibbs, and wounded a female victim following a heated argument at an apartment complex in Milwaukee, Wisconsin. According to police, Carter left the scene after the shooting. The female victim survived however, Brian Gibbs died from his wounds. Cater Police say Carter has at least four different looks (haircuts) which might make the search difficult. Alan Cater is as Patrick. Although he is described as being very quiet, he has a violent temper. Cater has a small scar on his face by his right eyebrow and scars on his left thigh, wrist and arm. He is 30, 6'0" and 170 pounds.

Fred Alba Wert (Aggravated Assault, Murder) -- Joann Antone had always wanted to work for a carnival. Her dream came true when she started working for one that was traveling around the Midwest. While on the road, she met and fell in love with someone who had the same passion - Fred Wert. The two hit it off and started dating. After a year on the road together, Fred and Joann started talking about marriage. When Joann got pregnant, it was time to settle down, so she and Fred moved to Michigan. But Fred became restless at home and wanted to go back to his traveling ways. Shortly after the baby was born, he hit the road with the carnival again. Wert was hardly ever home and Joann says that when he was, Wert was abusive. Joann couldn't take it, so she made him move out. The only time Wert came around was for the occasional visit with his daughter. Joann tried to move on with her life. She started dating a childhood friend, Mark Spencer. As the two got closer, Wert became jealous. When Wert realized Joann was in a new relationship, he flew into a jealous rage. On March 1, 1993, Wert went to Joann's house and cut the phone lines. He then started banging on the door to get in. That's when police say Mark Spencer went outside to try to calm Wert down. As Mark walked out the door, Wert shot him in the chest. Mark died a few minutes later in Joann's arms. In the chaos, Wert was able to disappear. There was no sign of Wert until June, 1997. A man named Billy Ray Shugart was arrested for the rape of his girlfriend's daughter. Police fingerprinted him and released him out on bond. Shugart's prints turned out to be Fred Wert's, but he disappeared before police could arrest him. Wert could be anywhere, but police believe that he's possibly working as a truck driver or with a carnival. Police are hoping someone will recognize his tattoos and turn him in, before he hurts anyone else. Fred Wert is as known as Billy Ray Shurgart and "Highway." He bites his lip and has a scar from it. He has several tattoos which include two hammers with the word "Carnie Power" on his right arm; a skull with wings on his left arm; "Cheryl" on his chest and "Highway" on his right shoulder. Wert is 46, 5'8" and 170 pounds. (See Show #829, OAD 12/03/05)

Patty Ann Kenley

Phillip J. Kenley (Aggravated Sexual Assault Of A Child, Unlawful Flight to Avoid Prosecution) -- Police in Collin County, Texas say Patty Ann Kenley and her husband Phillip are pedophiles. According to authorities, between April and June 1997, Patty sexually assaulted an 11-year-old boy in her husband's presence. They say Phillip simply watched, allowing the disgusting sex crimes to take place. On June 13, 1997 arrest warrants were issued and the Kenleys were taken into custody later that day. However, like so many other criminals, they posted bond and didn't show up for their scheduled court date. Police believe the pair fled together and may still be traveling together, but they also say it's possible they've parted ways.

Now, both are wanted for sexual assault and unlawful flight to avoid prosecution. Police believe they may have ties to Springville, Ark., but could be anywhere. Patty, who is also known as Pattyann Hutson Kenley, has a small scar on her left buttock and a scar on her right leg. Patty Kenley is 37, 5'8" and 200 pounds. Phillip has an unknown tattoo on his right arm. He has previously worked for a waste management company. Phillip Kenley is 40, 6'0" and 175 pounds. (See Show #828, OAD 11/26/05)

Roman Saldarriaga (DUI Manslaughter) -- Police in Florida are trying to track down Roman Saldarriaga. Saldarriaga is a young teen who they say was driving drunk when he slammed into another car, killing the driver. On September 1, 2003 Saldarriaga was on his way to a friend's house in Naples, Florida when he lost control of his car and hit another car. Janelle Hail, a mother of two, died at the scene, entangled in the wreckage of the crash. At the scene of the crash, investigators found empty beer cans inside Saldarriaga's car. When police asked him about the evidence they found, Saldarriaga confessed that he had five or six beers and gave a blood sample. When the results came back, they weren't surprised. Saldarriaga's blood-alcohol content was more than twice the legal limit. However, before police could arrest him, Saldarriaga managed to take off and he hasn't been seen since. Saldarriaga may be in Colombia where he has family. Saldarriaga is 22, 5'8" and 170 pounds. (See Shows #82 and #829, OADs 9/10/05 and 12/03/05)

Unknown Mesa Mass Murderer (Murder) -- Police are investigating the murder of five people in Mesa, Arizona and their killer, whose identity is unknown. On February 21, 2006 the Mesa Police Department responded to 911 calls reporting multiple gunshots in one of Mesa's upscale neighborhoods. Police responded within minutes and discovered five bodies (three adults and two children) in the residence. The victims were identified as Steven Duffy, his brother Shane Duffy, Tammy Lovell, and her two children, Jacob and Cassandra. Police say Steven Duffy was Tammy Lovell's boyfriend, and Shane Duffy was dating Cassandra Lovell. Police canvassed the neighborhood and conducted interviews, but there were no eyewitness accounts of anyone leaving on foot or suspicious vehicles in the area around the times of the gunshots. There was no sign of forced entry into the home and the doors and windows remained intact. Investigative leads determining a motive and possible suspects are currently underway. Police have noted that Tammy Lovell and Steven Duffy were informants in an arson case against Duffy's former employer, William Craig Miller. While Duffy was involved in the alleged arson, police say that he and Lovell helped investigators build the case against Miller. Miller has been identified as an investigative lead. Ballistic, fingerprint, and DNA evidence were collected at the crime scene and are currently being processed. The Mesa Public Safety Foundation has issued a \$6,000 for information leading to an arrest or indictment in this case.

Unknown Al Kite Killer (Murder) -- When 20-year veteran detective Tom Sobieski arrived on the scene of a homicide on May 24, 2004, he knew he had his hands full. The victim, 53-year-old Al Kite had been tortured and ultimately stabbed to death. Kite's body was found in the basement of the townhouse he owned in Aurora, Colorado. During the investigation detectives learned that in the week's leading up to the murder, Kite had been looking for a roommate to help pay his mortgage. Just days before the murder, he'd apparently found an interested person. Authorities became suspicious of this likely tenant when he mysteriously disappeared after the murder. Detective Sobieski identified the roommate as Robert Cooper from

a rental form. Although the form contained information which might lead him to Cooper, Detective Sobieski later learned that information was falsified. When Sobieski learned that the killer used Kite's ATM card shortly after the murder, the lead went cold when he could not identify the suspect from the surveillance stills from the bank - the suspect wore a mask. Another potential lead came from cell records from the killer's phone. Police tracked the phone's activity all over Denver. But once again, the killer was one step ahead. Apparently after the murder, the killer intentionally left the phone in an area where homeless people hung out, forcing cops to track the phone to the wrong person. When the case stalled, Detective Sobieski turned to the few people who'd seen Robert Cooper. One was Al Kite's girlfriend. Although she never saw Cooper's face, she did note the man dressed nice and walked with a limp and used a cane. When Sobieski interviewed another woman who'd met Cooper, he was told a different story. This Robert Cooper did not limp but did speak with a Romanian accent. So now, the question is: which of these clues provide insight into the killer and which were planted by the killer to help him get away with murder? Police believe that Al Kite's killer is a clean shaven man who may come across as arrogant. He's 5'10" and 180 pounds. He may be from the east coast and may have connections to the banking industry.

Frederick Styles Wanamaker (Aggravated Sexual Battery) -- Fred Wanamaker is wanted for sexually abusing four young boys over the course of twelve years. Virginia State Police say that Wanamaker used his status as a family friend and Boy Scout leader to take advantage of three brothers and one of their friends. Police say Wanamaker was a neighbor of the three brothers in Yogaville - a new-age community in Buckingham County, Virginia. They say Wanamaker befriended the mom and her kids and over time he became a friend of the family and a father figure to the children. Wanamaker - a sailor by trade - eventually became a Boy Scout leader, taught neighborhood kids special courses on navigation and took them on camping trips. Police say Wanamaker started molesting the oldest of the brothers at about age 10 and continued until he was about 13. At that time, he allegedly shifted his sexual attention to the second oldest child for a few years. When the youngest brother turned 10 and started going on camping trips with Wanamaker, the oldest brother (then an adult) felt he had to tell his mother what had happened to him, lest it happen to his brother as well. He was too late. According to police, all three brothers and one of their friends from the Boy Scout troop had been sexually assaulted. Wanamaker's alleged abuse spanned from 1985 to 1997. He has a professional, quiet, intellectual demeanor. He enjoys sailing and has worked as a merchant marine captain. He has training and credentials, which qualify him to pilot virtually any seagoing vessel. Wannamaker is 59, 5'8" and 180 pounds. (See Shows #634, #774 and #797, OADs 5/26/0, 7/31/04 and 3/05/05)

Michel Barrera (Attempted Murder, Armed Burglary) -- Barrera is wanted by the FBI for the 1998 armed robbery of two Miami banks, carjacking a Miami man, and the attempted murder of a Metro-Dade police officer during his getaway. Agents say on February 3, 1998, Michel Barrera and his accomplice robbed the Terra Bank in Miami, Florida, of approximately \$19,000. Then, on May 1, 1998 around 1:00pm they robbed the Republic National Bank in Miami at gunpoint. Following the robbery, the two men fled the bank and a high-speed chase ensued with Metro-Dade police officers. During the chase, cops say the two suspects fired on pursuing officers, then carjacked and severely injured a Miami civilian before ditching his car in a canal. Search teams combed the heavily foliaged area near the canal and were able to find and arrest Barrera's accomplice, but Michel Barrera was nowhere to be found. Barrera, a Cuban immigrant, comes across as a sweet, nice young boy. However, he is a known gang member who

may try to recruit other teenagers to commit crimes and may be hanging out with "punk" teenagers on the street. He has used the aliases Michael Barrera, Rene Caso, and Christopher Montefu. He has a burn scar on his left shoulder and "Maria" tattooed on his upper right rear shoulder, although he may have tattooed over this and grown his hair longer to change his appearance. He is always armed and has been known to impersonate a cop in home-invasion robberies. Barrera is a known drug user and loves to drink Malt liquor. He enjoys playing paintball, and frequents shooting ranges. Michel Barrera is 25, 5'8" and 146 pounds. (See Shows #519, #539 #561, #608, #611, #639, #731, #746 and #800, OADs 11/21/98, 4/24/99, 10/9/99, 10/14/00, 11/18/00, 7/7/01, 8/16/03, 12/27/03 and 3/26/05)

MISSING:

Matthew William Kruziki

Age: 24

Height: 6'2"

Weight: 200 pounds

On Friday, December 23rd, 2005, Matthew Kruziki was traveling through Iowa when he and a friend decided to take a break and relax a little bit. The pair checked into a Dubuque, Iowa hotel and went to "The River Queen Lounge" across the state line in East Dubuque, Illinois. The River Queen Lounge was the last place anyone ever saw Matthew Kruziki. Matt and his friend were enjoying themselves throughout the evening at the lounge. Patrons and staff members remember seeing Matt and his friend and said that Matt bought some fellow patrons drinks. Police think that Matt's generosity may have gotten him into trouble. Sometime after midnight, eyewitnesses told police that Matt and the bartender got into an argument over the tab. Matt had bought too many rounds, and wasn't able to settle the bill - he was asked to leave the bar. Meanwhile, Matt's friend stayed behind and assumed that Matt was returning to the hotel across the Mississippi River in Dubuque. Instead, Matt returned to the River Queen Lounge at around 1:10 AM early Saturday, Christmas Eve, morning. According to police, he had left his jacket and wallet behind and was trying to retrieve them but because of the earlier argument over the bill, he was not allowed back into the club. Instead, he was forced to leave without his belongings. Matt was last seen going out into 20-degree weather without his coat or wallet. Matt has not been seen since. The Kruzikis are offering a generous reward to find their missing son. Matt has brown hair and occasionally has a scruffy beard. Due to nerve damage to his right arm and hand, the webbing on his right hand between his thumb and forefinger is collapsed. Matt likes to drink microbrew and imported beer. He plays guitar and enjoys going to jazz clubs and coffee houses. He is described as very outgoing and talkative and is very dedicated to working on social reform.

CAPTURED:

Stanley Osbourne (Rape, Assault) -- In March 2001, police say Osbourne raped his 16-year-old step-daughter and fled before he could be arrested. Five months later, Osbourne decided to kill his wife, Bonita. According to police, he lured Bonita to Kings Point, New York under the pretense of going to see a marriage counselor for their problems. But Osbourne had no intention

of legitimately addressing their marital issues. In fact, they say the way he planned on "fixing" the problem was to murder the woman he married. A witness told police he saw a couple arguing in the street. He noticed the man, who cops later identified as Osbourne, was holding something black in his hand that might have been a gun. The witness called 911, but by the time police arrived, it was too late. Osbourne's wife had been severely beaten with a hand gun. She was alive, but badly injured. Luckily, between Bonita's account and the witness', police were able to piece together what had happened. Authorities say when the couple arrived at Kings Point, Osbourne tried to cut Bonita with a razor. But Bonita fought back and jumped out of the car. Then Osbourne attempted to shoot her, but the gun misfired. In a rage, Osbourne pistol whipped his wife, causing a skull fracture and a huge amount of blood loss. Bonita told police Osbourne fled in his car, and she somehow managed to drag herself off the ground and to the road. She was treated for her injuries and released. (See Show #821, OAD 9/10/05) A barrage of AMW tips placed Stanley Osbourne in the Toronto suburb of Brampton, Ontario. He was taken into custody without incident.

Los Angeles, California...EMIGDIO PRECIADO...Two men pleaded not-guilty to the September 2000 shooting of a sheriff's deputy during a traffic stop. Jose Guardado and Carlos Gutierrez faced nine charges, including conspiracy to commit murder and the attempted murder of a police officer. They were both convicted and are serving lengthy sentences in a California state prison. However, Emigdio Preciado is still at large.

Atlanta, Georgia...UNKNOWN ATLANTA CHILD PREDATOR...Cops say in June 1995, 14-year-old Nicole Smith was raped and murdered. The case was never solved. Nine years later, in June 2004, a 13-year-old girl was raped. Using DNA, investigators have linked the two cases together. Cops have a composite sketch and need your help to identify and locate this child predator who may still be stalking young girls.

Oak Island, North Carolina...WILLIAM HOLBERT...William Holbert is a convicted scam artist. Cops in North Carolina say his latest real estate con took a couple for \$200,000. Holbert likes body-building, and he could be going by the name Donald Brukart.

Brooklyn, New York...JEROME HANDY...His hair color has earned Jerome Handy the nickname "Red." But cops in Brooklyn, New York call him something else – Killer. They say he shot a man to death in an argument over a woman. He could be hiding in Georgia.

Vallejo, California...KIM SAELIO...Cops say Kim Oukuan Saelio is accused of shooting a man to death during a home invasion robbery in Vallejo, California. Saelio goes by the street names "Tim-Tim" and "Mr. T". Cops say he could be hiding out in Oakland.

Detroit, Michigan...ISMAIL ABDULAH MALIK...Police in Michigan say Ismail Abdullah Malik and two other men shot an officer after a routine traffic stop. Cops arrested the other suspects, but Malik disappeared. He could be using the name Steven Pierre Patterson.

Bakersfield, California...UNKNOWN BAKERSFIELD CONVENIENCE STORE ROBBERY... On February 26th a gun-wielding bandit rushed into a Bakersfield, California convenience store. He pointed his weapon at the owner, Don Batsch, and demanded everything. Before Don could even understand what was happening, the robber began firing at him. Thankfully, Don survived the two gunshots. Now cops need your help in identifying and locating this creep.

San Diego, California... SAN DIEGO JEWELRY HEIST...Cops say two men in their early twenties robbed a San Diego jewelry store of more than \$1 million dollars in loose diamonds and watches on February 11, 2006.

Encinitas, California... UNKNOWN BLOWTORCH BANDIT...Cops say that on January 31, 2006, a male suspect attempted to rob two Encinitas, California businesses armed with only a blowtorch. Luckily, cashiers in both establishments were able to fend off the unsuccessful thief, but cops are hoping the public can help in identifying the Blowtorch Bandit.

Orange County, Texas... MARLON WINTERS...Cops say Marlon Winters is every parent's worst nightmare -- he uses mind control and predator tactics to molest and rape children. Since we've aired his case, we've gotten tips about his whereabouts from all over the world. Now, police believe he could be floating between different cities in Germany and Amsterdam, Holland.
