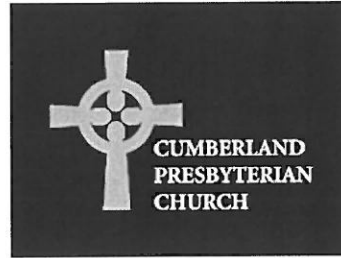

MY Country 96.1FM is locally-owned and is broadcasting the service to the Midland-Odessa area without any charge to the church.

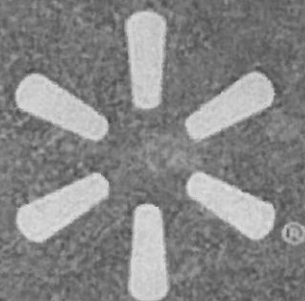
