"The Girl in the Car" – While Apollo 11 astronauts orbited the moon preparing for their historic landing, realizing a goal set by the late President John F. Kennedy, his brother Senator Ted Kennedy drove off a bridge into the waters of Martha's Vineyard. Ted left a young woman, Mary Jo Kopechne, who had been a campaign staffer for their late brother Robert F. Kennedy, in the submerged car. Kopechne died and to this day the diver who pulled her from the water and the accident investigator sent to the scene believe she might have been saved had the Senator reported the accident when it happened. Instead her story has largely been lost to history as the media and the public focused on the man whose career was forever damaged by the accident, rather than the bright and young woman who did not live to tell us what really happened on that mysterious night. 1969: The FBI and the Panther (5/14)

FORMER BLACK PANTHERS DESCRIBE THE VIOLENT BATTLE BETWEEN THE FBI AND BLACK POWER MOVEMENT IN 1969, TUESDAY, MAY 14, ON ABC

"The FBI and the Panther" – In 1969, a running battle between the Department of Justice, the Nixon White House and the Black Power movement reached its height. Patterns of infiltration, wiretapping and violence marked that year. The

special episode features powerful firsthand accounts that chronicle how the Black Panther Party established itself and became so influential in 1969; how their agenda evolved; what the Panthers represented to African Americans; and why the White House deemed them a threat. "The FBI and the Panther" airs TUESDAY, MAY 14 (10:00-11:00 p.m. EDT), on The ABC Television Network and will be available streaming and on demand.

The documentary spotlights the gripping and deeply personal story of the life and death of a charismatic 21-year-old Panther leader named Fred Hampton. Hampton was gunned down as he slept, having been drugged and set up by a police informant. As the bullets flew, his pregnant girlfriend tried to shield him with her body. A full 50 years after Fred's death, his then unborn child, Fred Hampton Jr., returns to the scene with his mother who recalls in vivid detail her attempts to save him.

"The FBI and the Panther" also details the story of the violent raid on Panther headquarters in Los Angeles that year, from the perspective of Black Panthers who were involved and an LAPD officer wounded in the shootout. Young Black Lives Matter leaders, along with former police and Black Panthers, describe a violent battle that unfolded between the FBI and the militant, charismatic and ill-fated young Black Panthers. Black Lives Matter founder Patrisse Cullors and recording artist Tariq Trotter of The Roots talk about how this chapter of American history continues to shape the story of race in America today.

1969 : Culture Wars, Media Wars and the Vietnam War on 'Fortunate Sons,' Tuesday, May 28 SEASON FINALE

CULTURE WARS, MEDIA WARS AND THE VIETNAM WAR

'Fortunate Sons' Airs Tuesday, May 28 (10:00 - 11:00 p.m. EDT), on ABC

"Fortunate Sons" traces the roots of the American culture wars to a time 50 years ago when the nation was increasingly prosperous and increasingly divided. The question of what America owed the world and its own people was hotly debated as the gap between the generations grew. In 1969, as President Richard Nixon battled a growing anti-war movement, TV shows like "Hee Haw" and "Lawrence Welk" promoted small-town values, while other shows like "That Girl" and "The Brady Bunch" challenged ideas about what a family and what being female should look like. In the same period, John Lennon and Yoko Ono staged Bed-Ins for Peace and young TV stars like Marlo Thomas attended anti-war rallies. "Fortunate Sons" airs TUESDAY, MAY 28 (10:00-11:00 p.m. EDT), on The ABC Television Network, and will be available streaming and on demand.

In 1969, as millions of young Americans turned 18 and were eligible for the draft for the first time, parents and their young adult children were at odds over what it meant to be American. Were the hippies waving Viet Cong flags the real patriots, or was it the "silent majority" who voted Richard Nixon into office and supported the war effort? Where did that leave the young men returning from the war – the drafted and the volunteers – who were changed forever by what they had seen?

"Fortunate Sons" explores the growing divide in the nation that year, along with the journey of three U.S. soldiers, including Tiney Corbett Jr., a young African American soldier who braved enemy fire for \$75 a day while seeing fellow soldiers waving confederate flags; Dan Millians, a helicopter pilot from Georgia, who enlisted out of high school and ended up rescuing Vietnamese civilians during one of the most infamous massacres in American military history; and a young John Kerry, who volunteered after graduating from Yale, but became a leading opponent of the war after his service. In a new interview, Pat Buchanan, Nixon's youthful media advisor, describes life inside the White House in 1969. He and Kerry would go on to battle one another for decades. "Fortunate Sons" also examines the massacre at My Lai, where American soldiers were found to have slaughtered old men, women and children, and that ultimately changed popular sentiment about the war itself.

20/20 : Two-Hour '20/20' Documentary Unravels the Complex Mystery Behind the Attack and Rape of Woman Staying in Miami Hotel

TWO-HOUR '20/20' DOCUMENTARY UNRAVELS THE COMPLEX MYSTERY BEHIND THE ATTACK AND RAPE OF WOMAN STAYING IN MIAMI HOTEL

'20/20' Features Private Investigator Who Pieces Together Clues Using Hotel Surveillance Cameras and Tracks Down DNA Match

'20/20' Airs on Friday, April 5 (9:00-11:00 p.m. EDT) on ABC

In the early hours of February 21, 2005, a utility worker found 21-year-old Inna Budnytska unconscious, naked, beaten and near death, abandoned in an undeveloped Miami cul-de-sac. Budnytska, a guest in a nearby airport hotel, had no memory of her attack and rape. Authorities looked at the hotel's surveillance footage for potential answers, but found puzzling information. The cameras recorded her walking into the lobby at 3:40 a.m. and then never captured her again. In a two-hour documentary, "20/20" reports on the mysterious case and features private investigator Ken Brennan, who meticulously gathered and pieced together clues, discovering how Budnytska left the hotel and tracking down the man whose DNA matched her attacker. "20/20" airs on Friday, April 5 (9:00-11:00 p.m. EDT), on ABC.

"20/20" has a new interview with Mark Bowden, who first reported the story of Budnytska in Vanity Fair and interviews with Budnytska; Brennan; Alan Foote, former Miami-Dade police detective who worked on the case; George Perez, the night manager at the Airport Regency hotel the night the perpetrator attacked Budnytska; Peter Dimouleas, Inna's current husband who was with her before the attack; Jose Vazquez, the Airport Regency's vice president; and Tom Chase, Frederick, Maryland Police Sergeant who helped Brennan locate Budnytska's attacker.

Brennan watched all of the hotel's security footage to find any missing clues. He noticed that on the same day as Budnytska's attack, a large man rolled a heavy suitcase out of the hotel in the early morning and returned about an hour later, without the suitcase. Brennan concluded that the man may have carried Budnytska out of the hotel in the suitcase and then dumped her body. Brennan eventually identified the man as Michael Jones, tracing him to Frederick, Maryland—over 1,000 miles away from the Miami hotel. Jones' DNA matched that of the attacker, but authorities struggled to gather additional evidence. As a result, Jones took a plea for a reduced charge and received only two years in prison. Later, authorities ran Jones' DNA through CODIS, the FBI's national database, and his DNA matched two other cold rape cases: one in Colorado Springs and one in New Orleans. In 2009, a Colorado jury found Jones guilty of sexual assault and he received 24 years to life in prison. In New Orleans in 2015, Jones pleaded guilty to two counts of forcible rape and received 45 years in prison.

The special on the complex mystery behind the attack of Inna Budnytska is part of "20/20" two-hour documentary programming. The original eight-week, two-hour programming lineup has been extended to fifteen weeks and will run through April 12. Since the two-hour documentaries premiered on Jan. 4, "20/20" has been Friday's No. 1 newsmagazine each week in all key demos: Total Viewers, Adults 18-49 and Adults 25-54. Hour Documents Jordan's More-Than-Seven Years in Juvenile Detention and How His Conviction Was Recently Overturned by the Pennsylvania Supreme Court

"20/20" features an interview with 21-year-old Jordan Brown, who was recently cleared by the Pennsylvania Supreme Court of a murder conviction he was charged with at age 11. In the interview, Jordan opens up to ABC News correspondent Juju Chang about the confusion he felt when he was first arrested for the murder of his father's pregnant fiancée, his almost decade-long fight to clear his name, his time in juvenile detention and life now that he's free. "20/20" airs Saturday, April 6 (10:00 – 11:00 p.m. EDT), on ABC. (Rebroadcast. ABC OAD: 10/19/18)

"20/20" reports on the details of the case throughout the years and features interviews with Christopher Brown, Jordan's father, who stood by his son and fought for his innocence; Jeffrey Martin, Troy Steinheiser and Robert McGraw, former Pennsylvania State Police officers who worked on the case; Dennis Elisco and Stephen Colafella, Jordan's attorneys; John Bongivengo, the initial district attorney on the case; Marsha Levick, deputy director and chief counsel of the Juvenile Law Center that worked with Jordan's lawyers on the case; and Bob Mayo, a local reporter who closely followed the story.

In 2009, Jordan was a typical fifth grader living in Lawrence County, Pennsylvania, with his dad, Kenzie Houk (his soon-to-be stepmother) and Kenzie's daughters, 7-year-old Jenessa and 4-year-old Adalynn. But on Feb. 20, 2009, everything changed when Kenzie was discovered dead inside their home after Jordan and Jenessa left for school. Police found a youth-sized shotgun in the home that they claimed smelled like it had been recently fired and discovered gunshot residue on Jordan's shirt and pants. Jordan was swiftly arrested for the crime, despite there being no DNA, blood or fingerprints linking him to the crime, and was convicted in 2012 in juvenile court of first-degree murder and first-degree homicide. Last July, the Pennsylvania Supreme Court unanimously overturned his conviction, citing insufficient evidence for Jordan to have been convicted.

More than two years after that tragic day, "20/20"co-anchor Amy Robach sat down with Cam who shared his new face with the world and opened up about his surgery and new lease on life. The hour features interviews with Dr. Eduardo Rodriguez, who performed the face transplant surgery at NYU Langone Health; Bev Bailey Potter, Cam's mom; Randy Underwood, Cam's father; Julie Jones, Aaron and Brad Underwood, Cam's siblings; Kevin Pauls, Cam's friend; and Patrick Hardison, a Mississippi fireman who also underwent a face transplant surgery performed by Dr. Rodriguez after being severely injured in a fire. Cam was an athletic young man who worked in his stepfather's business after high school graduation, earning enough money to buy a house by age 19. However, over a period of years during which he broke up with his longtime girlfriend, drifted from a close friend, saw his dear brothers move out of state and was dealing with stress from his work, Cam began to suffer from depression and developed a drinking problem. After his suicide attempt, Cam was rushed to University of California Davis Medical Center where he underwent multiple surgeries. But his life would never be the same and he started to wear a mask everywhere he went. After learning about the life-changing face transplant surgery that Dr. Rodriguez could perform on him, Cam waited for a perfect donor with the same skin tone, skull size, hair color, a full set of teeth and the same blood type. Cam found a match in Will who died after a long struggle with mental illness. With the blessing of Will's mother, Cam received the transplant.

Documentary Features New Interviews With Law Enforcement and Others Closely Involved in Case

'20/20' Airs Friday, May 31 (9:00 – 11:00 p.m. EDT), on ABC

In May 2010, authorities found a 23-year-old college student and dancer, Juri "Julie" Kibuishi, dead inside the home of her close friend Sam Herr. Police initially suspected that Sam pulled the trigger, but as they continued to investigate, they quickly unraveled the mystery that Sam's friend and neighbor, Daniel Wozniak, was the true killer. Wozniak confessed to killing Sam so he could steal his money and to murdering Julie in an attempt to frame Sam for her death and throw police off his tracks. With reporting by ABC News' senior national correspondent Jim Avila, the two-hour "20/20" documentary outlines the new details of the case, including Wozniak's confession, motive and fate as he currently sits on death row, and features new interviews with law enforcement and others closely involved in the investigation and case. "20/20" airs Friday, May 31 (9:00–11:00 p.m. EDT), on ABC.

The two-hour documentary includes new interviews with Glen Way, who is still in touch with Wozniak; former homicide detective Mike Cohen, who interrogated Wozniak; Matt Murphy, Senior Deputy District Attorney for Orange County, who prosecuted the case; Lieutenant Ed Everett and Sergeant Jose Morales, who worked on the case; David Medina, defense attorney for Wozniak's fiancée, Rachel Buffett; Eileen Frere, ABC station KABC reporter who covered the case; a previously unaired television interview with Buffett, following her arrest; and Carol and Anthony Celeste, who knew Wozniak from their days in the theater. "20/20" also features interviews with June Kibuishi, Julie's mother; Steven and Raquel Herr, Sam's parents; and Wesley Freilich, who was caught up in Wozniak's web. The documentary also has footage from Buffett's police interrogation and stress tests, and the riveting and revealing Wozniak interrogation tapes.

When police could not locate Sam after Julie's death, they tried to track him down through his ATM card activity but instead found 17-year-old Freilich had been withdrawing money from Sam's account. Freilich told police that he received the card from Wozniak, whom he knew through the local theater program and was withdrawing the money for him. Wozniak frequently changed his story during police interrogations but eventually confessed to killing Sam so he could steal his money and finance his upcoming wedding and honeymoon. Wozniak detailed how he shot Sam, cut off his body parts and disposed of them in a nearby park. He also confessed that he had tricked Julie into meeting him at Sam's apartment, where he shot her twice. Wozniak pleaded not guilty during trial, but a jury convicted him of two counts of first-degree murder, and the judge sentenced him to death in 2016. He is currently in prison in California. A jury found Rachel Buffett guilty of being an accessory after the fact, and she is serving time in jail.

She opens up about the difficult details of her abduction including being held for months in captivity by Nathaniel Kibby, who forced her to wear a shock collar and kept her prisoner inside a shipping container; and the psychological strategies she had to deploy in order to stay alive, including bonding with Kibby. The hour includes interviews with Lauren Munday, the woman who unknowingly aided Abby's release; Miranda Cloutier and Parish Dawe-Chadwick, Abby's best friends; Zenya Hernandez, Abby's mother; and officials involved with the case including New Hampshire Deputy Attorney General Jane Young, New Hampshire State Police Captain Joseph Ebert, Police Chief Chris Perley and Officer Eric Benjamin.

Munday told authorities that Kibby had given her counterfeit money, which police say set off a chain of events that led to Abby's release after Munday told Kibby the police were coming for him. In the months following Abby's return home, parts of her story slowly came out through her lawyers who said she was "violently abducted" and spent months enduring "acts of unspeakable violence." In 2014, Abby came face to face with Kibby in court as he was arraigned on charges of kidnapping; and in 2016, Kibby plead guilty to sexual assault, criminal threatening, kidnapping, witness tampering and assault, and received a prison sentence of 45 to 90 years.

Tad's wife Jill saw Tad's and Elizabeth's connection as a father-daughter relationship. In late January 2017, a middle school student claimed to have seen Tad and Elizabeth kissing in his classroom. After Tad was ordered by the school to stay away from Elizabeth, he was suspended when he violated the order. After being on the run for more than a month, Tad sought refuge with Griffin—a stranger who provided shelter in exchange for manual labor—in Northern California. Soon after, Griffin realized who they were and alerted authorities. Last April, Tad pleaded guilty to taking a minor across state lines for sex and to obstructing justice. Earlier this year, Tad was sentenced to 20 years in federal prison.

When Michele MacNeill's 6-year-old child found her unresponsive in her bathtub, her daughters Alexis Somers and Rachel MacNeill immediately suspected that their father, Martin MacNeill, had killed her. It took authorities five years to charge Martin, a wealthy doctor and father of eight, with Michele's murder. A two-hour "20/20" documentary reports on the twists and turns of the story including what prosecutors say was Martin's plot to kill Michele; his affair with another woman, Gypsy Willis, who moved in as the nanny just weeks after Michele's death; the identity fraud scandal involving Gypsy and Martin's stealing his adopted daughter's identity that landed them both for a time in federal prison; and his daughters' persistent pursuit to seek justice for their mother and put their father behind bars for good. "20/20" airs on Friday, June 14 (9:00-11:00 p.m. EDT) on ABC.

"20/20" features new interviews with Alexis and Rachel, children of Michele and Martin; Doug Witney and Jeff Robinson, retired investigators who worked on both the identity fraud and murder cases; Chad Grunander, a prosecutor on the murder case; and crime writer Shanna Hogan, who wrote the book "The Stranger She Loved," based on the story. "20/20" also includes interviews with Linda Cluff, Michele's sister; Gypsy, Martin's former mistress; Julie Willis, Gypsy's sister; Doug and Kristi Daniels, the MacNeills' neighbors who were on the scene after Michele's death; Jill Harper, Michele's niece; and Sergeant Josh Motsinger, one of the first police officers on the scene.

After the medical examiner ruled their mother's death to be natural, Alexis and Rachel were able to convince the county attorney's office to look into their father's past. Investigator Witney discovered a dark history: Martin used fake transcripts to get into medical school and forged checks in California resulting in felony probation. Investigators also asked a toxicologist to review the original toxicology report on Michele, which showed an unusual combination of powerful sedatives and painkillers. Following that review, the state medical examiner's office changed Michele's manner of death from natural to undetermined. Less than two months after he was released from prison on the fraud conviction, Martin was arrested and charged with his wife's murder.

During the trial, prosecutors claimed that Martin convinced Michele to have a facelift and then drugged and drowned her so he could be with Gypsy. Anna Osborne Walthall, another former mistress of Martin, testified in court that Martin once told her there is a way to naturally induce a heart attack so it couldn't be detected in tests. The jury found Martin guilty of first-degree murder and a judge sentenced him to 15 years to life in prison. Martin died by suicide at the Utah State Prison just two days before the tenth anniversary of Michele's death.

Ronald "Scott" Catt shocked a community when police apprehended him in Texas for doing what most fathers could never imagine – robbing two banks of \$108,000 with his son, Hayden, while his 18-year-old daughter, Abby, drove the getaway car. A two-hour "20/20" documentary unravels the details behind the heists, including the manipulative tactics Scott used to rope Hayden and Abby into the crimes; Scott's startling police confession, during which he admitted to robbing several banks in two states; his substance abuse issues; and resulting financial troubles, which Scott revealed to "20/20." During the documentary, Abby breaks her silence for the first time in almost five years to ABC News chief national correspondent Matt Gutman. Abby opens up about her steadfast love for Hayden and Scott; how her father and brother led her into a life of crime; her time in jail for the bank robberies; the mistakes she made after receiving parole in 2015, which landed her back behind bars; and life now as an expectant mother. Gutman also has an exclusive interview with Hayden from prison, who reveals what life is like now and reflects on the past. "20/20" airs Friday, June 28 (9:00 – 11:00 p.m. EDT), on ABC.

The documentary features an exclusive interview with Chrystal Fassett, former bank teller who was present when the Catts robbed one of the banks; and interviews with Susie Gregory, who volunteered at Abby's jail and learned of her backstory from a 2013 "20/20" report, and took her in when she received parole in 2015; investigator Jeff Martin, who worked on the case; Troy Nehls, the local sheriff who allowed Abby to serve time in the county jail instead of state prison; Skip Hollandsworth, Texas Monthly reporter who wrote about the Catt family crimes; and Joanna Voss, Abby and Hayden's aunt. The documentary also features revealing interrogation tapes, footage from Hayden and Abby's emotional 2013 reunion in front of "20/20" cameras before they parted ways to serve their sentences, and a 2015 interview with Abby after she received parole.

Police quickly tracked down the Catts due to their construction worker disguises, purchased by Hayden and Abby with Scott's credit card at a local home improvement store. While they awaited sentencing, Scott continued to manipulate his children by sending letters encouraging them to exaggerate his alcohol addiction when speaking to the media in an effort to make him appear more sympathetic. In 2013, all three accepted plea deals for aggravated robbery. Scott received 24 years in prison, Hayden received 10 years and Abby received five years, which she was allowed to serve in jail.
