

We had an ad schedule start at 9am yesterday (2/13) for a political ad, and due to a configuration error in our automation system, the "Paid by" tag was cut off from airing until today (2/14) at 11:30am. The spot ran from 9a-Midnight once each hour on 2/13 and 6a-10:30a on 2/14 for a total count of 20 aired spots before the issue was resolved.

Engineering worked with the automation software technical support to troubleshoot the issue. Technical support was able to find by trial and error that the configuration error was in the play controller of the automation system. There was an old configuration set to listen to an audio level threshold and stop playing audio on a given play device if that threshold was not reached. The "paid by" tag was just soft enough for that configuration to take over and cut off the tag from airing.

The issue was fixed as of 11:30 on 2/14 and all future spots will play correctly
