(b) **Initiative: WDST Internship Program.**

4 college students participated in WDST's Internship program during this reporting cycle.

Interns majoring in programs related to the media industry received college credits from Marist College and SUNY New Paltz for participating in WDST's internship program. They received hands-on training in video production, marketing, promotions and website design. Interns also received training in our promotions department in marketing strategy, concert promotions and on-site remotes as well as our production department in producing commercials and on-air presentation.

WDST also participated in the NAB intern program this year.
