The on-air personality will then indicate whether the Contestant’s guess is “too high,” “too low,” or “correct”. a. If the number is correct, the Contestant will win one the specific cash jackpot amount. ii. Winners must claim their prizes in person at the WAFL offices within 30 days after the end of the contest. Prizes not claimed within the 30-day period will be forfeited.

All players will receive a consolation prize of a free Beach Bag and Travel Cup furnished by West Dover Dental, players can win just one consolation prize, although they may make multiple guesses during the contest.

Eligibility

All entrants must be at least 18 years old and legal residents of the United States, living or working in Station’s total survey area (as defined by Arbitron). A winner will be disqualified if he/she or a member of his/her household has won a STATION contest within the previous 30 days.
