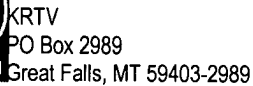
On March 26, 1998, KRTV(TV) was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until April 1, 2006.

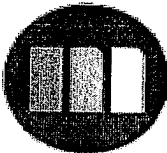
