Georgia residents get their benefits paid on the same schedule every month. Payments are distributed beginning on the fifth of the month and based on the last two digits of your SNAP ID number. SNAP benefits to low-income households are sent through the Georgia Electronic Benefits Transfer (EBT) card. Georgia SNAP EBT cards can be used at most grocery stores and certain other retail locations. Part 2 next week

SNAP benefits may be used to purchase fruits, vegetables, meat, poultry, fish, dairy products, breads, cereals, snack foods and non-alcoholic beverages. You cannot use SNAP benefits to buy alcoholic beverages, tobacco prod- ucts, vitamins, medicines, supplements, live animals, pet foods, cleaning supplies, paper products and cosmetics. You cannot use SNAP to buy hot meals prepared at the point of sale.

Severe thunderstorms in our area in the fall and winter can be extremely impactful and may sometimes catch people off guard as thunderstorms tend to occur less frequently during our cooler months. Access to care and medication is key to HIV prevention in our state. A program focused on a spectrum of social services for HIV-positive Georgians aims to help more people access free or low-cost care, HIV testing and medication, as well as fight the stigmas associated with the disease. According to federal government's Health Resources and Services Administration's most recent data, close to 2000 people in Georgia were diagnosed with HIV in 2020.

New laws enacted during the 2022 legislature will kick in January 1st including a bill making it easier for food trucks to do business. House Bill 424 provides a tax credit for contributions to nonprofits for foster children. Senate Bill 361 provides a dollar-for-dollar income tax credit on contributions to public safety initiatives. Senate Bill 87 provides income tax credits for contributions to scholarships for service-disabled veterans.
