(A) Initiative: Internship Program

During the reporting period, Noalmark Broadcasting Corporation implemented an internship program. The internship program is designed to give students the opportunity to experience the careers available in the radio broadcasting industry. The internship program chooses interns from applicants who express an interest in the radio industry.

Interns are exposed to the various operations of a radio station which may include some combination of on-air work, show production, remote broadcasts, engineering, traffic, billing, administrative assistance, sales, commercial production and board operation, depending to some extent upon the interests of the intern and the needs of the station. We are currently searching for interns for this program.

(B) Initiative: Management EEO Training

A training session was held with upper-level management on November 6, 2023. The session entailed a comprehensive review of the FCC EEO regulations and the Company's ongoing compliance efforts.
