Re: Election of Retransmission Consent

Dear Ms. Schofield:

This letter is in response to your letter dated March 27, 2012 notifying us that Hardy Telecommunications, Inc. ("Operator") intends to begin providing cable television service in the Washington, DC (Hagerstown) DMA. WTTG and WDCA, Washington, DC ("Stations"), licensed to Fox Television Stations, Inc. ("FTS"), elect retransmission consent with respect to retransmission of their broadcast signals by Operator. This election is for the headend located at 2255 Kimseys Run Road, Lost River, WV 26810, as well as any and all communities serving the Washington, DC (Hagerstown) DMA.

Accordingly, Stations hereby notify Operator that, pursuant to Section 325(b)(3)(B) of the Communications Act of 1934, as amended (the "Act"), and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission (the "Rules"), Stations elect to assert their rights under Section 325(b)(1)(A) of the Act and Section 76.64(a) of the Rules to require that Operator obtain Stations' express consent before retransmitting their signals. This election of retransmission consent is for the remainder of the current election cycle, ending December 31, 2014.

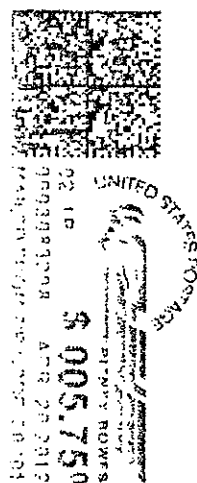

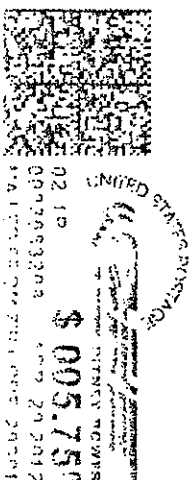
