Re: Election of Retransmission Consent

Dear Mike:

Pursuant to our September 5, 2008 telephone conversation, this letter is a notification that the television stations owned and operated by Fox Television Holdings, Inc. ("Stations"), elect retransmission consent with respect to retransmission of their broadcast signals by Comcast Cable Communications, LLC ("Operator"). This election is for the headends and Stations covered under the terms and conditions of that certain Retransmission Consent Agreement effective October 17, 2006 ("Agreement"). A current list of Stations is attached for your reference.

Accordingly, Stations hereby notify Operator that, pursuant to Section 325(b)(3)(B) of the Communications Act of 1934, as amended (the "Act"), and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission (the "Rules"), Stations elect to assert their rights under Section 325(b)(1)(A) of the Act and Section 76.64(a) of the Rules to have their signals retransmitted by Operator, only with their express consent. This election of retransmission consent is for the period January 1, 2009 through December 31, 2011.

Enclosed please find a copy of the conditions applicable to Fox that were adopted by the FCC in connection with News Corporation's purchase of an interest in DIRECTV in December 2003.
