Re: Election of Retransmission Consent

To whom it may concern:

Please be advised that Fox Television Holdings, Inc. ("FTH"), on behalf of all of its owned and operated television stations ("Stations"), which are identified by call sign, community of license and DMA in Exhibit A hereto, elects retransmission consent with respect to retransmission by DIRECTV, Inc. ("DIRECTV") of the broadcast signals of the Stations, each only within its own DMA.

Accordingly, FTH hereby notifies DIRECTV that, pursuant to Section 325 (b) (1) (C) of the Communications Act of 1934, as amended (the "Act"), and Section 76.66 (d) (1) of the Rules and Regulations of the Federal Communications Commission (the "Rules"), FTH elects to assert its right under Section 325 (b) (1) (C) of the Act and Section 76.66 (d) of the Rules to have the broadcast signals of the Stations retransmitted by DIRECTV, or a subsidiary thereof, only with its express consent. This election of retransmission consent is for the period January 1, 2006 through December 31, 2008.
