2. TO ENTER: Enter by calling the NET Radio toll free telephone number, 1-888-638-7346 and giving your name, address and phone number or via e-mail to radio@netNebraska.org. Only one entry per person. All entries must be received by 10/24/2017 6:30 p.m. (date and time)
3. ELIGIBILITY: You must be 18 years of age or older. It must have been at least 30 days since the last time you won a contest sponsored by NET Radio.
