Dear Mr. Sutor:

This is in reference to the request filed on June 13, 2016. Entercom requests an extension of the STA granted on January 14, 2016, to operate station KEZW(AM) at night using the daytime ND antenna at 1.25 kW due to failure of the antenna switching system.¹ In support of the request, Entercom states that additional time will be required to resolve a problem with the nighttime 280 degree monitor point before it can resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA IS HEREBY GRANTED, and station KEZW(AM) may continue to operate with a nighttime emergency 1.25 kW ND antenna using the daytime antenna system (with no change to the licensed 10 kW ND daytime operation). It will be necessary to further reduce or cease operation if complaints of interference are received. Entercom must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

¹ KEZW(AM) is licensed for operation on 1430 kHz with 10 kW day (ND) and 5 kW night (DA).

Entercom may need to file an FCC Form 301 application and/or an FCC Form 302 application to make any needed changes to the nighttime authorized pattern in order to resolve the monitor point issue. Otherwise, an e-mail or letter must be submitted to our staff to certify the station has resumed licensed operations with negligible parameters changes after all work has been completed.

This authority expires on **January 14, 2017**.
