

Large Number of Absentee Ballots are Not a Problem

Minnesota is on the doorstep of its biggest statewide election changes in years by providing more latitude for absentee voting and giving political parties, campaigns and others the ability to track who has sent ballots in for counting.

Starting June 27th, voters can obtain an absentee ballot to vote early in the August 12th primary either in person or by mail without having to cite a legally recognized excuse, as was required before a 2013 law change.

Officials intimately involved in election planning anticipate a greater percentage of voters than ever will cast a ballot ahead of election day.

Absentee votes have ranged from 5 to 10 percent of the overall ballots cast in the last four elections. The head of elections in Minnesota's second-largest county said he believes as many as 20 percent of county voters could submit an absentee ballot this year.

Otter Tail County Auditor, Wayne Stein, says a larger number of absentee ballots will not be a problem. They can run them through the machine a week ahead of time, however, the information stays on a computer card and they cannot read the vote totals or give the information out until 8 pm on election night. The results from absentee and regular votes are on separate computer cards that are merged before sending the information out to the state.

Officials in Wisconsin, Montana, Illinois, North Dakota, Idaho and Washington state have refused to sign, citing open record laws and the need for public awareness.

EERC DIRECTOR-FIRED

UND's energy, environmental center director fired

GRAND FORKS, N.D. (AP) - The University of North Dakota has fired the director of the school's Energy and Environmental Research Center.

WDAY-TV reports the university confirmed the move Thursday.

Gerald Groenewold had been placed on paid administrative leave in early May. He declined a request from the station to comment Thursday.

The EERC is UND's primary research facility and employs about 300 people, including scientists and engineers.

Groenewold pleaded guilty in 2008 to a misdemeanor assault charge for an incident involving his wife, state Sen. Connie Triplett. He was sentenced to one year of probation and ordered to complete 30 hours of community service.

Thomas Erickson is the center's associate director for business, operations and intellectual property. A university spokesman says Erickson will oversee the day-to-day operations of the lab.

Johnson says he won't go negative on GOP rivals

ST. PAUL, Minn. (AP) - Endorsed Republican gubernatorial candidate Jeff Johnson says he doesn't intend to wage a negative campaign against three fellow GOP hopefuls who are challenging him in an August primary.

Johnson is a Hennepin County commissioner who won the party's backing at a weekend state convention. He hopes to emerge from a four-way primary as the nominee to face Democratic Gov. Mark Dayton.

Johnson appeared Monday with state Republican leaders at the Capitol before a fly-around. He says he thinks he'll need to raise and spend \$1 million to be successful against businessman Scott Honour, former House Speaker Kurt Zellers and former Rep. Marty Seifert.

It's the first competitive primary for Republicans in a statewide race since 1994, when incumbent Gov. Arne Carlson dispatched with a challenger from his right.

Being a Minnesota candidate requires signup soon

★ ST. PAUL, Minn. (AP) - Everybody who has ever wanted their name on an election ballot in Minnesota can take that step for the next two weeks.

Candidate filing for the 2014 campaign opens Tuesday and runs for two weeks. It covers anyone running for state and federal office. Some local candidates must file during the window, too, although some municipal offices and school district board seats have a filing period that starts in late July.

This year, the top races are for governor and U.S. Senate. Control of the 134-seat House is also at stake as are the offices of attorney general, secretary of state and auditor. Voters will also fill eight seats in Congress.

People who file and change their minds have until June 5 to pull their name from contention.

STOLEN ASSAULT RIFLES-REWARD

Reward offered in Ill. stolen assault rifle case

★ CHICAGO (AP) - Authorities say a \$10,000 reward is available for information in the theft of 13 semi-automatic assault rifles stolen from a freight train container at a Chicago rail yard.

The Bureau of Alcohol, Tobacco, Firearms and Explosives, Chicago police and the National Shooting Sports Foundation announced the reward Tuesday. The money will go for information leading to an arrest and conviction in the thefts. The ATF is offering \$5,000 and the NSSF is offering a \$5,000 match. The NSSF is a trade association for the firearms industry.

Authorities say the Smith & Wesson M&P Sport Rifles were taken from a Norfolk Southern freight container between May 4 and 6. Authorities say the weapons were being shipped to a licensed gun dealer in Minnesota. The train was coming through Chicago.

Longtime Minnesota congressman Oberstar dies at 79

MINNEAPOLIS (AP) - Former U.S. Rep. Jim Oberstar, who served northeastern Minnesota for 36 years, has died. He was 79.

A statement released by his family says Oberstar died Saturday morning in his sleep. No cause of death was provided.

Oberstar, a Democrat, was elected to Congress in 1974 and served 18 terms before he narrowly lost to GOP challenger Chip Cravaack in 2010.

After his defeat, he said he loved serving northeastern Minnesota. His district included Duluth and the Iron Range.

He was the state's longest-serving member of Congress, and became chairman of the House Transportation and Infrastructure Committee in 2006.

Lawmakers move to preserve online voter signup

ST. PAUL, Minn. (AP) - Gov. Mark Dayton has signed a bill preserving an online voter registration system overseen by Minnesota's secretary of state.

State lawmakers quickly approved the bill and sent it to the Democratic governor before a court order kicks in.

On Monday, a Ramsey County judge ruled Secretary of State Mark Ritchie had overstepped his bounds by establishing the virtual sign-up unilaterally last fall. The judge ordered that the system be shut down by midnight Tuesday, absent legislative intervention.

The bill takes effect Wednesday.

Felony Charges to be Dropped in Plea Deal with Former Sheriff

A plea agreement has been reached in the criminal case against former Becker County Sheriff Tim Gordon.

Assistant Stearns County Attorney Kevin Voss says the deal calls for two felony charges of theft by swindle and making a false claim to be dropped. In exchange, Voss says Gordon has agreed to plead guilty to a misdemeanor charge of misconduct of a public official.

Gordon was accused of selling the county a used boat, motor and trailer and claiming the equipment was new. It was purchased with a state DNR grant. Gordon was sheriff for 10 years before he suddenly resigned two years ago. A sentencing hearing is scheduled May 28.

The Stearns County Attorney's office prosecuted the case to avoid a conflict of interest for the Becker County Attorney's office.

Industrial Finishing Services Pays Pollution Fine

Industrial Finishing Services, a metal coating company, has been the subject of a Minnesota Pollution Control Agency investigation for wastewater violations at its Deer Creek, Perham and New York Mills facilities.

According to the MPCA, the company failed to obtain required permits and monitor wastewater discharges at all three facilities. Discharge from the Deer Creek facility exceeded limits for cyanide, chromium, and zinc during parts of 2013. Both the Deer Creek and New York Mills facilities failed to meet reporting requirements.

The company has corrected the problems at all three facilities, and paid a \$35,000 for the violations.

Sen Ingebrigtsen Votes Against New Cell Phone Tracking Rules

ST. PAUL, Minn. (AP) - New restrictions on police use of cell phone tracking technology have won backing from the Minnesota Senate. Senators voted Tuesday to require a special tracking warrant when a device is used to find a person's location by their cell phone or other electronic devices.

The lone vote against the bill came from Republican Sen. Bill Ingebrigtsen, a retired sheriff from Alexandria. He says it sends the wrong message about police techniques and suggests they are merely stockpiling data.

Ingebrigtsen says that only the BCA and Hennepin County have this tool now but more counties might be interested in getting one if the price goes lower..

The bill says law enforcement must show probable cause of a crime. People being tracked must eventually be notified that their information was collected.

Republican Sen. Branden Peterson of Andover says the bill responds to rapidly advancing technology.

Franson Sued for Defamation by Ex-boyfriend

ALEXANDRIA, Minn. (AP) - A state lawmaker from Alexandria is being sued for defamation by an ex-boyfriend whom she has accused of threatening and stalking her. The lawsuit by McLeod County Republican Party chairman Eric Harpel claims his reputation was ruined by statements Rep. Mary Franson of Alexandria made in a court petition seeking a restraining order.

Harpel says Franson falsely accused him of stalking and threatening her and sending her lewd emails, text messages, photos and videos. The lawsuit also claims Franson illegally accessed and deleted Harpel's emails. KFGO radio reports Harpel is seeking more than \$50,000 in damages.

Franson told a Fargo radio station in an email that she's optimistic that Harpel's complaint will be dismissed.

MINNEAPOLIS (AP) - The Minnesota Security Hospital is being fined \$1,000 after investigators found substantiated maltreatment in an incident that led to the death of a patient.

Darnell Dee Whitefeather is charged with murder for allegedly stomping on the head of Michael Francis Douglas in order to get staffers' attention on Jan. 22. Douglas died from his injuries.

The Department of Human Services says the facility failed to provide necessary care to the two men. The department calls it an "unacceptable failure."

DHS announced the fine Tuesday. It also is extending the conditional status of the security hospital's license through late 2016.

The Minnesota Security Hospital has a series of management lapses in recent years. The hospital was placed on probationary license status in 2011 after several cases of patient maltr

How Can I Prevent Lyme Disease?

Tips for preventing Lyme disease include the following:

Because infection does not occur until a tick has been attached for at least 24 hours, a thorough daily tick check can be an effective first-line defense.

Be aware that the ticks are very small, although they are larger when engorged with blood.

If you spend time outdoors in areas inhabited by deer ticks, wear shoes, long pants tucked into socks or pant legs, and long sleeves.

Use insect repellent with 20%-30% DEET around your ankles, other areas of exposed skin, and clothes.

If you work or walk in brushy areas or woods, check regularly for ticks; they are easier to see against light clothing. Check especially around the armpits, groin, scalp, belt line, neck and head. Check pets often, as well.

If possible, avoid tick-infested areas, particularly in May, June, and July.

If you're in tick-infested areas, walk in the center of trails to avoid overgrown grass and leaf litter.

If you do find a deer tick on your skin, remove it immediately.

No injuries after mudslide prompts road closure

Heavy Rain

★ MINNEAPOLIS (AP) - A mudslide on a Mississippi River bluff in Minneapolis has caused a partial road closure and forced the evacuation of some administrative employees of a nearby hospital.

Deputy Fire Chief Todd White tells the Star Tribune that the slide occurred around 7 p.m., sending a 100-yard swath of the bluff onto the road and river below. He says about 6 to 8 feet of mud were left on the West River Parkway, which was partially closed. No one was injured.

A statement from the Fire Department says crews determined the University of Minnesota Medical Center was not affected.

The Pioneer Press reports twenty administrative employees of the hospital were evacuated as a precaution. Patients were not affected.

The mudslide comes after torrential rain and flash flooding in the area Thursday.

paddlers and swimmers to think twice before heading out on the water right now.

The Department of Natural Resources says people must be especially cautious around high water, wear life jackets and be aware of local flooding conditions and alerts. And people should not venture into flooded areas.

Boat and water safety specialist Kara Owens says rivers, lakes and streams are extremely swollen across Minnesota, and water temperatures are colder than normal.

Owens says stream and river currents are extremely strong, which many boaters and swimmers aren't used to. And she says boaters should be aware that there's more debris in the water, often floating just at or below the surface. Hitting a log at high speed can damage boats and cause serious injuries.

PARTY TURNOUT EFFORTS

Minnesota parties open offices, push absentee vote

ST. PAUL, Minn. (AP) - Looking for an edge, Minnesota's Republican and Democratic-Farmer-Labor parties are promoting no-excuse absentee voting and setting up satellite offices around the state.

Both gave a glimpse Thursday at their get-out-the-vote operations in a year when voters will elect a governor, a U.S. senator and many other elected officials.

Republican Party Chairman Keith Downey says the GOP's 10 "victory" offices will be aimed first at helping endorsed candidates prevail in August primaries before turning to fall matchups. He says expanded use of absentee voting will augment this year's efforts.

Democrats say they have 18 campaign offices now open across the state, from Albert Lea in the south to Virginia in the north. They too are urging people to cast ballots ahead of time either in person or through the mail.

Water Over Two Roads in OTC

High water is over the road in two places in Otter Tail County. One is south of Fergus Falls on Co Hwy 15 south of Co Hwy 112. The other place is on Co Road 34 west of Perham in the Little McDonald, Paul Lake area. Signs have been put up to warn motorists about the water over the road but both roads remain open at this time.

FARGO, N.D. (KFGO AM) -- Parts of the region took a hit from mother nature over the weekend.

Heavy rain fell over southeastern North Dakota and western Minnesota leaving fields under water, some rural roads closed and streams and rivers on the rise.

The two day total at Hector International Airport in Fargo is 1.85 inches, but amounts varied across the metro. one report of 3.50 inches in West Fargo.

The Red in fargo is expected to rise to about 22-1/2 feet by Friday, and will mean the closure of North Elm between 14th and 15th avenues.

No other problems are expected.

Rainfall amounts elsewhere include:

5.0" Leonard, N.D. 4.5" Verndale, near Wadena 4.0" near Ashby in Otter Tail County.

Two-to-two-and-a-half inch amounts were common across Clay, southern Cass, parts of Richland and Wilkin counties.

★ Water recedes in SW Minn., eastbound I-90 reopens

★ LUVERNE, Minn. (AP) - The water has been receding in southwestern Minnesota, where officials closed all four lanes of Interstate 90 from Luverne to the South Dakota border.

★ KELO-TV reports that officials re-opened the eastbound lanes of the interstate around 8:30 a.m. Sunday. Water up to four feet high from heavy rains covered the freeway earlier in the morning.

★ Heavy rain washed away the spillway at Blue Mounds State Park, north of Luverne. The dam holds back water for a swimming pond in the park. The water drains into the Rock River, which flows through Luverne.

★ Secondary roads and farm fields were underwater elsewhere in Rock County Sunday. A road crew rescued one vehicle stranded near the town of Hills on Sunday morning.

★ Crews fill 50K sandbags in International Falls

★ INTERNATIONAL FALLS, Minn. (AP) - Sandbagging is under way in the International Falls area of far northern Minnesota because of rising waters on Rainy Lake and the Rainy River.

★ The Koochiching County sheriff's office says volunteers have filled about 50,000 sandbags to protect homes. A department statement says there's been damage to docks and boathouses, but no confirmed reports of damage to any homes.

★ Voyageurs National Park has had to close over 30 campsites because all the park's docks and some of its boat launches are under water.

★ Thunderbird Lodge on Rainy Lake says its docks are under water.

★ Minnesota Highway 11 was closed yesterday due to water over the road near Loman, about 16 miles west of International Falls, due to flooding on the Rainy River. The river runs along the U.S.-Canadian border.

NEW YORK (AP) - Adrian Peterson has helped launch an educational program for people with severe allergies, something that affected the Minnesota Vikings' running back before his MVP season.

Peterson had a strong allergic reaction to shellfish in training camp two years ago, even though he'd been eating it for 27 years. The reaction, called anaphylaxis, caused facial swelling and breathing problems. His trainer, however, was familiar with such symptoms and had the equipment to deal with them.

Now, Peterson is encouraging everyone to take steps in dealing with severe allergies. He has teamed with the pharmaceutical company Mylar Specialty on the project.

As part of the campaign, three youngsters who have such health issues can win a trip to Minnesota's training camp this summer.

:28 :36 "Yeah, basically it's a bacteria that when caterpillars ingest it, it causes damage to the caterpillar's stomach and the caterpillar quits feeding and basically staves to death and then the bacteria affects the caterpillar then also. It's very specific to caterpillars. It actually found naturally in the soil so anybody in contact with the soil would be in contact with ... that."

Since ^{the Foray chemical} it only affects caterpillars, humans, pets, trees and other plants are not damaged. Lubben agrees that there are many misunderstandings in what they are spraying. He is required to keep records of where ^{they are} he was and what ^{they are} is was spraying. When a ^{women} lady accused him of making her dog sick, he could prove he was ^{not spraying near} not even close to the area where her dog was.

Lake associations and property owners usually get together to have an area sprayed for tent caterpillars and ^{to} spread ^{the cost} the cost out that way.

ST. PAUL, Minn. (AP) - Minnesota's online health insurance marketplace has launched a campaign aimed at making sure young adults don't lose coverage when they graduate from college.

MNsure CEO Scott Leitz says many graduating students will lose the health insurance they have through their schools. But the loss of coverage may make them eligible to enroll for coverage in private plans via MNsure.

Individual graduates whose annual incomes are under \$22,980 and don't have access to employer-sponsored health insurance may also be eligible for the public Medical Assistance or MinnesotaCare programs.

MNsure says college graduates may be known as the "young invincibles," but they're the age group most likely to visit the emergency room, and without health insurance the expense of a trip to the ER can be steep.
