# **ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JAMIE COOPER TELEVISION, INC.**

Pursuant to the Alabama Business and Nonprofit Entity Code, Sections 10A-1-4.02(c)(4), 10A-4-1.02, 10A-2-10.01, 10A-2-10.03, and 10A-2-10.06, the undersigned corporation, **JAMIE COOPER TELEVISION, INC.**, a corporation organized and existing under the laws of the State of Alabama (hereinafter referred to as the "Corporation"), hereby submits the following:

1. The name of the Corporation is **JAMIE COOPER TELEVISION, INC.** The Articles of Incorporation were filed in Madison County on May 30, 2003. Their Alabama Entity ID Number is: 229-234.

2. The Articles of Incorporation of the Corporation shall be amended as follows:

There shall be deleted Article I and a new Article I shall be added as follows:

## **"ARTICLE I**

The name of the corporation is:

**WTZT Television, Inc."**

3. This Amendment to the Articles of Incorporation of the Corporation was approved by Unanimous Written Consent of the Shareholders and the Board of Directors as of July 1, 2020. There were 1,000 shares eligible to vote on the amendment.


4. This Amendment to the Articles of Incorporation of the Corporation was not adopted by the Board of Directors without shareholder action.

5. (i) At the time of the approval of the Amendment, there were 1,000 shares of Common Stock of the Corporation, par value \$1.00 per share, outstanding and entitled to vote on the Amendment. The holders of such shares were entitled to cast one vote per share, or an aggregate of 1,000 votes, and the holders of such votes were undisputedly represented pursuant to the aforementioned Unanimous Written Consent.

(ii) The total number of undisputed votes cast in favor of the Amendment was 1,000, and the number of votes cast against the Amendment was 0.
