POLITICAL DISCLOSURE STATEMENT ELECTIONS - 2019

RADIO STATIONS WNAE-AM/96.7-FM, WRRN-FM, WKNB-FM WARREN COUNTY, PENNSYLVANIA

During their election campaigns, all legally qualified candidates are entitled to purchase time on WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM. WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will consider all requests for such time and will make reasonable accommodations to meet such requests. Although each such candidate has the right to "reasonable access" to the facilities of WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM for the airing of political advertisements, WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM retain the right to limit the amount of time sold to a candidate and has the ultimate discretion with respect to the placement of political advertisements.

During the 45 days preceding a primary election and the 60 days before a general election, WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM charge candidates in the respective elections the "lowest unit charge" for an advertisement if the advertisement constitutes a "use" of the WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM facilities. The advertisement is considered to be a "use" if it is controlled, sponsored or approved by the candidate or the candidate's campaign committee. During any period other than the 45-day and 60-day periods, the charges for political advertisements constituting a "use" are set so as to be no higher than those charged other advertisers for comparable use of the stations' facilities. Any political advertisement that is not a use, including any advertisement purchased by an independent political action committee or any advertisement dealing with non-candidate ballot issues, is sold at prevailing commercial rates. If a political advertisement constitutes a use, WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will provide opposing candidates with "equal opportunities", as established by federal law, to use WNAE-AM/96.7's, WRRN-FM's and WKNB-FM's facilities.

The terms and conditions applicable to political advertising on WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM are as follows:

 Sponsorship Identification. A complete sponsor identification, aired in the candidate's voice, must be included in each advertisement as required by FCC rules and regulations.
 In addition, all federal candidates are required to announce the office they are running for,

the fact that they approved the ad and who paid for the ad.

- 2. Credit. Cash at least 1 business day in advance is required.
- 3. <u>Political Agreement</u>. A signed Agreement Form for Political Broadcasts must accompany any time order. This form must list the officers, board of directors, or executive committee of the political entity purchasing the time.

4. Proof of Candidacy. WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM, at its option, may require the candidate to produce proof that he/she is a legally qualified candidate. All federal candidates must fill out a candidate certification form.

5. Production Facilities. The stations' production facilities will be available to produce commercials for political advertisers on the same terms as provided to commercial

advertisers.

6. Schedules. WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will make available to political candidates any and all dayparts and rotational packages and any special packages that are available to commercial advertisers. For information regarding packages and rotations not described below, please call the station. Rates charged by WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM are based upon the use of 60-second or 30-second spots.

7. The following limitations have been set regarding the number of spots that may be

purchased:

WNAE-AM/96.7-FM

6a-12a - No limit - subject to availability

WRRN-FM

6a-10a - 1 per hour, Monday through Saturday 10a-12a - No limit - subject to availability

WKNB-FM:

6a-10a – 1 per hour

10a-12a - No limit - subject to availability

9. Make Good Policy. In the event of a missed spot, WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will make good in the same daypart within 3 days. If time prohibits making the spot good (e.g., missed on last day before election) WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will refund cost of the missed spot to the purchasing entity within 5 working days.

10. Rebates. If a new lowest unit charge is established after a political advertiser's purchase has been made or run, WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM will rebate the overcharge to the political advertiser within 10 days or will credit the overcharge to the

candidate's future time purchases, as the candidate directs.

11. Local Public Inspection File. The rules and regulations of the Federal Communications Commission require that each station must maintain, and permit public inspection of, a complete record of all requests for political time together with an appropriate notation showing whether such requests were granted and the amount charged. This information must be retained in the station's local public inspection file for two years. The local public inspection file for WNAE-AM/96.7-FM, WRRN-FM and WKNB-FM is maintained at 310 Second Avenue, Warren, Pennsylvania. Any member of the public, including opposing candidates, is entitled to inspect the materials placed in these files during regular business hours.

12. The stations does not air political advertisements during newscasts and do not have a news adjacency class of time.
