Local control will almost always produce better results than a federal mandate from bureaucrats who are unaccountable to the people that are ultimately subject to these regulations.' As HuffPost previously reported, conservatives have largely been forced to abandon brazen calls for outright transfer and sale — at least publicly — instead embracing savvier tactics aimed at achieving many of the same industry-friendly goals that would come with stripping lands from federal control. That has included supporting federal-state agreements that would give states a greater role in public land management and pushing permitting reform legislation aimed at giving states the authority to manage oil, gas and other energy development across the federal estate — a de facto transfer of control that would establish federal lands in name only." "Aaron Weiss, deputy director at the Center for Western Priorities, told HuffPost that the issue became 'such a third rail that candidates across the West generally stopped going there' — and pollsters largely quit posing such direct questions. 'It's incredibly consistent over the years and not even close,' he said of public opposition. 'This is not like an issue that is on the margin for Montana voters. 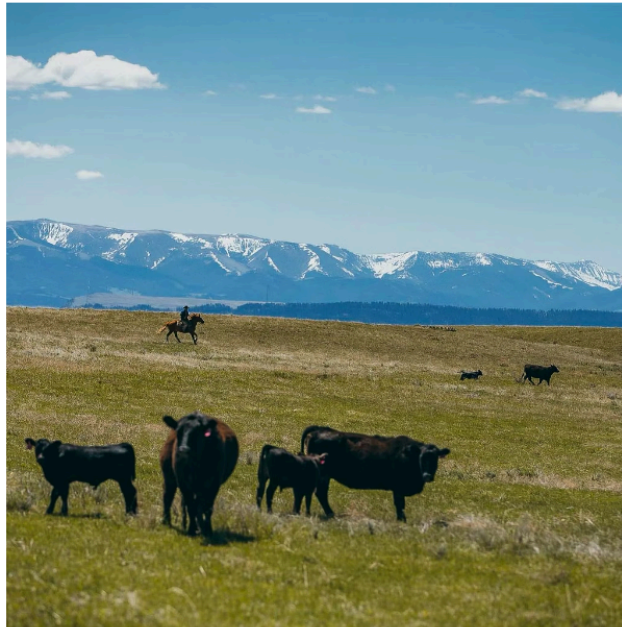

The goal was to create a way to thank landowners involved in the state’s Block Management Program. **The Wilks Brothers Provided A Large Part Of LandTrust’s \$6 Million First Round Venture Funding.** “So far, LandTrust lists more than 1 million acres of lands in Montana, with more soon to come, according to a recent press release. That’s because the Wilks brothers, one of the largest landowners in the state, plan to enroll ‘hundreds of thousands of acres.’ The brothers have also provided a large part of the \$6 million for the first round in venture funding. The investment will allow LandTrust to expand into five more states this year, the company said.’ [...] ‘We invested in LandTrust and are adding some of our lands to the platform because it allows us to provide the general public access to our private land in a safe, secure and simple way to create a more equitable and accessible outdoor experience for all,’ said Justin Wilks, executive vice president at Wilks Brothers. In Idaho, as their property has expanded, the brothers have shuttered trails and hired armed guards to patrol their acres, blocking and stymying access not only to their private property, but also to some publicly owned areas. **The Wilks Brothers Came Under Fire In Idaho For Cutting Off Access To Land For The Snowmobile Industry, Shutting Down Hunting Access, And Kicking Out Timber Companies Causing 100 People To Lose Their Jobs.** “In Idaho, the Wilks brothers did more than gate a few roads. They also revoked road-use contracts that propped up the region’s multimillion-dollar snowmobile industry, shut down hunting on their land and told timber companies to pull crews from the area. About 100 people lost their jobs. No one claimed that

those actions were illegal, but they heightened fears that local residents were losing control of the region. A 2017 video of a roadside argument between an armed Wilks guard and a local ATV rider traveled quickly around the state. Afterward, the Wilks family hired a lobbyist to push for a law that would stiffen penalties for trespass. The bill passed.” [New York Times, [6/22/19](#)]
