Ladies and Gentlemen:

Pursuant to Section 325 of the Communications Act of 1934, as amended and Section 76.64 of the FCC rules, this is to notify you that **KCAL-TV, LOS ANGELES** (“Station”), assigned to the Los Angeles market (“DMA”), elects the retransmission consent option with respect to carriage of Station’s signal on your cable system whose head-end is located in **USC CAMPUS, CA** and any other cable systems that you own, operate, or control that serve communities in the DMA for the 2015-2017 election period.

This will not affect the continued carriage of Station’s signals by your systems as to any part of the relevant period for which an existing retransmission agreement is already in effect. If no agreement is in effect beyond December 31, 2014, then it will be necessary for your system to obtain our express, prior, and written consent in order to retransmit KCAL-TV’s signal after 12:01 AM on January 1, 2015 (or, if earlier, after the expiration date of any existing agreement).

For purposes of clarification, this election letter does not authorize your cable system(s) or other video distribution system(s) to retransmit the signal of the Station in any manner.
