### Section I. Issues

The stations have identified the following topics as significant issues facing our community in this quarter:

- A. **Fire/Fireworks ordinances and safety** – Fires are a recurring issue in the area every year, especially in the summer. We had guests who discussed topics such as clearing away lawn and tree debris, ordinances for backyard grills and fire pits, and fireworks safety and ordinances.
- B. **June primary election** – The primary election was of significant interest, as Montana has gained a second seat in the House following the 2020 Census.
- C. **Marijuana** – Recreational marijuana was recently legalized in Montana. There are efforts currently trying to de-legalize it, as well as separate efforts to keep it legal, but increase the taxes on marijuana.
- D. **Road construction projects** – There are numerous road construction projects underway in Montana this summer. We had guests on to discuss where some of those projects were located, what they were trying to accomplish and where to go for more information.
