Problem # 1: *Bringing Attention To The "Move Over" Law*

The Alabama Department of Transportation (ALDOT) is bringing awareness to two issues of great importance across our state for the remainder of the year. Spot announcements will air on the following subject matter: "Railway Safety" and "Move Over" when you see flashing lights.

Alabama Department of Transportation has enrolled in the PEP program for the remainder of the year. From now through Dec 31, 2019, we will air the two remaining spots. One spot focuses on Railway Safety... "Never try to beat and train. It is a deadly game." A second spot is designed to bring attention to The "Move Over" law which requires that you move over when you see flashing lights. If you can't move over – Slow Down!

Problem # 2: *Masks required in all Baldwin County courts beginning July 6*

Judge Stankoski issued an order Wednesday mandating that all persons wear a mask in the Baldwin County Courts including the satellite courts in Foley and Fairhope beginning July 6, 2020.

This mandate includes but is not limited to court employees, visitors, witnesses, law enforcement, cleaning personnel and vendors. Medical exceptions will be handled on a case by case basis. All attorneys are encouraged to conduct as much business as possible by paperwork and virtual hearings should be requested in all matters where practicable.

These restrictions shall remain in place until the Court determines they can safely be discontinued.

Problem # 6: *Mobile County Public School System Plans To Start Online School September 1st.*

Mobile County Public Schools will not open on Aug. 10. Instead, the district's superintendent announced today a plan to open online on Sept. 1.

The first nine weeks will be online, but will students be able to go back once that time passes? The answer depends on how our area is doing with coronavirus.

Superintendent Threadgill said he's working closely with the county's health department to make sure he's not putting students and staff at risk by going back too soon.

"Mobile County Public Schools will not reopen for students on Aug. 10, 2020," Superintendent Chresal Threadgill said.

For many parents, the announcement was one they have been waiting for, for weeks.
