ARTICLES OF INCORPORATION  
OF  
ACORN COMMUNITY ENTERPRISES

A California Public Benefit Corporation

ONE: The name of this corporation is Acorn Community Enterprises.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are the promotion and provision of activities which increase the overall health of families in Central and Eastern Shasta County, including job training, substance abuse counseling, and therapeutic activities for adults and children.
