Re: 2015-2017 Three-Year Election for Retransmission Consent

Dear Mr. Nissenblatt:

In accordance with Section 76.64 of the Rules of the Federal Communications Commission ("FCC"), this is to notify you that Station **WJTV**, **Jackson**, **MS** (the "Station") elects to require **Comcast Cable Communications**, **LLC**, which serves the community(ies) and/or county(ies) and unincorporated areas within those community(ies) and county(ies) listed on the enclosed 2015-2017 Retransmission Consent Election Statement, to obtain the consent of the Station for retransmission of its broadcast signal effective January 1, 2015, through December 31, 2017. Consent of the Station for retransmission of its signal will be required for, but not limited to, the system(s) serving the community(ies) and county(ies) listed on the enclosed Election Statement.

If you already have a retransmission consent agreement with the Station or with Media General, Inc. or a subsidiary thereof (including, without limitation, Young Broadcasting LLC or a subsidiary thereof) (collectively, "Media General") that covers the Station for all or a portion of the January 1, 2015, through December 31, 2017, cycle, then the terms of that agreement will govern for the period specified in the agreement. If such an agreement expires prior to December 31, 2017, then it will be necessary for you to negotiate for retransmission consent following that expiration. In addition, if any retransmission consent agreement between you and the Station or Media General contains an automatic renewal provision, then this letter shall also serve as notice

of termination of that agreement, and it will be necessary for the system(s) to negotiate for retransmission consent following expiration of the current term of that agreement.

We will send you an agreement at the appropriate time in advance of the expiration of the current agreement.
