Dear Ladies and Gentlemen:

Cox Media Group, LLC ("Broadcaster") provides AT&T Services, Inc. ("Operator") with this notice pursuant to Section 325 of the Communications Act of 1934, as amended, and Section 76.64(f) of the rules and regulations of the Federal Communications Commission. Broadcaster is the ultimate owner of the television stations identified in Attachment A hereto (each, a "Station").

For the period January 1, 2018 through December 31, 2020, Broadcaster hereby elects **RETRANSMISSION CONSENT** with respect to the primary video stream of each such Station's digital signal on each of Operator's multichannel video programming distribution systems in each Station's respective market, as identified in Attachment A, including but not limited to those multichannel video programming distribution systems serving areas or communities identified in or covered by Broadcaster's retransmission consent agreement with Operator and/or listed in Attachment B.
