Cox Media Group, LLC ("Broadcaster") provides Cox Communications, Inc. ("Operator") with this notice pursuant to Section 325 of the Communications Act of 1934, as amended, and Section 76.64(f) of the rules and regulations of the Federal Communications Commission. Broadcaster is the ultimate owner of the television stations identified in Attachment A hereto (each, a "Station").
