Dear Ms. Witmer:

I am writing to confirm that, for the period beginning November 1, 2008 and ending December 31, 2011, the New Jersey Public Broadcasting Authority ("NJN") has waived its must carry rights and all of the must carry obligations of Time Warner Cable, Inc. ("Time Warner Cable") with respect to carriage of the broadcast signal of WNJN, Montclair, New Jersey, on the Time Warner Cable of New York City systems serving Southern Manhattan; Western Brooklyn, Queens; Northern Manhattan; Mt. Vernon; and Staten Island, New York (collectively, the "Systems"), which must carry obligations were imposed upon Time Warner Cable as a cable provider pursuant to Sections 4 and 5 of the Cable Television Consumer Protection and Competition Act of 1992, as amended, and all applicable FCC rules and regulations.


