Entercom Kansas City License, LLC hereby notifies the Commission and requests authority to commence digital broadcasting using iBiquity Digital Corporation's HD Radio™ technology. Consistent with the Commission's recent Order on interim digital operations,<sup>1</sup> Entercom Kansas City License, LLC hereby supplies the following information in support of this application.

1. *Date.* Entercom Kansas City License, LLC commenced digital broadcasts on KQRC-FM on or about February 9, 2005.
2. *Certification of Facilities.* Entercom Kansas City License, LLC hereby certifies its facilities conform to the iBiquity Digital Corporation hybrid FM specifications.

4. *Transmitter Output Power.* Entercom Kansas City License, LLC will be utilizing the "high level" method of combining the analog and digital signals.

Combined: 29,795 watts

Analog: 32,745 watts

Digital: 2,950 watts

5. *Certification of ERP.* Entercom Kansas City License, LLC hereby certifies its analog effective radiated power will remain as specified in the current instrument of authorization (FCC File No. BLH20030422ABJ) after commencement of digital operations.
6. *Radiation Exposure Certification.* Entercom Kansas City License, LLC hereby certifies that its existing analog and proposed interim digital operations will not cause human exposure to levels of radio frequency radiation in excess of Section 1.1310 of the Commission's rules and is therefore categorically excluded from environmental processing pursuant to Section 1.1306 (b). With respect to "on tower" or other exposure to workers at the site, appropriate power reduction or cessation of transmitter operation will be undertaken by the licensee and other site tenants.
