**Re: Retransmission Consent Elections**

Dear Mr. David:

In the fourth quarter of 2014, we received one or more letters from you directed to one or more of the television stations listed in Exhibit A hereto (for which the ultimate parent in each case is Hearst Television Inc. ("Hearst")) in which you state that FilmOn X, LLC ("FilmOn X") intends to commence operations as a multichannel video programming distributor ("MVPD") in the relevant station's Designated Market Area ("DMA").

Since the time of your letters, we have received no further communications from you expressing FilmOn X's intent to commence operations as an MVPD in our stations' DMAs.

It remains our position that FilmOn X does not currently qualify as an MVPD under the definitions of MVPD as set forth either in the Communications Act of 1934, as amended, or in the rules and regulations of the Federal Communications Commission ("FCC"). See 47 U.S.C. § 522(13); 47 C.F.R. § 76.1000(e), § 76.1300(d). Accordingly, FilmOn X is not entitled to invoke the FCC's rules relating to the commencement of new operations and the election of mandatory carriage or retransmission consent by television stations that such a new MVPD seeks to retransmit.

In the event it is determined that FilmOn X's 2014 notice is proper, but without waiver of any of Hearst's rights, which are expressly reserved, Hearst, on behalf of each television station listed in Exhibit A, hereby elects retransmission consent for all FilmOn X systems in each station's DMA as listed in Exhibit A for the election cycle that commences January 1, 2018, and terminates December 31, 2020.
