## **License Renewal Instructions: Post-filing Instructions and Text**

Once a station's renewal application is filed, the station must begin broadcasting post-filing announcements. Your station must begin airing such announcements on <u>December 1</u>. Instructions and the text of the announcement are provided below.

#### **Post-Filing Announcement Instructions**

Public notice of a station's license renewal application filing must be broadcast a total of <u>six</u> times over the <u>four-week</u> period beginning on December 1. These announcements do not need to air on set days or at a specific time, **provided that**:

- No more than two announcements may be aired per week to count towards the total six required. This means that the station should schedule at least one announcement per week, and two announcements in two of the weeks.
- All announcements must air between 7:00 a.m. and 11:00 p.m. local time.
- The announcements should be broadcast on the primary and any multicast channels (if you have insertion rights).

When airing the post-filing announcements, the text of the announcement must be presented onscreen during the verbal broadcast of the announcement.

#### TEXT OF THE POST-FILING ANNOUNCEMENT

On December 1, 2022, Gray Television Licensee, LLC, licensee of WCAX-TV, 506 MHz, Burlington, VT filed an application with the Federal Communications Commission for renewal of its broadcast license. Members of the public wishing to view this application or obtain information about how to file comments and petitions on the application can visit publicfiles.fcc.gov and search in WCAX-TV's public file.

#### **Certification**

WCAX-TV must record the date and times of post-filing announcements on the attached certification form. Once all the notices are completed, you must upload this certification to the station's online public file.

The certification should be placed in the folder named "<u>Local Public Notice</u> <u>Announcements</u>" within <u>seven</u> days of broadcasting the final post-filing announcement.
