Dear FCC:

Arkansas Educational Television Commission d/b/a Arkansas Educational Television Network ("AETN"), by its counsel, responds to Kathryn Berthot's letter dated November 10, 2008 (the "Enforcement Letter") regarding the compliance of Stations KAFT(TV), KEMV(TV), KETG(TV), KETS(TV), KETZ(TV) and KTEJ(TV) (collectively, the "AETN Stations") with the Commission's DTV Consumer Education Initiative requirements during the third quarter from July 1, 2008 to September 30, 2008. The Enforcement Letter notes that the Commission has no record of receiving timely filed third quarter Form 388 DTV consumer education reports for the AETN Stations.

AETN is an Arkansas state entity that operates six analog and five digital noncommercial educational television stations across the state of Arkansas. The stated mission of AETN is to offer lifelong opportunities to Arkansas residents, to supply instructional programs to Arkansas schools, to provide programming and services to improve and enhance the lives of Arkansas residents, and to illuminate the culture and heritage of Arkansas and the world. To accomplish this mission, AETN provides a high-quality public television service designed to inform, educate, motivate, entertain, enlighten and inspire.

AETN's Failure to Timely File Third Quarter Form 388 Reports Was Inadvertent

AETN respectfully submits that its failure to timely file third quarter Form 388 reports for the AETN Stations was an inadvertent error that has been promptly remedied. In the midst of preparing updates to the Form 387 DTV Transition Status Reports for the AETN Stations—which were due on October 20, 2008—AETN failed to meet the pending deadline for the Form 388 reports on October 10, 2008. AETN filed the required third quarter Form 388 reports for the AETN Stations on November 12, 2008 and subsequently amended the forms on November 19, 2008. AETN regrets its error and will ensure that all FCC reports, including those relating to the Commission's DTV Consumer Education Initiative, are timely filed going forward.

The Commission's deadline for filing third quarter Form 388 reports was October 10, 2008. This deadline was only 10 days prior to the Commission's October 20, 2008 deadline for filing updated Form 387 DTV Transition Status Reports. During this time, AETN worked diligently to review the DTV transition status of each of the AETN Stations and ensure that the Form 387 status reports for the AETN Stations were up to date and accurate. Unfortunately, while AETN's focus was on its efforts to update the Form 387 status reports for the AETN Stations, AETN missed the Commission's deadline for filing the third quarter Form 388 reports for the AETN Stations.

AETN has been steadfast in its efforts to prepare its statewide network of noncommercial education television stations for the impending DTV transition and to inform viewers about the impending DTV transition. Indeed, AETN has made sustained and substantial efforts to inform viewers of the AETN Stations about the DTV transition and its impact on their ability to receive the AETN Stations after the transition – going well beyond the minimum requirements for DTV consumer education required by the FCC. It is thus very regrettable that AETN's efforts to provide the Commission with a complete and accurate update on the DTV transition status of the AETN Stations indirectly contributed to AETN's failure to comply with the Commission's October 10, 2008 deadline for the filing of third quarter Form 388 reports.

AETN Has Remedied Its Error and Will Timely File Future Reports to the FCC

AETN has now filed a third quarter Form 388 report for each of the AETN Stations. After being notified of the Enforcement Bureau's inquiry on November 10, 2008, AETN promptly prepared the Form 388 reports, which were filed by counsel on November 12, 2008 and subsequently amended on November 19, 2008. The reports reflect that, with the exception of one day, the AETN Stations fully complied with the Commission's requirements for DTV consumer education during the third quarter. Indeed, AETN aired three times the amount of DTV consumer education spots required during the quarter, eight times the amount of DTV consumer education spots required between the hours 6pm to midnight, and three times the number of 30-minutes DTV consumer education programs required.

AETN sincerely regrets its failure to file third quarter Form 388 reports for the AETN Stations by the October 10, 2008 filing deadline. AETN takes very seriously the Commission's deadlines for the filing of required forms and reports. Accordingly, AETN will be even more vigilant of FCC filing deadlines going forward and will make every effort to file all required FCC forms in advance of the relevant filing deadline.

AETN Is Not Required to Upload Filed Form 388 Reports to its Website

The Enforcement Letter requests information regarding the date on which the filed Form 388 reports for the AETN Stations were uploaded to the AETN website. AETN, however, respectfully submits that it is not required to upload filed Form 388 reports for the AETN Stations to its website. The requirement to place Form 388 on a broadcaster's public website

applies only to broadcasters that select Option One for compliance with the Commission's DTV Consumer Education Initiative. It does not apply to noncommercial broadcasters – like AETN – that select Option Three.

In establishing the broadcaster education requirements for its DTV Consumer Education Initiative, the Commission adopted "rules that give both commercial and noncommercial broadcasters a *choice of education <u>and reporting requirements.</u>" In doing so, the Commission set forth three options for broadcaster education, each with its own set of distinct requirements: (1) Option One, which requires broadcaster to employ a set number of crawls; (2) Option Two, which allows broadcasters to use a variety of in-program messaging techniques; and (3) Option Three, which requires public service announcements and longer educational messages.³*

All three options for broadcaster education require quarterly reporting of DTV consumer education efforts. More specifically, "[u]nder each of the options, broadcasters must report on [their] educational and outreach activities by filing Form 388 with the Commission and placing it in the station's public file."

It is clear from the discussion in the DTV Report and Order, however, that only broadcasters that select Option One are also required to place Form 388 on their public websites. In the DTV Education Report and Order, the Commission expressly states:

A broadcaster choosing to comply with Option One will be required to electronically report its consumer education efforts to the Commission on a quarterly basis, and place these reports in the broadcaster's public file and, if the broadcaster has a public website, on that website.⁵

In contrast, the DTV Education Report and Order, in the sections relating to Option Two and Option Three, does <u>not</u> contain any express discussion of a requirement that broadcasters place Form 388 on their public websites. The DTV Report and Order's discussion of the reporting requirement for Option Three states:

We also find that the record supports a requirement that noncommercial broadcasters electing Option Three electronically report their consumer education efforts to the Commission on a quarterly basis, and place these reports in the broadcaster's public file, just as under Option One.⁷

Unfortunately, the rule sections codifying the Commission's reporting requirements for broadcaster education contain a typographical error with respect to this difference in the

reporting requirement between Option One (which requires that broadcasters place Form 388 on their public websites) and Options Two and Three (which do not). Section 73.3527(e)(13) of the Commission's Rules states that "[s]tations electing to conform to the requirements of Section 73.674(b) must also provide the form on the station's public website, if such exists." Section 73.674(b) of the Commission's Rules, however, sets forth general requirements that apply equally to Option One, Option Two and Option Three.

AETN believes that the Commission actually intended Section 73.3527(e)(13) to refer to Section 73.674(c), which sets forth the specific requirements only applicable to Option One. ¹⁰ This regulatory interpretation is appropriate for several reasons.

First, the reference to Section 73.674(b) in Section 73.3527(e)(13) is not externally consistent with the discussion in the DTV Education Report and Order. The DTV Education Report and Order expressly states that broadcasters have a choice of education and reporting requirements. However, the DTV Report and Order makes clear that all three options require broadcasters to file Form 388 with the Commission and place it in their public files. Thus, the only choice available to broadcasters with respect to reporting requirements is whether or not they are required to place Form 388 on their public websites (i.e., whether or not they select Option One). Because, however, Section 73.674(b) applies to all three DTV consumer education options, Section 73.3527(e)(13) effectively requires that all broadcasters place Form 388 on their public websites – regardless of whether or not they have selected Option One.

In contrast, Section 73.3527(e)(13) would be externally consistent with the DTV Education Report and Order if it were to refer to Section 73.674(c). Section 73.674(c) sets forth the specific requirements only applicable to broadcasters that select Option One. If Section 73.3527(e)(13) were to refer to Section 73.674(c) then, only broadcasters that select Option One would be required to place Form 388 on their public websites – which would be consistent with the discussion of reporting requirements in the DTV Education Report and Order.

Second, Section 73.3527(e)(13)'s reference to Section 73.674(b) is not internally consistent with the Commission's other rules – including Section 73.674(b). Section 73.3527(e)(13) states that the requirement that broadcasters place Form 388 on their public websites is applicable to "[s]tations electing to conform to the requirements of Section 73.674(b)." However, Section 73.674(b) is applicable to all three DTV consumer education options – because the Commission requires all broadcasters to comply with the DTV Consumer Education Initiative. Thus, stations cannot elect to conform to the requirements of Section 73.674(b). In contrast, stations can elect to

conform to the requirements of Section 73.674(c), which is only applicable to broadcasters that select Option One.

Finally, as explained above, the DTV Report and Order only expressly discusses the requirement that broadcasters must place Form 388 on their public websites when discussing Option One of the broadcaster education requirements. The fact that this requirement is not expressly discussed in the sections of the DTV Report and Order relating to Option Two and Option Three – unlike the reporting requirements applicable to all three options (electronic reporting to the Commission and placement of Form 388 in the public file), which are expressly discussed in all three sections – strongly suggests that the requirement was not intended to apply to either Option Two or Option Three.

Accordingly, AETN respectfully submits that it is not required to place the filed Form 388 reports for the AETN Stations on the AETN website because it did not select Option One to comply with the DTV Consumer Education Initiative.

Enclosed, please find the Declarations of Mike McCullars and Reginald Davis, each of whom has personal knowledge regarding the compliance of the AETN Stations with the Commission's DTV Consumer Education Initiative during the third quarter.

DECLARATION OF MIKE MCCULLARS

- My name is Mike McCullars. I am the Executive Assistant & Senior Director of Special Projects employed by Arkansas Educational Television Commission d/b/a Arkansas Educational Television Network ("AETN").
- 2. AETN failed to file third quarter Form 388 DTV consumer education for AETN's stations KAFT(TV), KEMV (TV), KETG(TV), KETS(TV), KETZ(TV) and KTEJ(TV) (the "AETN Stations") prior to the Commission's October 10, 2008 deadline for filing the reports..
- On November 10, 2008, counsel for AETN informed me that the Commission's Enforcement Bureau was investigating AETN's failure to file the third quarter Form 388 DTV consumer education reports.
- 4. Immediately after learning of AETN's failure to timely file the Form 388 reports, I consulted with Reginald Davis of our Programming Department and began to prepare third quarter Form 388 reports for the AETN Stations.
- 5. On November 12, 2008, counsel for AETN electronically filed the third quarter Form 388 reports for the AETN Stations with the Commission, which were subsequently amended on November 19, 2008. Copies of the filed Form 388 reports have been placed in public inspection file for each of the AETN Stations. Copies have not been placed on the AETN website.
- 6. AETN's failure to file the third quarter Form 388 reports for the AETN Stations by the October 10, 2008 deadline was the result of an unfortunate oversight on my part.
- 7. During the days leading up to October 10, 2008, AETN was focused on its efforts to review the DTV transition status of each of the AETN Stations and to assist counsel with any required updates to the Form 387 DTV Transition Status Reports for the AETN Stations.
- 8. AETN did not realize that the deadline for filing third quarter Form 388 reports for the AETN Stations had passed until it was notified of the Enforcement Bureau investigation.
- 9. During the period beginning July 1, 2008 and ending September 30, 2008, AETN has provided general information relating to the DTV transition, the availability of DTV converter box coupons, and a link to the website www.dtvanswers.com on the AETN website, which is located at http://www.aetn.org/. A screen shot of the AETN webpage relating to the DTV transition is attached at Attachment A.
- 10. During this period, AETN has also presented information relating to the DTV transition to 10 civic groups totaling over 370 persons.
- 11. The FCC Enforcement Bureau, in its letter dated November 10, 2008, did not request that any additional documents be produced.


DECLARATION OF REGINALD DAVIS

- 1. My name is Reginald Davis. I am an On-Air Promotions Editor in the Programming Department employed by Arkansas Educational Television Commission d/b/a Arkansas Educational Television Network ("AETN").
- On November 10, 2008, I provided information to Mike McCullars relating to the broadcast of DTV consumer education spots on AETN's stations KAFT(TV), KEMV (TV), KETG(TV), KETS(TV), KETZ(TV) and KTEJ(TV) (the "AETN Stations").
- With the exception of one day, July 4, 2008, AETN broadcast at least 120 seconds per day of on-air DTV consumer education on the AETN Stations during the period beginning July 1, 2008 and ending September 30, 2008. A run report for these DTV consumer education spots is attached at Attachment B.
- 4. During this period, AETN also broadcast at least 15 minutes per month of DTV consumer education on the AETN Stations during the hours of 6pm and midnight. See Attachment B.
- 5. AETN also aired the 30-minute DTV consumer education program "ABCs of HDTV" on the AETN Stations three (3) times during this period. A run report for this DTV consumer education program is attached at Attachment C.
- 6. The FCC Enforcement Bureau, in its letter dated November 10, 2008, did not request that any additional documents be produced.

KAFT-13 / Fayetteville

On March 1, 2010, KAFT signed on at a new full power level having completed work on transmission equipment to increase the broadcast power strength by nearly double. This was a completion of the overall digital transition, when on June 12, 2009, the KAFT analog 13 transmitter was shutdown. Nearly all over-the-air viewers and cable companies in northwest Arkansas are able to receive the KAFT digital signal provided that they use a digital converter box with their analog TV or use a new digital TV with tuner. Some viewers may need to raise the height of their outdoor antenna to receive a reliable signal.

KETG-9 / Arkadelphia

On February 27, 2010, KETG signed on at a new full power level having completed work on transmission equipment to increase the broadcast power strength by nearly double. This was a completion of the overall digital transition, when on June 12, 2009, the KETG analog 9 transmitter was shutdown. Nearly all over-the-air viewers and cable companies in southwest Arkansas are able to receive the KETG digital signal provided they use a digital converter box with their old analog TV or use a new digital TV with tuner. Some viewers may need to raise the height of their outdoor antenna to receive a reliable signal.

KEMV-6 / Mountain View

On June 4, 2010, KEMV signed on at new full power level having completed work on transmission equipment and the replacement of a small broadcast antenna with a new, larger antenna. This project increased the KEMV digital broadcast power strength by about three times and coverage area by nearly double. This completion of work has been part of the DTV Transition when on June 12, 2009, the KEMV analog 6 transmitter was shutdown. Most over-the-air viewers and all cable companies in north central Arkansas should be able to receive the KEMV digital signal now provided that they use a digital converter box with their analog TV or use a new digital TV with tuner. Some viewers may need to raise the height of their outdoor antenna to receive a reliable signal.

Work is underway at KTEJ in northeast Arkansas on transmission equipment to increase the broadcast power strength by nearly six times. This is a maximization project that is part of the overall digital transition, when in February 2009, the KTEJ analog 19 transmitter was shutdown. This work is expected to be completed in mid-2011. Until then, most over-the-air viewers and cable companies in northeast Arkansas are able to receive the KTEJ digital signal provided that they use a digital converter box with their analog TV or use a new digital TV with tuner. Some viewers may need to raise the height of their outdoor antenna to receive a reliable signal.

KETS-2 / Little Rock

Since late July 2009 KETS-DT/Little Rock has broadcast at full power from the KASN broadcast tower near Redfield south of Little Rock with reports that all is working well with a strong signal from this area.

KETZ-12 / El Dorado

KETZ/El Dorado has continued the broadcast of its digital channel since the end of analog broadcast on June 12, 2009. All is working well with a strong signal from this area.

Loss of Coverage Area Notice

In early Spring 2009, viewers of <u>KEMV</u> in north Arkansas and <u>KETG</u> in southwest Arkansas (who in the past, received a snowy analog picture from AETN) were notified that they might have no reception after the analog shutoff date of June 12, 2009. However, since the completion of the power maximization projects at KETG on February 27, 2010, and at KEMV on June 7, 2010, viewers in the southwest Arkansas counties of Howard, Little River, Miller, and Sevier counties as well as viewers in north central Arkansas counties of Boone, Newton, Pope, Fulton or in southern central Missouri should no longer be affected.

Reception within any of AETN's broadcast areas may be obstructed by hills, buildings or electrical lines resulting in picture or audio problems. Viewers may still need an outside antenna or to raise the height of their existing antenna. All viewers should be sure that their antenna or "rabbit-ears" are designed for both VHF and UHF. For more information, contact the FCC's Call Center (1-888-CALL-FCC), the TTY number (1-888-TELL-FCC) or go online to www.dtv.gov/maps for the online digital reception mapping tool. Or viewers may contact AETN (1-800-662-2386) or visit online at www.aetn.org/dtv or go to www.dtv.gov/dtv made mass.pdf for an easy to read "DTV Made Easy" booklet.

AETN Digital FAQs:

Q. How do I get AETN on DirecTV or DishNetwork? And can I see AETN in HD on those satellite systems?

A.The two satellite companies use the Nielsen Designated Market Areas (DMAs) to divide up the country to provide their services. Currently, the law allows a satellite company to offer "local service" in a DMA meaning that all local broadcasters that sit in that DMA will be included in their "local channels" package.

<u>DishNetwork</u> includes AETN as a local station in northwest Arkansas (Fort Smith-Fayetteville DMA), central Arkansas (Little Rock-Pine Bluff DMA) and south Arkansas-north central Louisiana (Monroe-El Dorado DMA) and announced in March 2010 that local service is planned for northeast Arkansas (Jonesboro DMA).

<u>DirecTV</u> also offers this local service in northwest Arkansas (Fort Smith-Fayetteville DMA), central Arkansas (Little Rock-Pine Bluff DMA) and south Arkansas-north central Louisiana (Monroe-El Dorado DMA).

Satellite subscribers in other parts of Arkansas will not have AETN included in their "local channels" package at this time. However, DishNetwork currently does offer AETN as a "statewide station" for areas where AETN is not part of a "local channels" package. This special service, which customers have to specifically request by name ("Statewide Channel: Arkansas Statewide PBS-KETS") for a small additional cost per month, allows AETN to be received by DishNetwork customers regardless of whether there is a "local channels" package available or what channels are included in those local packages. DirecTV does not offer this special service at this time.

As for HD (high definition) service on satellite, DirecTV tells us that they launched AETN-HD in their HD package in Fall 2009. DishNetwork says it launched AETN-HD in their HD package in mid-2010 for their customers. In either case, satellite customers must sign up for the HD package and have an HDTV set in order to actually watch HD programming in HD. Otherwise, viewers will see HD programming that has been down-converted to SD (standard definition at a lower resolution). Satellite customers should talk to their provider for more information about HD services available in their area.

Over-the-air viewers of AETN already receive AETN's primary channel (AETN-PBS) in HD as well as the secondary channels (AETN PLUS and AETN Create) in SD (standard definition at a lower resolution) -- for free -- if they have an HDTV set with built-in digital tuner.

Note: AETN's secondary channels are <u>not</u> carried by either DishNetwork or DirecTV and there are no plans by either to ever do so until required by law.

Q. Will I still be able to receive the analog broadcasts from AETN?

A. No. Now that the analog shutdown date has come and gone, all full-power analog broadcast stations in the United States have been shut down except for a few that will serve as "night-light" stations for another month. Thus, AETN shut down its remaining analog broadcast service from KAFT/Fayetteville in northwest Arkansas, KEMV/Mountain View in north central Arkansas, and KETG/Arkadelphia in southwest Arkansas on the morning of June 12, 1009. Viewers who rely on an antenna or rabbit ears and who have not done so must connect a digital converter box to any analog TV they wish to use or purchase a new digital TV with tuner to enjoy free, over-the-air television.

Q. What is the latest concerning AETN's digital broadcast service?

A. Since mid-June 2009, AETN has been broadcasting at the fullest power allowed by the FCC at all six transmitters: KAFT/Fayetteville in northwest Arkansas, KEMV/Mountain View in north central Arkansas, KETG/Arkadelphia in southwest Arkansas, KETS/Little Rock in central Arkansas, KETZ/EI Dorado in south Arkansas and KTEJ/Jonesboro in northeast Arkansas. Any problems that may occur should only be weather-related or due to temporary technical problems because of equipment or power failure.

Work to increase broadcast power strength and coverage area has been completed (as of early March 2010) at KAFT and KETG as well as at KEMV (as of early June 2010) with other work currently being done at KTEJ, which should be completed in mid-2011.

Q. Why can I still not receive AETN now that analog broadcast has ended?

A. It is possible that some cable have not made changes in their equipment to again receive AETN or that they cannot receive a reliable signal due. Viewers should contact their provider to find out the situation and when that will be remedied. It is also possible that some viewers and cable companies have their antennas sitting where they receive too much interference, have their antennas aimed in the wrong direction, do not have an antenna for both VHF and UHF, have old equipment or wiring, or are sitting too far away from a transmitter to receive a reliable signal. These areas are known as "dead-spots". The only remedy at this time is to eliminate anything that might interfere with reception (see next question below) or to raise the height of the antenna. Viewers are reminded to re-scan their convertor box or digital TV regularly after any adjustment. And, some viewers may need to "double rescan" -- see this section under "DTV Information".

Q. Is there anything else I need to know or remember about digital TV?

A. Where you live may also affect whether you receive the new digital signal. Such things as hills, tall buildings and structures, high-power electrical lines, storms, dense foliage, and even interior venetian blinds or large appliances can affect the reliability and quality of the signal. Viewers who used to rely on rabbit-ears or antennas in their attic may need to have an antenna on the roof of their home or on a tall pole beside their house.

Viewers who rely on over-the-air digital reception are encouraged to occasionally rescan their channels as local stations have changed frequencies and/or are increasing their broadcast power that may allow viewers to receive them for the first time or with a consistent signal. For an easy to read booklet called "DTV Made Easy", go online to download a copy at www.dtv.gov/dtv made easy.pdf.

Viewers who are not connected to cable or satellite and who wish to continue to use their analog TV sets will need a digital-to-analog converter box for each analog TV they wish to use. A coupon to help purchase a DTV converter box was available through the end of July

2009. Unless a viewer already has a coupon, any future purchase of a converter box will be a full price.
