

PRE-FILING ANNOUNCEMENT

On September 27, 2011, WXCY(FM) was granted a license by the Federal Communications Commission to serve the public interest as public trustees until October 1, 2019.

Our license will expire on October 1, 2019. We must file an application for renewal with the FCC by June 1, 2019. When filed, a copy of this application will be available for public inspection at www.fcc.gov. It contains information concerning this station's performance during the last eight years.
