**STATEMENT OF LINGARD BROADCASTING CORPORATION
IN RESPONSE TO FCC EEO AUDIT OF WLOV-TV**

Lingard Broadcasting Corporation, (“LBC”), licensee of Television Station WLOV-TV, West Point, Mississippi, hereby submits its statement in response to the Commission’s EEO Audit inquiry of February 26, 2013, pursuant to §73.2080(f)(4) of the Commission’s Rules, regarding its station employment unit (“Unit”).

Response to Item 2—Having fewer than five (5) full-time employees, WLOV-TV (*i.e.*, the Unit) is not required under the Commission’s Rules to have an EEO recruitment program. Nonetheless, LBC categorically states that in its hiring practices it affords equal opportunities to all qualified persons, and does not discriminate in employment based upon race, color, religion, national origin, or sex.

The following table reflects the names, job titles, and the number of hours each is regularly assigned to work per week for all of the Unit’s full-time employees:


